



Subject: Weekly Report

1. Snow crews were in on Friday night, Saturday morning/afternoon, Sunday evening, Monday morning/afternoon/evening, and Thursday morning. Due to the frequency and long duration of snow on Sunday/Monday, crews reduced the amount of salt used. Salt was focused on hills, intersections, and main routes.
2. In between snow events, crews focused on hauling snow out of the Downtown.
3. Cargill Salt, which holds the state contract for this year, has notified the Village that due to the high demand throughout the region they are experiencing delays in salt delivery. While we certainly expect to have enough salt to make it through the winter, we will be a little more conservative to help ensure higher priority locations such as intersections, hills and busier streets remain salted.
4. Window installation at Village Hall will begin on Monday. It should be completed within two weeks.
5. I met onsite with the developer and builder of Mycroft Row on Burlington. Representatives from Verizon were also onsite. Verizon's engineer will be preparing plans to move their lines underground and will coordinate with the other cell providers to have them utilize the same conduit for their wires.

- Building Permits.** So far in February, the Village has issued eight (8) permits having a total reported construction value of \$380,577.
- ZBA/PC Meeting.** Last night, 2/18/2021, the ZBA/PC conducted a public hearing in consideration of a village-initiated text amendment regarding the storage of commercial and recreation vehicles on residential and non-residential properties. After much discussion, the hearing was continued to the ZBA/PC's next meeting scheduled for 3/18/2021.
- Group Home Update.** The Village has yet to receive any application in consideration for a large group home or renovation work at 359 Ruby (see previous related statement posted at www.clarendonhills.us.) Staff will continue to monitor.
- DwellSocial Restaurant Delivery.** It was brought to the Village's attention that a restaurant delivery service was providing weekly pickup from a resident's driveway. While the service may be convenient, the traffic generated was cause for concern. The homeowner was happy to introduce the business to the Village, and the business was happy to move its pickup location out of the neighborhood. Staff will continue to monitor.

- Train Station – Inbound Shelters.** A planned sculpture made of recycled railroad track iron rails will be installed along the east wall of the main shelter. Last Friday afternoon, the Village, Legat Architects and the John Burns Construction visited the warehouse where these rails will be purchased. The chosen rails and the design schematics for the sculpture are pictured to the right.

With warming temperatures, metal work on the each of the shelters has restarted.

- Gates.** BNSF has substantially completed scheduled work. Barrier safety fence installation and pavement repair will begin in Spring 2021.
- Streetscape.** Punchlist items, including the metal railings in front of Village Hall, will be completed in Spring 2021.

- d. **Burlington Plaza/Alley.** Survey work is complete, and Plaza-design concepts are underway. Before the Downtown Design Review Commission, the first presentation of plaza concept designs is expected in late-February, early-March. Notice of this meeting will be posted on the Village website and at Village Hall.
- e. **Train Station – Outbound Shelter.** Construction is scheduled to start in Spring 2021, with completion by July 4, 2021.
