- **COVID-19 Business Operation Update** – Businesses continue to install tents and seating areas in the outdoor areas provided by the Village. This is a good sign that better weather is coming. We will monitor the situation as the vaccine progress is made and discuss the future of outdoor seating with the Board.
- **Staff Response to COVID-19 Pandemic/Village Operations** – Staff operations are continuing to operate well, with Village Hall staff moving to a 4-day in office, 1-day remote cycle.
- **COVID-19 Health Department Update** – I attended the weekly review meeting on Monday. General trends are continuing to move in the wrong direction again, mirroring what is happening in most parts of the Country. Number of cases and the positivity rate are rising. As of April 5, 19.7% of DuPage residents were fully vaccinated, a 3% increase from last week. More than 318,000 have received a “first dose” of the vaccine, about 40,000 in the last week. This suggests that something close to that number will be fully vaccinated in about one month. About 81% of persons 65+ in DuPage County have received at least the first dose, which is about 4% higher than last week.
- **Refuse Rollout** – Staff worked through any missed pickups, can switches and other issues as the refuse rollout continued.
- **Village Phone System Problems** - The Village phone systems were fully restored this week. Staff is meeting with its IT consultant to choose a path going forward.
- **DITS**- Dancin' in the Streets planning continued this week, with bands, the stage, and volunteers all being finalized hopefully in time for some announcements next week.
- **Election Day Update** – The Village Board room was used for the April 6<sup>th</sup> election. This went smoothly for the most part. Thanks to the Police Department for assisting with off-hours opening and closing.

6. Inspections were performed for a number of building projects that impacted the village right of way.



- Building Permits.** So Far in April, the Village issued six (6) permits, having a total reported construction value of \$326,370. Please be aware of periodic public sidewalk closures and detours on Burlington Avenue, west of Prospect. We have three (3) significant projects underway: Hamel Dental (210 Burlington), Tierra Distillery (211 Burlington), and Mycroft Row (221-231 Burlington.)



- 5 McIntosh.** I don't typically make it a practice to post information about upcoming new single-family projects. However, given this proximity to the downtown and the uniqueness of the property, I thought it would be appropriate to share this information. A homebuilder recently purchased the property at 5 McIntosh. This property is unusual in that it is only 40 feet wide and shares its southern border with a public alley. Preliminary plans for a single-family home and detached garage appear to comply with Village zoning code requirements. Please note that these plans are preliminary and may change.



- Zoning Board of Appeals/Plan Commission.** This month's meeting scheduled for April 15, 2021, is canceled.

- Train Station – Inbound Shelters.** This week the contractor focused on painting and light fixture installation. If weather permits, the contractor plans to begin applying a concrete graffiti coating, and other painting finishes next week. Topsoil and landscaping are still on track to begin later this month.

- Train Station – Outbound Shelter.** The north shelter was demolished this week. The new shelter is being constructed as Phase 2 of the state-funded streetscape program. In addition to the north shelter, this phase will include the remaining streetscape and landscaping improvements at the crossing and the installation of an electric-car charging station across from Village Hall.



- c. **Streetscape.** Installation of the Village Hall railings is expected next week. Other punch list items will be completed in Spring 2021. Native planting beds are expected to fill in over the next two to three years.
- d. **Gates.** Exit gates are expected to be installed in late 2021 or early 2022.
- e. **Burlington Plaza/Alley.** On April 5, 2021, the Village Board approved and directed staff to develop construction plans for Burlington Plaza at Burlington Avenue and Prospect Avenue's southwest corner. Construction of the Plaza and reconstructed alley is planned for summer 2021.
