1. Vehicle Stickers are almost due...residents are required to purchase a village sticker for each vehicle they will have housed in Clarendon Hills. The annual license period **begins July 1st** of each year and ends on June 30th of the following year.

Residents can make online purchases at www.clarendonhills.us/stickers, or the link can be accessed by visiting the Village Website and clicking "Online Bill Pay" or "How do I," and a link to the site will be available.

Prices are as follows:

Passenger Car - \$40

Motorcycle - \$30

Seniors (62+) are eligible for a 50% discount.

1. Watering took up the lion's share of the week.
2. We finished up the remaining tree planting at the beginning of the week.
3. Minor tree trimming occurred in a variety of locations.
4. Maintenance was performed on the end loader.
5. Bid specifications were completed for crack filling and asphalt patching.
6. Bids were opened for the Burlington Plaza and Alley project. The bids and references are under review. A recommendation is expected within a couple of weeks.
7. A Right of Way permit was reviewed to allow School District 181 to install fiber between their schools.
8. Nicor began work to replace the gas main on Chicago Avenue west of the Middle School. The work is expected to be completed before school starts in the Fall. Some vehicles are being stored along Burlington and Nicor has committed to restore that area when their job is complete.
