1. ComEd has notified the Village that they will be doing tree trimming adjacent to their lines in different areas of the Village. A map and a copy of the post card they sent to the affected residences is attached to this report.
2. Crews were in overnight from Tuesday to Wednesday to address the snowfall. The last crew left Wednesday night around 8:00. The other crew came in before dawn on Thursday to start loading out the Downtown snow piles. That work continued all day Thursday and into Friday.
3. Water meters were read on Tuesday morning.
4. Truck maintenance and minor repairs following the snow event occurred on Thursday and Friday.
5. DuPage County Stormwater notified us that they will be taking public comment until February 15th on their MS4 Water Quality Program. More information is available at:

6. I attended the DuPage Mayors and Managers Conference – Transportation Technical Committee meeting on Thursday. This meeting covered the logistical items around the pass thru federal dollars to fund road projects in DuPage County.
7. I sat in on a conference call with the Community Development Director and Assistant Village Manager and representatives from Verizon that notified the Village that their third-party vendor Crown Castle will be pursuing the installation of small cell installations within Clarendon Hills. Crown Castle is conducting feasibility studies and intend to co-locate antennas to serve multiple cell companies. This project would allow Verizon to rollout out 5G service for home internet which is currently underway in other areas of the Chicago market.

TREE TRIMMING TO BEGIN SOON

Trees and branches that interfere with power lines can create safety hazards and cause power outages. Preventative tree maintenance helps avoid power outages.

- Within the next 3 months we will trim trees, branches and vines that interfere or have the potential to interfere with power lines.
- In some cases, tree removal may be required. The remaining tree stumps are treated with an approved herbicide to prevent future regrowth. Herbicide will be applied by state-licensed applicators.
- All work is performed by trained, qualified arborists.

Re: Notification Required under 220 ILCS 5/8-505.1

To Whom It May Concern:

ComEd intends to perform vegetation management activities on distribution circuits in your area within the next few months. The vegetation management activities are a key component of ComEd's maintenance program to ensure system electrical reliability, as vegetation contact with ComEd equipment is a leading cause of outages.

In accordance with applicable statutory requirements, ComEd is required to provide each affected municipality a map (see attached) or common addresses of the area affected by the vegetation management activities.

Please be aware that ComEd has notified any affected customers and property owners with (i) a statement of the vegetation management activities planned, (ii) the address of a website and a toll free telephone number at which a written disclosure of all dispute resolution opportunities and processes, rights, and remedies provided by the electric public utility may be obtained, (iii) a statement that the customer and the property owner may appeal the planned vegetation management activities through the electric public utility and the Illinois Commerce Commission, (iv) a toll-free telephone number through which communication may be had with a representative of the electric public utility regarding the vegetation management activities, and (v) the telephone number of the Consumer Affairs Officer of the Illinois Commerce Commission. The notice also stated that circuit maps or common addresses of the area to be affected by the vegetation management activities are on file with the local municipal or county office.

We recognize that our vegetation management activities sometimes create concern by your residents because trees near our electrical wires are significantly trimmed or sometimes require removal. Qualified line-clearance workers contracted by ComEd will be performing the tree pruning work. Supervisors and General Foremen will be in close contact with the crews, ensuring that the work is performed properly. Additionally, we are strong advocates of proactive efforts to ensure that only appropriate vegetation is planted near our facilities, and our easement and leases usually specify vegetation restrictions. Trees that grow greater than 20 feet, for example maple, elm, and blue spruce, should never be planted under or near distribution power lines. At full height, these trees could contact lines and cause a power outage or create a safety issue. On the other hand, trees and bushes that grow to heights less than 20 feet, for example dogwoods or crabapples, can often be planted near distribution power lines.



1. Fire Prevention Bureau Activity.
 - This week Lt. Godek has followed up several construction projects in the village to make sure they are on track.
 - This week Lt. Godek completed ten (10) Fire/Life Safety Inspections.
2. Training Report:
 - Daily on duty sessions were conducted. Building familiarization was done at several buildings during the past week.
 - On Wednesday evening nineteen (19) firefighters attended Fire Suppression training. Classroom tactics and strategy simulations were conducted.
3. COVID 19 Report:
 - COVID 19 Hospitalizations are still at an uncomfortable rate at both Hinsdale and LaGrange Hospitals but have been steadily decreasing. Today Hinsdale Hospital had 10 COVID patients and LaGrange had 21 patients. Over 85% of these patients are unvaccinated.
 - EMS personnel continue to take full PPE precautions during all EMS calls.
 - Over the past 3-4 weeks the fire department has thirteen (13) employees who tested positive for COVID 19 and were in isolation according to CDC guidelines and had to test negative in order to return to work. At this time, we have no fire department employees currently in isolation and who are still testing positive.
4. Emergency Medical Services Report:
 - No report
5. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
6. Emergency Management Report:
 - No report.
7. Du-Comm Report:
 - On Wednesday, January 2nd I attended the virtual meeting of the Du-Comm Support Services Committee. Probably the biggest discussion revolved around the deployment of new Starcom radios for all fire and police departments in DuPage County.
8. Vehicle Maintenance:
 - Engine 86 (2002 Pierce Pumper) was taken out of service with much equipment removed and taken to Woodstock Illinois early Monday morning (1/24) to have the fuel lines replaced from the fuel tank in the rear of the vehicle all the way up to the engine. These fuel lines are

corroding because of age and allowing air into the fuel system which is causing hard starting problems. When Engine 86 is completed, Ladder 86 will be going in for the same repairs because of the same starting problems.

9. Incidents of Interest:

- Sunday, January 30th at 8:43 PM. Medic 86, Squad 86, and Hinsdale Engine 84 responded to a vehicle accident with injuries on Park Ave. at Western Ave.

10. Mutual Aid Calls:

11. Fire/Rescue/EMS calls:

- The Hinsdale Fire Department responded Automatic Aid to Clarendon Hills seven (7) times.
- The Westmont Fire Department responded Automatic Aid to Clarendon Hills four (4) times.
- The Tri State Fire Department responded Automatic Aid to Clarendon Hills two (2) times.
- The Clarendon Hills Fire Department responded Automatic Aid to Hinsdale four (4) times.
- The Clarendon Hills Fire Department responded Automatic Aid to Westmont two (2) times.
- Clarendon Hills Medic 86 responded to one (1) EMS calls in Westmont.
- The Fire Department responded to twenty-nine (29) emergency calls in the past week.
