- **Conference Attendance** – I attended the ILCMA Winter Conference from Tuesday afternoon to Thursday morning. Numerous issues of interest were covered including current challenges in recruitment and retention of employees, police culture challenges and legislative updates. The latter includes potential for increase in Local Government revenue from the State, possible continuation of remote meeting options beyond the pandemic emergency and statement of economic interest forms.

Please note that the Clarendon Hills residents will be allowed to place accepted electronic waste items at their curb for collection by LRS on **MONDAY, May 2, 2022**

This complimentary event will take place for one day only, so please mark your calendars.

In order to participate and to schedule service, residents must call **844.NEED.LRS** or submit your request at **LRSrecycles.com/ewaste**. Residents who don't request/enroll for this service may not have items collected. Submissions will be accepted until 5 PM on Thursday, April 28, 2022.

ALLOWABLE ITEMS INCLUDE:

TV's, printers, computers, computer monitors, laptops, gaming consoles, fax machines, scanners, stereo equipment, cell phones, keyboards/mice, extension cords, telephones, cameras, network cables, computer cords.

SMALL HOUSEHOLD APPLIANCES:

Blenders, microwaves, toasters, alarm clocks, hair dryers (most small corded items).

NOT ACCEPTED:

Electronics containing liquids/hazardous materials (these items include air conditioners, refrigerators, dehumidifiers, etc.), batteries for cars, boats, sump pumps, etc., smoke detectors, thermostats, lightbulbs, gas-powered items.

If an allowable item is too large to handle, or needs special consideration, LRS may not be able to take it, or reschedule for a different day.

1. On Thursday, Senior Accountant Kari Krzemkowski and I met virtually with Sikich, LLP, for the audit fieldwork exit conference. I am happy to report that the CY 2021 audit was another success for the Village! Sikich noted that they were pleased the Village could have all the work papers and financials completed a month ahead of previous years. I would note that the audit's success could not be possible without each person's effort in the Village Hall. Dan Berg, Partner for Sikich LLP, will present the final audit to the board tentatively at the last board meeting in May.
2. Effective today, April 1, 2022, Yard Waste Stickers increased in price from \$2.75 per sticker to \$2.83 per sticker. Yard Waste Stickers are available for purchase at the Village Hall, Clarendon Hills Jewel, and the Clarendon Hills Hardware store.
3. Utility billing Clerk Cesarini sent out past due notices for water bills that were not paid by March 25th. Those residents that received the notice were assessed a ten percent penalty. All payments are due by April 25th to avoid further action, such as a red tag notice.
4. On Friday, April 1, 2022, IMRF released the 2023 Employer contribution rates. IMRF contributions must be paid on the earnings of all employees working in participating positions. Our employer contribution rate on member earnings is based upon actuarial costs for retirement, supplemental retirement, death, and disability benefits. The CY 2023 will be 12.12%; this is the lowest contribution rate the Village has had in the last ten years of data. (Shown below)

1. **Metra Parking Lot – General community use**

The Metra off-street parking lot is available after 3 pm on weekdays and all day on weekends.

This 93-space lot provides ample additional public parking options for general use by all Downtown visitors and only an easy three block walk to most downtown businesses.

2. **Wet weather and construction site cleanliness**

The Community Development Department deals with concerns about cleanliness around construction sites. Now that Spring and wet weather is upon us, the Dept wishes to remind the community that our neighborhoods' perception is important and proper cleanliness in and around construction sites is vitally important to the entire community.
