Message from the President

Dear Neighbors,

For my last message of the year, I like to reflect on accomplishments from the year and also look to the plans already in motion for next year.

A major goal of my tenure on the Village Board is continuing to invest in the community's infrastructure. On November 7th, we will finally hold the ribbon cutting for the Train station and surrounding downtown revitalization program. These projects were half funded by outside agencies including Metra, Regional Transit Authority, DuPage County, IL Commerce Commission, Illinois Department of Transportation and federal grants through West Suburban Mass Transit District, Congestion Mitigation and Air Quality Improvement Program (CMAQ) with the help of Chicago Metropolitan Agency for Planning (CMAP). The balance was funded utilizing local capital funds and the Downtown TIF with no new tax increases. The new public spaces created by the improvements are already getting daily use as public spaces and during special events, including the farmers market, Oktoberfest and the Witches Ride after party events.

Next year, the Village is authorizing the reconstruction of Burlington Ave with watermain replacements. Federal funding will cover up to 80% of the road construction costs. Additionally, the Village expects to finish the concrete curbs in the Village with the reconstruction of Ann and Byrd to bring those streets up to the Village's current standards.

The Village also continues to invest in the safety of the community by increasing public safety resources. In 2022, the Village Board increased police staffing by one officer, providing full staffing for each shift. In October, the Village issued body cameras to all police officers, meeting the State of Illinois mandate ahead of the 2025 deadline. Body cameras help in gathering evidence, protect officers from unfounded accusations and ensuring our officers are held to the highest policing standards. In 2019, the Village Board authorized increasing fire staffing by 33% to add an additional certified paramedic to our ambulance, allowing for two experienced, fully trained paramedics to respond to every medical emergency in town. Finally, the Fire Department received a new ambulance with the latest technology/equipment and was authorized to order a new ladder truck and pumper, replacing equipment that is 23 years old.

When COVID hit, the Village was ready to do business online. During my tenure we continued to invest in technology, allowing for online requests, remote participation in Village Board meetings, more timely digital communications including emergency texts and email "blast" communications, and complete transparency into government documents and finances through the public documents' portal. Almost all business with the Village can at least start online, with much of it routed automatically through Village departments. Every year we add new services online and streamline our processes both internally and externally to better provide services for our residents, businesses and local contractors.

Along with the public infrastructure improvements, the Village continues to seek private-public partnerships with our business community to create a business environment that is profitable for businesses while maintaining the small-town charm many of our residents moved here for. Since created in 2020, the Downtown TIF has been able to bring much of the core downtown up to modern building standards, including assisting with putting fire sprinklers in Tierra Distillery, Il Mio, and The English Garden. These investments have been matched at least 3:1 by the local property owners and local business owners, and these properties may still be vacant if not for the Village proactively assisting the modernization of these properties. Because of the shifting business environment, we are seeing businesses such as The Open Door and Tap Room, La Pearl, Thassos Greek Restaurant, and Wasabi Restaurant and Bar open without using any tax dollars.

Additionally, the Village committed to support the Chamber of Commerce with funding allowing the Chamber to enhance and expand events and marketing for the downtown. The Ogden TIF is now wrapping up after successfully attracting the

Infinity Dealership. The proposed budget includes refunding the remaining balance of \$276,289 to local taxing districts, including our local schools. This represents a dividend from a successful development plan, and we will continue to see additional dollars in future years for our schools.

The Village Board is also committed to keeping taxes low. The Board is expecting homeowners to see about a 1% property tax increase on their Village portion of the bill (2%, with 1% offset by redevelopment or "new growth"). This is despite record inflation and rising pension costs for the Village's Police Pension which will absorb a majority of the increase in revenue. The Village has done this by decreasing administrative staff, eliminating middle managers throughout the organization and utilizing technology to lower staffing requirements over the years.

REFERENDUM ON THE NOVEMBER BALLOT

At the July 18, 2022 Board meeting, staff was directed to proceed with a referendum to convert the Village Clerk position into an appointed rather than an elected position. This would take effect at the end of the current elected term in May 2023. Dawn Tandle, the current long term serving Village Clerk, has advised that she does not intend to run for election in 2023 for another term. The proposed question will be on the November 2022 ballot.

The Village determined that the duties could be absorbed by current staff members and/or minor contractual spending with a projected savings to Village residents. The Village currently employs an Executive Assistant that acts a Deputy Clerk in order to fulfil some of the duties of the position in the Clerk's absence. Unlike other paid positions within the Village, Illinois State Statute requires a referendum be approved to allow for the position to be appointed and to distribute the statutory duties of the position among staff. The Village Clerk would be appointed by the Village President with the advice and consent of the Village Board if the referendum is approved.

The proposed question will be on the November 2022 ballot.

Shall the Village Clerk of the Village of Clarendon Hills be appointed by the President, with the advice and consent of the Board of Trustees, rather than be elected?

FREE PARKING AT METRA LOT

With all the new restaurants and businesses downtown in the Village, residents should know that there is FREE parking at the Metra lot weeknights after 3PM and during the weekends.

Please don't leave valuables in the car and be sure to lock your vehicles.



Winter Snow Reminders

Residents are required to park off the Village streets if the weather predicts 2 or more inches of snow fall. This is to allow for proper snow removal. *(It's recommended snow be removed from the top of your vehicle prior to driving!)*

No person shall dump snow onto any public road, public sidewalk or fire hydrant.

Garbage cans should be placed at the end of your driveway and not on the street which includes the concrete ribbons. This makes it easier and safer for our crews to clear the streets of snow and allows cars to go around garbage trucks picking up cans.
