**Recent Training, Meetings and Events:**

- Department staff were trained on the newly amended/added disorderly conduct and rules of conduct Village ordinance.
- Sgt Finrock performed the last safety drill of the school year at Prospect.
- Another school year is in the books with summer classes starting up next week.
- Summer break is here! Please remember to follow bicycle safety and the rules of the road.

**Recent incidents:**

May 24, 7:57am, officers responded to the intersection of Naperville & Middaugh for a two-vehicle traffic crash. Upon investigation, officers determined one of the drivers involved had a suspended license. The driver was ultimately cited for driving with a suspended license and failure to yield.

May 24, 9:59am, officers responded to the report of a hit & run accident on the 200 block of Walker. The caller advised their car was struck by another vehicle, breaking off the side mirror off. Officers were able to locate the other vehicle involved nearby and the two parties exchanged information about repairs.

May 25, 2:03am, officers were dispatched to a disturbance in a parking lot on Carlisle. Upon arrival, officers observed three subjects who appeared to be arguing with each other regarding a domestic issue. All parties involved advised the argument was verbal in nature and denied any injury. Officers worked to mediate the situation, separated the parties involved and offered assistance resources.

May 25, 11:35am, officers responded to a residence on Ogden for the report of a domestic battery that occurred in the driveway. The incident was witnessed by passers-by who described the aggressor as being completely nude and striking the other party who was seated in their car. Officers spoke with the victim who was evaluated by medics on scene. Officers searched for the suspect with negative results and later obtained an arrest warrant. Case pending.

May 27, 10:48, officers responded to a residence on Barclay for the report of domestic battery. Upon arrival, officers spoke with the parties involved and determined one subject threw hot water they made for tea at the other subject. The offending party was taken into custody, charged with two counts of domestic battery and transported to the DuPage Jail.

May 29, 8:18, the landlord of a property on Woodstock spoke with officers at the station regarding a former resident sleeping at the property after being evicted. Officers were able to locate the subject and issued him a trespass order on the request of the property owner.

May 30, 8:39pm, officers responded to the Jewel Osco for a suspicious vehicle that appeared to have crash damage and was blocking the entrance driveway to the parking lot. Upon arrival, officers made

contact with the driver who exhibited signs of alcohol impairment. The driver was taken into custody and charged with DUI alcohol, obstructing an officer/firefighter/correctional employee and failure to reduce speed to avoid an accident, issued a court date and released. The driver's vehicle was towed from the scene.














