**Subject:** Weekly Activity Report

#### **Recent Training, Meetings and Events:**

- Sgt Finfrock hosted a multijurisdictional UAS (drone) operator scenario class. Sgt Robak, Det Michalek, and Ofc Calderon attended the training as CHPD operators.
- Sgt Robak attended a three-day Advanced Active Shooter Management training class.
- Temporary no-parking signs were posted on the south side of Sheridan at Prospect due to recent resident complaints/concerns expressed regarding vehicular and pedestrian safety at the intersection.
- Lexipol recognized CHPD with the award for Excellence in Policy Management 2023
- The department was awarded approximately \$52,535.00 in grant funds from the Illinois Law Enforcement Training and Standards Board. The funds will be applied to cover the purchase of all department issued officer worn body cams and squad cams purchased in 2022.
- The department is finalizing plans for the annual 4<sup>th</sup> of July fireworks show, which is graciously provided by the Hinsdale Golf Club.



**Recent incidents:**

June 21, 3:57pm, officers met with a resident at the station regarding identity theft. The resident reported their computer was hacked by unknown persons who tried to convince them to send cashier checks. Identity theft resources were provided, and a report was taken in the event monetary loss was discovered.

June 21, 4:59pm, a resident on Clarendon Ct called to report an unknown male had knocked on the front door advising his AirPods were tracked to the address via Apple. The resident advised the subject that was incorrect and there were not any AirPods in the residence. The subject left after hearing this. Officers searched the area and conducted extra patrols.

June 22, 12:37pm, officers took the report of a "No U-Turn" sign being knocked down in front of the Fire Department by unknown means. Officers reviewed video footage in the area but were unable to determine how the sign was damaged.

June 23, 6:43pm, officers assisted CHFD with a subject on Ann St who was experiencing a mental health issue. The subject was transported to the hospital for treatment.

June 24, 1:14pm, a vehicle was stopped for a speeding violation on Chicago Ave. The driver was also found to be operating the vehicle with a suspended license. The driver was cited for driving while license suspended and speeding and released. The vehicle was driven away from the scene by a passenger.

June 25, 6:58pm, a resident on Prospect who was in the process of moving out of the recently sold home called to report that two unknown females opened the front door of the residence and proceeded to enter. Upon confronting them, the subjects left in an unknown direction. The resident advised they did not know if the subjects were somehow related to the sale of the home or involved in criminal activity. The area was searched with negative results and extra patrols were conducted.

June 25. 10:24pm, officers responded to the area of 55th and Alabama for a report of a disturbance. On scene a dog walker reported a car drove close to them on the roadway causing an altercation between the two parties. The subjects, who reside in unincorporated jurisdiction, later reengaged with each other resulting in one of the parties' car being "pepper sprayed". The matter was turned over to the DuPage County Sheriff's office for further investigation.

June 26, 2:58pm, a vehicle was stopped for speeding on Chicago Avenue. The driver of the vehicle did not possess a valid license either. Officers cited the driver for no valid license and speeding and released them on scene.
