1. In-house crews replaced 90 feet of storm sewer that runs underneath a fairway at the Hinsdale Golf Club. The storm sewer was made of corrugated metal pipe and had rusted out to the point where it could not be lined.
2. New plants were installed at the corner of Park and Eastern by Premiere Landscaping.
3. Fall plantings were installed in the Downtown planters by The English Garden Flower Shop.
4. I reached out to the concrete contractor at Sparrow to coordinate with them on completing some additional concrete replacement and to advise them to coordinate with their plumber regarding installation of a new water service line before completing the patio.
5. Additional work included:
 - Watering Downtown planters and new grass areas
 - Collecting water samples and transporting them to the lab
 - Farmers Market – set up and take down
 - Inspection of parkways following residential building projects
 - Utility locates
 - Troubleshooting some wifi issues at the train station

1. **Downtown Business Meeting:** Staff met with a new business owner who is looking to occupy the property at 5 S. Prospect Avenue. Since the meeting, the Operator of Jacaranda Boutique and Interiors has submitted a permit to build out the vacant unit at the corner. The Operator is interested in improving the current façade and is anticipating submitting a TIF Aesthetic Grant for façade improvements and signage.

Recent Training, Meetings and Events:

- Sergeant Finrock attended the D181 school safety meeting at the district office in Hinsdale.
- Sergeant Robak attended the DuPage County State's Attorney law enforcement training seminar at the judicial complex in Wheaton.
- Staff worked to finalize planning and setup for the "Witches Ride" taking place Saturday afternoon.
- I attended the ETSB podcast update online.
- Sergeant Wendy Porter retired Thursday after 24 years of service with the PD and Village. We are deeply grateful for her dedication and professionalism and wish her well in future endeavors.

Recent incidents:

October 10, 11:31pm, officers responded to a residence for the report of a domestic disturbance between family members. The disturbance was quelled by officers on scene with neither party having any indication of injury. One of the parties voluntarily left the residence for the evening. Domestic related resources were provided.

October 11, 11:11pm, officers were dispatched to a property damage car accident on Rte 83 near 55th St. One of the drivers involved was found to not have a valid license. The driver was issued citations for improper lane usage, no valid license and released with a mandatory court date.

October 12, 9:07pm, the owner of a vehicle called to report that their vehicle had been damaged by an object thrown by subjects riding past on e-bikes. The vehicle owner decided only to have the incident documented for reference.

October 13, 10:24am, officers met with a resident at the station for an identity theft report. The resident had fallen victim to someone filing a fraudulent unemployment claim in their name with the IDES. A report was provided for documentation purposes.

October 13, 10:am, officers were dispatched to the station for the report of a delayed domestic incident involving former in-laws. Interviews of some of the parties involved were conducted with further investigations pending.

October 14, 8:40am, officers met with a resident at the station for an identity theft report. The resident was alerted to unauthorized credit card charges to their account by an unknown subject at a hotel in

Florida. Identity theft resources were provided, and a report was made. Further investigation is pending.

October 14, 7:12pm, a vehicle was stopped for not having illuminated taillights when required while traveling on Rte 83 near Chicago Avenue. Officers discovered the driver's license was expired for over a year and they did not have valid insurance for the vehicle. Citations for improper lighting, no valid license and operating an uninsured motor vehicle were issued. The driver was released with a mandatory court date, and the vehicle was towed.

October 15, 8:53am, a vehicle was stopped for the driver disobeying a stop sign on Coe Rd. Officers learned the driver also had a valid warrant for their arrest. The driver was taken into custody on the warrant and transported to DuPage County jail.

Fire Prevention Bureau Activities:

- Two residential sprinkler inspections were conducted this week, and both failed.
