Village of Clarendon Hills Manager's Report

Date: May31, 2013

1. This week staff has been engaged in additional research and analysis for our ongoing negotiations with FOP. We will be discussing the status in executive session on Monday evening. Our next bargaining session is on next Wednesday.
2. I want to commend the Public Works Department for responses to two late night water main breaks in the Golf/Norfolk area on Tuesday evening, in the midst of a storm event. The stormwater system performed reasonably well in this event, but there were reports of some minor issues which we are following up on.
3. We are in discussions with Flagg Creek Water Reclamation District about sanitary sewer surcharging, which was a notable factor in flooding in certain neighborhoods during the April 18th event. While the Park Avenue improvements appear to have made a difference on the south side of town, we still have trouble spots north of the railroad tracks. We want to coordinate our stormwater discussions with them to the greatest extent possible.
4. Attached is the Code Enforcement Report for the week ending May 31, 2013.
5. Peg, Dan, and Brian are out of the office this week so there will be no reports from them this week. Feel free to contact any of them on Monday if you have questions about their departments.

SUBJECT: Department Notes

1. Tuesday was an...interesting...day. We experienced two water main breaks; one at Golf and Norfolk and the other in the 100 block of Prospect. Our crew repaired the first break and the contractor working for the home builder on Golf worked on the other. As we were finishing the repair, a heavy rain squall hit causing small pockets of flooding. The crew went to the areas and looked for blockages (none were found) and proceeded to check our other sensitive spots, such as the Blue Lake outfall and the Colfax/Richmond area. The system, as a whole, was functioning properly. Westmont's Dallas basin stayed within its banks, the lower section of the Park Av. Reservoir filled and was pumped-out by midnight, Hinsdale GC held water in the usual places and no overtopping was observed on the Middaugh side.
2. We are up to about 40 flooding questionnaires. A reminder that Burke will begin processing what we have thus far next week and begin some field work. We will have a status meeting with them on the 14th to assess the findings to date.
3. Ditch maintenance work continues this week. This will include some culvert replacement work. The affected residents have been notified.

Subject: Weekly Activity Report

1. Recent training:

- Several officers completed the monthly on-line Police Law training.
- Detective Shirley completed a two day traffic accident investigations class.

2. The Illinois Department of Traffic Safety "Click It or Ticket" campaign ended on May 27. Our participation includes additional officers assigned to enforce occupant restraint laws and seat belt enforcement zones in high traffic areas. The Department of Traffic Safety reimburses the Village for any overtime paid to conduct these activities. Department totals were:

- 52 seat belt citations issued
- 3 child safety seat citations
- 1 DUI arrest
- 2 fugitives apprehended
- 3 suspended/revoked license arrests
- 5 uninsured motorist citations
- 11 speeding citations

3. The promotional examination for sergeant has been scheduled for August. Selection Works of Oak Brook Terrace is working with the Clarendon Hills Police Commission to prepare and proctor a written examination and conduct oral interviews for the position.

4. Village sticker sales continue to be brisk. I would like to thank Betty Murphy, Judy Symonanis and Carol Haughey from the Clarendon Hills Women's Club for volunteering to sell stickers at the PD.

5. Lockdown drills at Clarendon Hills District 181 schools were conducted this week. Officers worked with school staff conducting surprise drills to reinforce safety plan procedures. Walker, Prospect and CHMS participated.

6. This week I met with organizers of the Daisy Dash. Paul Kelly and Mike Murphy indicated that enrollment is tracking slightly more than last year. The major difference this year is it's separation from Daisy Days but the course and other details remain the same. I will meet with Public Works this week to review our plan.
7. Today is Police Assistant Kelly Connelly's last day in the office. She accepted a position as a Chicago Police Officer and begins the police academy on Monday, June 3rd. Kelly started in the Village in 2012 and has done an outstanding job. She will work her last day for us at the Bike auction on June 8th. I want to wish her well in her new job; I know she will make a fine police officer.
8. Police Officer and Army Reservist Todd Helms will return to his police duties on June 17th. Todd has been on active reserve duty since May 2012. Following a training review with field training officers, Todd will be back on patrol in the Village. Officer Colin Hutchins, our newest officer, is scheduled to graduate the police academy on June 28th. He will then begin his 12 week field training with Clarendon Hills officers.

Significant traffic and criminal activity during the period May 24, 2013 through May 30, 2013

1. On 5/24 a Chicago resident reported that her car had been damaged while it was parked on the 200 block of Stonegate. A hit and run report was completed.
2. On 5/25 a resident on the 400 block of McDaniels reported that a black SUV had stuck the decorative light pole in the complex and left the scene. The black SUV sustained significant front end damage and was driven by a bald male white as it left the scene westbound on Park. Pending.
3. On 5/26 a Chicago resident reported that his car had been damaged while it was parked on the 100 block of S. Prospect. Damage is estimated at \$1500.00
4. At 2:22 am on 5/25, a 24 year old Westmont resident was stopped by Clarendon Hills officers on 55th St. After an interaction with officers he was arrested for DUI, having a blood alcohol concentration over .08, improper lane usage, operating an uninsured vehicle and illegal transportation of open alcohol.
5. On 5/29 a Chicago resident reported that her vehicle had been damaged while it was parked on the 10 block of Chestnut. Damage was estimated at \$1500.00
6. Clarendon Hills' officers made three arrests for driving with a suspended/revoked driver's license and served three arrest warrants in the last week.

Stepped up seat belt enforcement continues through May 31 in Clarendon Hills

CLARENDON HILLS — The 2013 Click It or Ticket continues through May 31 in Clarendon Hills.

The statewide effort is aimed at helping to save lives by cracking down on those who do not buckle up through the Memorial Day holiday weekend. Click It or Ticket started May 10.

The Clarendon Hills Police Department joined forces with the Illinois Department of Transportation, the Illinois State Police and more than 500 local law enforcement agencies in Illinois to save more lives by strongly enforcing seat belt laws.

“We try to focus on areas where we can see if people are wearing their seat belts and where there’s enough traffic to make it worthwhile ,” Clarendon Hills Police Chief Ted Jenkins said. “Most of the tickets are issued when we first start because a lot of people had forgotten about wearing their seat belts. The awareness for it catches on pretty quickly, though, and we a lot more compliance after the first few days.”
