Village of Clarendon Hills Manager's Report

To: Village President & Board of Trustees

1. We have completed the data entry for this year's Community Needs Survey. The results will be available in mid-October. We had a lower response rate, likely attributable to the timing of the survey. 268 people completed the survey. Many thanks to Cheryl Pierce for completing the data entry and to Christina Burns for overseeing the project.
2. The Special Events Committee held the year-end dinner on Wednesday. This year's concert was a success, with revenues exceeding expenditures by about \$8,000. The committee budgets conservatively on the concert in the event of a rain out. If we were to have to cancel a concert, we typically still must pay the band and stage company but would not receive the beverage revenue. The Committee discussed what went well and what they want to improve for next year. We will again begin the process of securing sponsors in October.
3. I attended a DuPage Mayor's and Manager's Conference "Coffee Break" meeting on Tuesday morning in Naperville. This event provides networking opportunities for municipal officials and DuPage area State Legislators. I had the opportunity to speak with various individuals. The consensus in Springfield at this time is that there is a waning momentum to discuss any serious pension fixes as the election season approaches. So it is possible we will not see any discussions of those matters until after the election. There is also a rumor that the fall veto session may be cancelled outright or shortened.
4. Discussions are continuing with another potential cell antenna tenant for the Burlington Water Tower. We hope to have a draft agreement to bring before the board for discussion sometime in October.
5. On Wednesday afternoon I participated in a meeting of the new Manager's Committee of the DuPage Mayors and Managers Conference. We discussed the upcoming implementation of the new Illinois Concealed Carry and Medicinal Marijuana Laws. We will be sending Police Staff to some additional training on both of these issues before their January 1, 2014 effective dates. Both laws have implications for law enforcement procedures and human resources management. The Medicinal Marijuana law also has

zoning implications. We are working with our neighbors to identify best practices in all of these areas, and to help ensure some level of consistency in our region.

Another topic of discussion at the meeting was joint purchasing. There are a couple of interesting avenues that we may explore based on information I received at this meeting. We are finding that our size sometimes limits the quality of our bids on certain items and services, by bundling our bids with neighboring communities, additional economies of scale can be achieved. Mike Millette and I are now working to identify some projects that may be good candidates for joint bidding over the next year. Once we have some additional information, we will bring this topic to the Board for discussion in the near future.

6. I attended a meeting of local government leaders whose jurisdictions fall within in County Board District 2 on Thursday. We discussed a number of issues of mutual interest, including a CDBG grant that the County was awarded for Disaster Recovery for the April Flooding event. Some funds may be made available to municipalities. However, it is possible that economic means testing will be a factor in determining which communities are eligible for assistance. Staff will be following information on this project as it becomes available closely.
7. As mentioned previously, Chief Jenkins has been in discussions with a local Boy Scout troop about the possibility of having an educational apiary (artificial bee hive) somewhere on Village property near the Public Works/Police Campus. We are still looking into options, but we believe this could be an excellent educational tool for area kids. Chief Jenkins is fairly knowledgeable about this topic as he is an amateur beekeeper. We will be presenting this concept for discussion at an upcoming board meeting, but we believe this could be a project that lends itself to partnerships with other community groups as well.

SUBJECT: Department Notes

1. Work on the 2013 Road Improvement Program will begin with grinding on Holmes this coming Monday the 23rd. A road closed notice sign was placed yesterday and we are in the process of distributing flyers today and are reaching out to the school districts. The primary detour route will be Prospect which may pose a challenge to commuters who wish to travel eastbound on 55th. We intend to monitor the intersection on Monday and Tuesday in order to assess the potential delays there. If modifications are necessary to the detour route, they will be made. The bulk of the work on Holmes should wrap-up by the beginning of November as the contractor shifts more effort to the other streets in this year's program.
2. Work on the 2013 Water Main Replacement Project continues about one week behind schedule. The contractor has delivered a second set of equipment but the second crew was unable to start this week. They will be on site Monday.
3. We spoke with the resident at the south end of Churchill and have developed a landscaping concept consisting of a small planter bed and some bushes. We will install this within the next two weeks.
4. Bids for the 2013 Sidewalk R & R program were opened yesterday. The apparent low bid is well under budget and will be presented at the 10/7 Board meeting.
5. We are continuing our pavement marking repainting work and will go as far into the month as temperature will permit. 70s are ideal, 60s are marginal and 50 or below are too cold.

1. **DTMP Update** - Upcoming subcommittee meetings* are scheduled as follows:

2. **Vintage Confections** - Vintage Confections, currently located at 102 S Prospect behind Starbucks, has decided to continue to grow their business in Downtown Clarendon Hills. Earlier this week, the owners signed a long-term lease that will allow them to relocate their expanding business into the former Modern Dog Boutique space at 29 S Prospect. Congratulations and thanks to them for making the Village their home.
3. **227-231 Burlington Demolition and Restoration** - We are slowly getting the final stretch of this restoration project. Although top soil delivery began this week, the owner still needs to back fill the hole in the center of the property, remove concrete along the rail road tracks, and clear the site of debris. It is also important to note that the Village recorded a lien for legal and project management costs incurred as a result of this much needed property maintenance project.
4. **Infiniti of Clarendon Hills** - Earlier this week, Randy Recklaus and I met with Peter Korallus, the Executive Manager for Infiniti of Clarendon Hills. Mr. Korallus reported that business was improving at a reasonable pace and that they are maintaining their focus on providing superb customer service and sales. He also noted that this store was most recently ranked 3rd in the Midwest Region.
5. **Permits Issued** - The Village issued 14 permits so far this month having a construction value of \$1,875,000.

1. Fire Prevention Bureau Activity during the past 2 weeks.
 - Work continues on the computerized pre plan project.
 - Five (5) Fire Prevention/Life Safety Inspections were conducted.
 - Work preparing for the annual fire prevention open house is in progress which will be held on Saturday, October 5th.
2. Training Report:
 - Wednesday evening. Twenty six (26) Firefighters attended training. The subject was Global Harmonizing System (formerly known as Right to Know training) regarding material safety data sheets, etc. Captain Rediehs will also be conducting this for all other departments in the village before December 1st.
 - The three (3) new POC firefighters attended recruit training on Thursday evening.
3. Emergency Medical Services Report:
 - The ambulance replacement committee has been meeting with various vendors during the last 2-3 months and we should soon have the specifications completed for the replacement for our current 2007 Ambulance.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report
5. This week I continued to work with the FEMA representative assigned to us to refine our application for reimbursement for emergency costs associated with the april 18th flooding event.
6. Car 301 (Chief) was taken in last week for warning light repairs at Lund Industries in Northbrook. On Friday car 398 (Fire Prevention) was taken to Lund for warning light repairs also.
7. Last Friday, Deputy Chief Farmer and I attended a special SWCD meeting to discuss Starcom Radio systems related to police and fire operations.

8. Last week, Captain Mark Rediehs and EMS Coordinator Dave Godek attended noise meter training that was done by IRMA.
9. On Monday, Deputy Chief Krupp coordinated a review with all departments present to go over the Computerized Emergency Management Program (CEMP). The CEMP contains our Emergency Operations Plan. The entire document was reviewed and updating will be done over the next 30 days.
10. On Tuesday, FPO Godek attended the SD181 Crisis meeting in Burr Ridge.
11. On Wednesday, I attended the monthly meeting of the MABAS 10 Fire Chiefs. The main topic at this meeting was the strategic funding plan for MABAS 10.
12. On Thursday, I attended the monthly meeting of the SWCD Executive Committee. The replacement of all mobile data computers for all fire and police departments (220 computers) was approved and will now go to the Board of Directors in October for approval. Also the engineering required for the Net 9 police radio system patch to Starcom was approved.
13. Today, DuComm is at the fire station updating all of the firmware on the seven (7) Starcom mobile radios located in fire department vehicles.
14. On Monday, Engine 311 (2002 Pierce) was taken to Wirfs in McHenry for annual maintenance and repairs. Normal preventive maintenance and servicing will be done to this 13 year old vehicle. Pump and generator service testing will also be done. The tires are being replaced and the fuel tank is being replaced because it is rusting and beginning to leak fuel. The vehicle should be back in service next week.
15. This week the interview and assessment committee for the promotion for Fire Department Lieutenants completed their work. Eight (8) firefighters went through the testing and assessment process during the past 2 months. We will be promoting four (4) firefighters to Lieutenant at the October 7th Board meeting.

 - During the past 2 weeks Clarendon Hills FD responded to ten (10) automatic response calls in Hinsdale.

 - Tuesday, September 10th at 7:03 PM. The fire department responded for a Com Ed transformer on fire in the rear of 120 Arthur Ave.
 - Wednesday, September 11th at 1:01 PM. Ambulance 314 responded to assist the Hinsdale Fire Department with an ambulance in the 700 block of Maple in Hinsdale.
 - Thursday, September 12th at 10:12 AM. Ambulance 314 responded to assist the Tri State fire Protection District for an ambulance call at 6340 Americana drive in Willowbrook.

Clarendon Hills considers sign requirement for zoning changes

In an effort to increase transparency, Clarendon Hills is considering a new requirement for notice of hearing signs to be posted on properties subject of a public hearing.

Village Trustee Eric Stach first suggested the sign requirement June 15.

The Village Board gave preliminary approval but will vote on the policy Oct. 7.

"It's a way to increase transparency and get greater input from the community," Stach said. "It's a very common tool used by municipalities. It's another way to let people know that a change in zoning is being sought for a particular property."

Zoning regulations require notice of public hearing to be posted in a local newspaper and mailed to property owners within 250 feet of the subject property. Agendas for public hearings also are posted on the village's website and at Village Hall.

The Zoning Board of Appeals/Plan Commission conducted a public hearing Aug. 22 and recommended the new requirement that a sign be posted 15 and 30 days on a property prior to scheduled hearings.
