Village of Clarendon Hills Manager's Report

1. I am happy to report that flooding has subsided in all areas of the Village and the only road currently closed is Park Avenue, roughly between Western and Richmond, due to a large amount of debris. Public Works is working on the clean-up and the road will be re-opened by the end of the day. Republic Services will be doing special storm related waste pick-up for the entire community on Saturday and Monday. The entire town will be covered both days in case people are unable to get all of the waste out to the curb on Saturday. No stickers will be required for either day, but residents are asked to get their garbage out by 7am. Notification went out via all the normal social media and a press release. A code red reverse 911 call will also go out to all Clarendon Hills residents with the information today. Dan Ungerleider and I will also be going door to door in a couple of the particularly hard hit areas to spread the word as well.

The Village phones are still down, but we have cell phones in every department so we can continue to take calls. The temporary numbers are available on our home page. AT&T is working on the problem and getting a back-up system for our phones is something we are looking into.

This storm required a full team effort of Village staff over the past 24 hours. Police and Fire responded to numerous calls both in town and in support of neighboring communities. Our front desk staff continues to respond to a variety of calls big, and small related to the event, and have organized and prioritized the response of our operational staff. The Village Manager's Office coordinated ongoing communication during the event and was able to get our garbage provider to be available for a quick clean-up. Community Development and Finance are in charge of damage assessment and record keeping in anticipation of possible federal and state assistance. Public Works was active supporting residents in a variety of ways and will be inspecting and restoring roadways over the next several days. I am very proud of all of the work that has been and is being done by everyone to support the community throughout this event.

2. The Chamber met Wednesday morning at Village Hall. They discussed the upcoming Daisy Days event and potential changes to the Chamber's website format. Christina

Burns represented the Village and encouraged members to participate in the Downtown Plan Update process.

3. I attended a meeting of the Southwest Central Dispatch Board of Directors on Wednesday evening as the Clarendon Hills representative. Chairman Bennett has agreed to hold a special meeting of the board to discuss the betterment of the financial reporting system that is supported by Clarendon Hills, Burr Ridge, Hinsdale, and Willowbrook. Special thanks to Chief Leahy who has shown a lot of leadership on this issue.
4. Mike Millette will not have a report this week due to the heavy storm response.

- Zoning Board of Appeals/Plan Commission** - On April 18, the Zoning Board of Appeals denied a homeowners request for a floor area ratio variation. Although the ZBAPC agreed that the current ordinance is flawed, the petition had not presented adequate justification to receive a variation at this time. The ZBA/PC is final for variation requests.
- 88 Park Av (fka 103 S Prospect Av)** - The public hearing for 88 Park Av (fka 103 S Prospect Av) was rescheduled to May 9, 2013 at 7:30pm due to an error found in the petitioner's application and related published notice for the public hearing. A revised notice for the May 9th meeting was mailed and published in accordance with Village Ordinance.
- Demolition of 227-231 Burlington Avenue** - Preparations for demolition continues. Although the April 18th storm added some delay to the start, fence installation and Nicor disconnection should occur and day.
- Downtown Master Plan (DTMP) Update** - The volunteer committee members and staff continued to prepare for the upcoming community visioning meeting. This second community event will be held on April 24 at 7pm in the Clarendon Hills Middle School. All are welcome to attend and encouraged to participate.
- National American Planning Association (APA) Conference** - I attended the Conference from April 13 -17 in Chicago. During this 5 day event, I participated in workshops, discussion groups and activities regarding: shared parking, community engagements, sustainable development and design, complete streets, economic development, government budgeting, comprehensive planning, and electric vehicle requirements, to name a few.
- Storm Event** - As part of the Village's management team, I began preparations for the recovery stages resulting from this natural disaster.
- Permits Issued** - 4 permits were issued this past week, including a demolition and 1 new home. The reported value of these permits was \$407,785.

1. Recent training:

- 2 officers completed dealing with variant behavior on-line training.
- One officer completed the April on-line training module.
- Officers Finfrock and Shaw completed an 8 hour class on the Psychology and Tactics of Violent Encounters.
- Five officers completed a 4 hour block of instruction relating to the handling of persons with mental health issues.

2. Supervisors are finishing up the last few performance evaluations this week.
3. Prescription drug collections continue this week at the PD, FD and Village Hall. Due to the recent storms our collections have been slow but will continue through Friday April 26.
4. 15 administrative tow hearings were scheduled this week. The Village prevailed in all 15.
5. I want to acknowledge the exceptional performance of not only our police officers but all Village employees this week. Many struggled to get in, some left flooded homes and all of them displayed a cooperative spirit dedicated to helping Clarendon Hill's residents not as employees but as friends and neighbors. Your efforts have been recognized and acknowledged by many, I am proud to work with you all.

Significant traffic and criminal activity during the period April 12, 2013 through April 18, 2013

1. On 4/13 damage to a fence between Tracy's Tavern and the Reserve was reported. No dollar loss is reported. Pending

2. On 4/12 a resident on the 100 block of Harris reported a watch and jewelry valued at over \$30,000.00 and an American Express card missing from her home. Our investigators have recovered some of the property from area pawn shops and are investigating a person known to the resident. Pending.
3. A resident on the 400 block of 56th Street reported that someone had entered her unlocked vehicle while it was parked in the driveway on 4/16.
4. On 4/16 a resident from the 10 block of 58th Street reported that her social security number had been used to open a Direct TV account. The account currently has an unpaid balance of over \$1000.00. She was helped with identity theft information.
5. On 4/18 a 16 year old Hinsdale resident and a 17 year old Clarendon Hills resident were taken into custody for driving through Hosek Park following the heavy rains. Witnesses alerted the police when a black Land Rover drove off the roadway on the 300 block of Harris and into the park. The vehicle drove around the interior of the park and then back onto the roadway on the 300 block of Hudson. Officers located the vehicle on Walker near Ridge and took the two occupants into custody. 1. Fire Prevention Bureau Activity during the past week.

- Five (5) Fire Prevention/Life Safety inspections were completed this week.
- Work continues on the computerized pre plan project.

2. Training Report:

- Due to severe weather the practical training to be conducted at 141 Chicago Ave. was cancelled. Twenty one (21) firefighters conducted inside practical training with small equipment inside the station.

3. Emergency Medical Services Report:

- No report.

4. Clarendon Hills/Hinsdale FD sharing of services report:

- No report.

5. On Tuesday, Deputy Chief Krupp and I attended the quarterly meeting of all Local Emergency Management Coordinators in Glendale Heights.

6. On Tuesday, Mike Millette, Randy Recklaus, Ted Jenkins and myself met to discuss fleet maintenance options. We are discussing this to look at possible options to reduce costs.

7. Flooding and storm situation report:

- Wednesday afternoon I participated in a DuPage Office of Homeland Security and Emergency Management (OHSEM).
- Thursday morning at approximately 4:00 AM., streets in the village began to flood and the Fire and Police Departments began to receive and respond to calls for flooded basements, electrical problems, people stranded in vehicles, etc.
- Thursday morning at about 6:00 AM, it was discovered that the AT&T IP telephone line that feeds the villages telephone systems failed due to flooding near 421 Park Ave. At this time this is still not working.

- Backup cellular telephones were deployed to all village facilities and this information communicated to the public via the internet.
- On Thursday morning the DuPage County Board chairman Cronin signed a declaration of Emergency for DuPage County.
- On Thursday afternoon, Governor Quinn declared 38 counties (including DuPage) Disaster areas.
- Also on Thursday, Village President Karaba signed Declarations of Disaster and Emergency. These declarations have been forwarded to DuPage County.
- In 24 hours the fire department responded to forty two (42) emergency calls for flooding in basements, electrical problems, gas leaks, carbon monoxide problems, rescued people from cars trapped in flood waters, removed residents from flooded homes, etc.
- At the peak of the flooding incident, the fire department had seventeen (17) members on duty and responding to emergency calls.
- Thursday afternoon, a crew of six (6) Clarendon Hills Firefighters assisted the Hinsdale Fire Department at 21 Spinning Wheel Road to assist in the evacuation of this 17 story apartment building because of a power failure caused by flooding.
- All village department heads met early Thursday morning to discuss and develop a response plan.
- All village department heads met on Thursday afternoon to discuss progress and recovery efforts.
- Today (Friday) at 10:00 AM all village department heads will meet to discuss progress, pending problems and also recovery efforts.
- All village departments are closely tracking expenses and recording them in detail in the event that disaster cost reimbursement occurs.

8. Incidents of Interest:

- During the past week Hinsdale FD responded to thirteen (13) calls in Clarendon Hills.
- During the past week Clarendon Hills FD responded to fifteen (15) calls in Hinsdale.

9. Fire/Rescue/EMS calls:

- During the past week the fire department responded to eighty one (81) emergency calls.

The following is a press release from the Village of Clarendon Hills:

The Village continues to monitor the flooding event that has impacted large portions of Clarendon Hills. The Village's storm drainage system is operating as intended, but it is simply beyond capacity due to the high volume and short time period in which the rain fell. Police and Fire personnel will continue to monitor the situation, and Public Works crews will remain on call to respond to issues. This event has impacted many homes and businesses.

For your safety, residents are reminded to use caution near flood waters. Do not attempt to drive or walk through standing water. Do not enter flooded basements due to concerns of electrocution. Please call 911 if you have concerns about sparking or electrical equipment in a flooded a basement. If you have sewage back up, please contact Flagg Creek Water Reclamation District at 630-323-3299.

For those residents whose homes are uninhabitable, Benedictine University has been opened as an emergency shelter at 5700 College Drive in Lisle, Illinois.

Village President Karaba has declared an emergency. While this does not guarantee assistance, it may allow residents opportunities to receive funds or loans for uninsured damage related to the floods. Residents are encouraged to take photos and keep receipts of any repairs. Additional information about any potential assistance programs will be released as it becomes available. The Village is currently working with Republic Service on a cleanup schedule for impacted areas. Again, residents will be notified as additional information is available.

The following roads will remain closed until the water recedes and clean up is completed:

- Park Avenue between Richmond and Western
- Richmond Avenue between Colfax and Park
- Burlington Avenue between Oxford and Iroquois

The Park Avenue detention area has seen significant flooding. Storm water drains from Westmont and Blackhawk Heights to Park Avenue before flowing toward Flagg Creek. We expect the detention basin to begin draining once waters upstream subside and capacity opens downstream. The pump located in this detention basin has failed, however this has had no impact on the rate of water draining from the area. The pump is intended to make the detention basin usable for recreation and will be assessed once crews can reach it. In addition, ComEd is reporting a small power outage

along Park Avenue.

Village Hall will open at 8 a.m. on Friday. Phones will continue to be down as the flooding impacted the Village's phone connections. To contact the Village, please use the following alternative numbers until further notice:

Flooding closes streets throughout area

More than 4 inches of rain has fallen over the past 24 hours across DuPage and western Cook County, and another 2-5 inches is expected to fall throughout the day Thursday.

The heavy rains are causing flooding of streets, leading to road closures, including York Road at the Hinsdale/Oak Brook boundary where Salt Creek has flooded the roadway at Spring Street, in front of the Graue Mill.

Sections of Ogden Avenue through the region were down to one center lane, particularly in Hinsdale just east of Route 83.

The heavy rainfall has raised elevations in Salt Creek and led the DuPage County Stormwater Management to operate its flood control facilities, including the Elmhurst Quarry which takes in Salt Creek water, and Wood Dale-Itasca Reservoir. Smaller, gravity operated facilities are also operating.

Metra trains are running, but experiencing delays of 20 to 45 minutes.

In DuPage County, offices at the government complex in Wheaton were closed except for courts and emergency services.

Westchester Elementary District 92 1/2 canceled classes today at all of its schools.

Burr Ridge is reporting power outages north of Route 83 Street and west of County Line Road.

Clarendon Hills residents should get cul-de-sac fix

CLARENDO HILLS — It appears that the handful of residents who came to Monday's Clarendon Hills Village Board meeting asking for help are going to get it.

Kristine Gross, of the 200 block of Churchill Place, was the spokesperson for those living on the cul-de-sac street, which runs only one block, north from 55th Street.

Gross said residents of the 24 homes are concerned about the street's ending at 55th Street. Trees planted there by residents and most of a fence between the end of the Churchill and 55th Street weren't left standing when a major road improvement project on 55th was completed late in 2012.

The Churchill Place residents are asking that the cul-de-sac be closed off again with a full fence.

"There isn't supposed to be access for vehicles from or to 55th from our street," Gross said. "We have 33 children on our block, so safety is a big issue."

The presentation Gross included a crime brief from the April 1 Clarendon Hills Doings about tire tracks found on the parkway between 55th Street and Churchill Place.

"It really isn't very clear there now that vehicles aren't supposed to be going across," Gross said.

Public Works Director Mike Millette said he has been in touch with representatives from the DuPage County Division of Transportation, which completed the 55th Street road improvements, about fixing the situation with the cul-de-sac.

"The county said it will extend the fence and repair the sod damage," Millette said.

The village may extend another section of the fence so that only a small pedestrian opening remains.

Village Manager Randy Recklaus said village staff would work with the Churchill Place residents in hopes of having the situation resolved to their satisfaction.

"I'm thrilled," Gross said. "We just want to get this taken care of because we're concerned about safety."

DeeDee Gorgol said she'll feel a little down after her last meeting as a District 86 board member in May.

"It will be sad," Gorgol said. "You make a group of friends and have a common interest and goal and it will be sad because ... I'm afraid maybe some of the goals we were putting out there won't be realized."

Gorgol and Board President Dennis Brennan are current board members who failed in their bid for reelection last week running as part of a slate that also featured current board member Kay Gallo and Roseanne Rosenthal. Gallo was the slate's only winner, as the "Friends for District 86" slate of Victor Casini, Ed Corcoran and Claudia Manley swept the other three open spots.

Gorgol said the results of the election were disappointing, but she's very glad Gallo has a spot on the board.

"There are still three strong members on the board that share my thoughts and my beliefs on how things should move forward with the district," Gorgol said of Gallo, Michael Kuhn and Jennifer Planson.

Gorgol is proud of the work she did during her four years on the board. The installation of turf fields at both schools and the recent improvements that included air conditioning and new, more secure entrances are among the accomplishments that she'll remember most and that she hopes the community remembers most.

With regard to the "Friends" slate that had a strong showing after a contentious campaign, Gorgol said Corcoran has appeared to be levelheaded and well intentioned to her, but Casini and Manley have not.

"I'm hoping that's not true," Gorgol said. "I just would hate to see the district go backward instead of moving forward."


Would Gorgol consider another run in 2015? She said if things go well over the next two years, she'd be fine passing the torch for good. But she didn't close the door.

"A lot will depend on what happens over the next two years," Gorgol said. "If things go downhill and I can't stand it, then I'll have to step in again."

It appears District 181 board members still need some convincing that late starts are the best way to provide additional professional development time for teachers next school year.

"I thought this one would be an easy one for me, but it's not," board member Marty Turek said at the board's April 8 meeting at [Elm School](#).

The eight two-hour late starts during the 2013-14 school year have been [proposed by District 181 administration](#) as a way to provide professional development for teachers as the district implements its new Advanced Learning Plan and the nationally mandated Common Core.

The late starts would align with those on the District 86 calendar, in an attempt to reduce inconvenience to families.

For working parents who can't stay home the extra two hours on those days, the district would offer morning child-care "for a fee that covers actual costs only," a board report from Superintendent Renée Schuster reads.

The late starts are currently included in the proposed 2013-14 calendar. The final calendar is expected to be approved at the board's May 28 meeting.

No board member voiced total support of the late starts last week. One member, Yvonne Mayer, said she was "completely opposed" to them (though her term will expire before the board's vote), and several others said they were curious about alternatives that would be both in the interest of families and within the constraints of the district's contract with its teacher union.

Schuster said two possible alternatives are early releases and the use of substitutes while teachers attend professional development sessions during classroom hours.

"With anything, you have to weigh the pros and cons," Schuster said.

Early releases, Schuster said, would cause scheduling issues for extracurricular activities, and the substitute alternative does not provide for district-wide development sessions, which Schuster said the administration wants to increase.

The superintendent said the late starts remain an idea only.

"We'll come back with it flushed out more before we ask the board to make a decision," Schuster said.

Turek said he preliminarily favored the idea of early releases, which seem less disruptive.

Board members said they've received many letters from the community on the issue.

District 181 parent Vivian Hessel of Clarendon Hills said during public comment last week she thinks late starts "are a terrible idea" because they will take instructional time away from students and represent lower expectations for teachers when those expectations should be raised.

"Late start days will also put undue burdens on families, especially burdens on two-parent working households like mine, and single-parent working households because this will be another scheduling task," Hessel said.

A parent survey is being distributed Monday to get the community's wider opinion on late starts. There are also two upcoming public meetings on the ALP, where late starts and professional topic will be among the discussion items, on April 25 and May 2. District 86 Board President Dennis Brennan said he believes his failed reelection bid is partly the result of serving on school boards that have taken action to improve the district and its facilities.

"If you sit there and do nothing, you'll probably get reelected," Brennan said Thursday, more than a day after his four-candidate slate placed only one winner. "But if you try to get something done ... you're going to probably raise the opposition, whoever that is."

In 2013, that opposition was "Friends for District 86," the candidate slate of Victor Casini, Ed Corcoran and Claudia Manley [that managed to go three-for-three Tuesday](#) after a campaign centered around improving fiscal responsibility, transparency, and community involvement in District 86.

Kay Gallo was the only winner from the "Building on Excellence" slate that also featured Brennan, DeeDee Gorgol and Roseanne Rosenthal.

During his eight years on the board—the last six of which he has served as president—Brennan said the district has made "much-needed improvements" to its facilities, bettered security in the district, and sought to eliminate the perception that [Hinsdale South](#) does not get same level of attention from the district as [Hinsdale Central](#).

Brennan said he wishes the three new board members well but issued a warning.

"It is tough to be a board member, compared to being out in the audience," Brennan said. "It's a lot easier out there, second-guessing everything."

Knowing how the race ended, Brennan said it might have benefited the slate to start campaigning earlier and to more aggressively attempt to convince the Downers Grove Township Republicans, [who officially supported the "Friends" slate](#), not to make an endorsement.

Brennan, who said his slate had little chance of getting that endorsement because of the differing political affiliations of its members, feels the party should stay out of nonpartisan elections like those for school board seats.

"Interference in this process was wrong and it was shameful," said Brennan, a Republican himself. "I do think they need new leadership in that organization."

Looking back, Brennan said the district is better off now than it was before he was first elected in 2005, and he hopes he is remembered as someone who served on boards that took political chances in order to improve the district.

Brennan said he left voicemails to congratulate each "Friends" winner after the election. He hopes they keep in mind the community and students when making decisions as board members, and keep out of mind some of the fiscal-issue ideas raised during campaign, such as not raising the tax levy year over year.

"I hope they really don't think they can zero-levy and not affect the programs and affect classroom teaching," Brennan said.

The outgoing board president expects to feel a void for a period of time after his last meeting in May, but he said he'll eventually move on.

And there's definitely one perk of not being reelected.

Brennan recalled a community member during the Hinsdale South Film as Literature movie controversy last year telling him he might lose his position if he doesn't watch out.

"Then I get to watch Monday Night Football," he said.
