Subject: Department Report

1. **227-231 Burlington Av** - Demolition work began today, Friday, June 14, 2013. The initial work of razing the buildings is expected to be completed within the next three weeks. Site restoration will take additional time. The contractors for asbestos removal and building demolition have been contracted and paid for by the property owner. Village expenses so far have included environmental reporting, attorney fees, staff time and project management via the Village's consulting engineer. The Village will be appearing in court this Monday morning to provide a status report to the judge.
2. **Downtown Master Plan (DTMP) Update** - Two of the three subcommittees met this past week to discuss existing conditions found in the downtown. Minutes from their previous meetings continue to be posted on the Village website. The next set of subcommittee meetings are scheduled as follows:
 - a. DTMP Land Use Subcommittee - Monday, 6/24 at 6 pm
 - b. DTMP Design Subcommittee - Tuesday, 6/25 at 7 pm
 - c. DTMP Economic Development Subcommittee - Thursday, 6/27 at 8am
3. **88 Park Av** - Mr. Van Zandt, the owner and the proposed developer of the property (fka 103 S Prospect) is scheduled to appear before the ZBA/PC for Conceptual Plan Review on June 20 at 7:30pm. Although this will be an open public meeting, it will not be a public hearing. During that meeting the ZBA/PC will provide comments, suggestions or points of concern to Mr. Van Zandt. Once completed, he may apply for preliminary planned unit development review which will include a public hearing before the ZBA/PC and Village Board review.
4. **CH CO2** - We continue to assist with the "carbon footprint" or CHCO2 events planned for the former police station property. The CHCO2 program is being managed and coordinated by community volunteers to establish and encourage positive dialogue about how we as individuals and as a community as a whole impact our environment and the planet. Their first event will be held from 8am to noon on site tomorrow morning, Saturday June 15th. Their first educational program will be held from 5:30pm to 6:30pm on Wednesday, June 19th before the *Dancing in the Streets* festivities begin. 1. Recent training:
 - Two officers completed the monthly on-line Police Law training.
 - Detective Shirley attended a 40 hour Basic Investigation Skills Program.
2. The Illinois Association of Chiefs of Police Traffic Safety Committee has awarded the Clarendon Hills Police Department third place for our Traffic Safety Challenge submission for 2012. The Traffic Safety Challenge documents efforts in traffic enforcement, pedestrian safety, public education and awareness, bicycle safety and other traffic safety efforts during the year. Clarendon Hills competes in the category that receives the most submissions, the 11-25 member municipal police department category. Participation in the Safety Challenge has always been voluntary but last year participation in the Challenge was made a condition of many traffic safety grants and the number of competing departments has increased. Congratulations to Officers Jeff Pasteris, Tom Laird, Zack Finfrock, James Shaw and Sergeant Paul Dalen for their state wide third place finish.
3. The Daisy Days Bike Auction was a success. All but one bike, two bike frames and a spare tire were sold. Net proceeds were \$627.00.
4. On Monday, Officer Porter and I attended a District 181 Safety meeting. Topics included changes in the crisis plan, updating procedures and expectations for the next school year.
5. Final preparations for the Daisy Dash were completed this week.
6. Christina Burns and I conducted interviews with three applicants for the part time police assistant position. We hope to wrap up the interviews early next week.

Hinsdale-Clarendon Hills District 181 looks into slip in test scores

CLARENDON HILLS — Administrators in District 181 plan to continue looking into why third-graders in most of its schools saw scores slip in growth on MAP testing during the 2012-13 school year.

Those students, who were involved in a pilot math program, did not fare very well in reaching growth targets on Measures of Academic Progress testing, which measures student growth during the school year. The 2012-13 pilot combined third- and fourth-grade math curriculums for the third-graders.

Districtwide, 47.2 percent of third-grade math students reached growth targets, compared to 55.7 percent in 2011-12. Elm School and Oak School were the only two of seven Hinsdale-Clarendon Hills Elementary District 181 schools at which the percentage of students reaching growth targets increased this year from 2011-12; there was a decrease at the other five schools.

"We need to look more at the inconsistencies between some of our schools," said Kevin Russell, director of curriculum, assessment and instruction. "We want to make sure we're consistent in how we're presenting materials."

Russell said goal setting with MAP testing with individual students is something that could be used in the future.

Concern about the slip in the percentage of students meeting growth targets was part of the reason about 50 parents showed up at a May 28 board meeting. Parents also spoke out against a new pilot math program for 2013-14, and the board voted against implementing it.

Superintendent Renee Schuster said she, too, would like to see the percentage of students meeting growth targets on MAP testing increase. However, she also was not discounting the positive aspects of the pilot math program used for third-graders in 2012-13.

"I would not agree that the pilot failed," she said. "Only looking at the growth numbers from the testing is too limiting of a view. Our achievement was very high, and not meeting growth targets doesn't mean there was no growth. You may have made considerable progress and still not have made your growth targets."

Schuster said teachers at Oak School, where students showed improvement in growth targets for 2012-13 over the previous year, have been asked to share insights with colleagues in other schools.

D181 begins summer projects

Hinsdale-Clarendon Hills Community Unit School District 181 has its work cut for it this summer to including stemming roof leaks at Hinsdale Middle School and removing diseased trees from throughout the district.

The 2012-13 school year is only just over, but the district is already starting to prepare for next school year.

Officials said the district's greatest focus will be on improvements at Hinsdale Middle School, which is 35 years old.

Jim Prusa, facilities coordinator for the district, said work began this week on 15 downspouts on the roof at the school.

The school was not flooded by the April 17-18 rainstorm but had already been affected by existing leaks.

"The normal leaks exposed themselves," Prusa said.

He said the district also will try a new method for connecting the downspouts to the sewer system.

"The new way will be better. There will be fewer leaks," he said.

Another major project at the school will be renovation of the first-floor boys', girls' and faculty bathrooms.

"We're replacing the galvanized metal piping in the walls with copper piping," Prusa said.

The restrooms will also get new water-tight floors and new ceilings. The current sinks and toilets will be maintained.

"The fixtures were in good condition. In an effort to maintain costs we're keeping them," said Gary Frisch, assistant superintendent for business operations.

Frisch said the cost of reworking the downspouts is \$173,000. The cost of the restroom renovation is \$138,000. He said the \$311,000 total for these projects is well under the \$424,000 that was budgeted for them.

The district also plans to remove eight trees from school properties throughout the district that have been impacted by the emerald ash borer. Prusa said the district did a tree survey last year to find what trees had been invaded by the insect that causes the disease in trees.

"If more trees have been affected since then we'll have to do another survey this summer," Prusa said.

Other regular maintenance work planned in the district includes deep cleaning and regular maintenance of heating and air conditioning systems at all schools. Frisch said the district is hiring 24 additional people to work during the summer. He said the district plans a new way of assigning cleaning work. Instead of having one cleaning team per building, it will deploy groups of cleaning teams to cover two school buildings.

Prusa said the new method is expected to be more efficient because work will not be affected when workers take vacation days.

Frisch said all schools, except Prospect School, will be open only four days a week, Monday through Thursdays during the summer. Having the schools open only four days will save money, he said.

Prospect School will be open five days to host a summer learning program through early July, and then will be open only four days a week after that.

Prusa said about 95 percent of summer work will be done before the first week of the next school year. Frisch said the regular summer work involves equipment, supplies and labor, and he did not have an estimate of the total cost.
