1. The board meeting materials for the SSA Bond issue are approximately 150 pages. In the interest of saving paper, only the staff memo and draft ordinance are printed for you. 2. The DuPage Mayors and Managers Conference (DMMC) has announced a one-time 50% reduction in dues for the current year. This will result in a \$3,742.47 savings for the Village. DMMC announced they could make this move because of their strong financial reserve position while maintaining their financial policies intact.
3. As a reminder, the next Board Meeting is on TUESDAY September 8th, instead of Monday, because the 7th is the Labor Day holiday. Please plan accordingly.
4. Work on the website continued this week. As part of the design process, the Village will be soliciting photos of the Village from residents through social media and the newsletter. Hopefully we get some great entries.

Subject: Department Report

1. **Park Willow.** The Department continues to work with the Park Willow Association and its home owners association management consultant to assess the fire damage at 501 Carlysle Drive and prepare for the rehabilitation of the building in compliance with Village ordinance. Most recently the Village issued a demolition permit to begin removing the damaged structures from the building in preparation for the rehabilitation work.
2. **Blackhawk Heights.** The Department continues to work with the Public Works Department and the Village Engineer to assess and potentially make recommendations to address residence concerns with regard to stormwater management in the Blackhawk Heights neighborhood.
3. **Judson University Design Studio** - On Friday (8/28/2015) President Austin, Manager Barr and I attended the Judson University Advanced Architecture and Urbanism Studio inaugural site visit here at Village Hall. The students will be exploring the community of Clarendon Hills through architecture and urban design, then develop recommendations for how Clarendon Hills might evolve to meet its economic, social and environmental needs. While the Community Development Department will be the "acting client", Village Board, ZBA and DTDRC members will be invited to participate throughout the program.
4. **CMAQ Grant.** On Wednesday, I met key members of the Chicago Public Building Commission to discuss next steps in completing our grant application for pedestrian access improvements adjacent to the village commuter station, and the next steps in seeking alternative funding for elements of the improvement plan.
5. **Code Enforcement.** The Village had seven (7) code enforcement cases in court on Thursday; two (2) were for delinquent Places for Eating payments, one (1) for property maintenance violations, two (2) were for working without a permit on a multi-family property, one (1) for obstructing the public right of way, and one (1) for recreation vehicle storage violation. Compliance has been reached for six (6) cases and one (1) will be returning to court in October for confirmation of compliance. Thanks to the Village Code Enforcement Officer, David Godek, for his hard work and diligence in addressing these matters.
6. **Permit Report.** In August the Village has issued twenty-six (26) permits, including one (1) new home, having a total reported value of \$1,328,662. The Monthly Permit Report for August will be posted by early next week at www.clarendonhills.us/cdforms.cfm.

Recent events and training:

- September 1, Officers assisted Prospect School's PTO with the bike rodeo. 30 to 40 bikes were registered with the Police Department.
- Congratulations to Officer Chad Johnson! He has successfully completed the 12 week field training program, and is now certified for solo patrol.
- This week, three officers participated in an 8 hour pistol, rifle, and rapid deployment tactics course. This was a live fire training exercise held by FIAT, which included members from area departments.

Significant traffic and criminal activity during the period August 29, 2015 through September 4, 2015.

1. August 29, officers responded to the 200 block of Eastern Ave. for a residential burglary. The homeowner found the back door forced open and called police. Officers cleared the home and processed the scene. The next day the homeowner called and reported jewelry missing valued at \$5,000.00.
2. August 31, an officer responded to the 500 block of Chase Dr. for a burglary to motor vehicle. The unlocked vehicle was entered by someone unknown, who took a telephone headset.
3. August 31, an officer responded to the 500 block of Carlyle Dr. for a burglary to motor vehicle. The unlocked vehicle was entered by someone unknown, who took a wallet containing credit cards.
4. August 31, a vehicle in the 5700 block of Concord Ln., which was unlocked, was entered, but nothing taken.
5. September 2, 7:35pm, an officer attempted to stop a motorcycle traveling east bound Ogden Ave near Oxford for speeding and lane change violations. The motorcycle driver refused to stop, and accelerated away at a very high rate of speed, eluding the officer. Pending investigation.

6. September 1, a resident of the apartment building at 501 Carlyle Dr. came into the station to report someone had entered her apartment and taken items. (The 501 building was the location of a fire and is not occupied). The victim related she had left some items in her apartment, after the building was condemned. She reported a 47" TV and jewelry taken.


8. Mutual Aid Calls:


