1. This morning our fire department held a small event in remembrance of the September 11th attacks. As always, it is a reminder of those events and the sacrifices made by first responders and our military and a chance to thank them for their service.
2. Assistant to the Village Manager Zach Creer and I met with Historical Society on Wednesday morning to discuss the fire damage. We expect to have another discussion at the next board meeting to further address the Village's involvement with the cleanup.
3. President Austin, PW Director Mike Millette and I met with Park District (PD) officials Friday morning to discuss drainage issues around Hosek Park. Based on this meeting, it looks like there may be potential improvements to store more water at the site as part of PD project. We appreciate the efforts of the PD to complete this project and will continue to work with them to move it forward.
4. That same morning, I met with Mike Millette, Village Engineer Bill Sprague and a representative for Chicagoland Paving to address resident's complaints relating to the road program and get a status update. As everyone knows, this is a very complicated project incorporating street reconstruction, new curbs, storm drainage and water main reconstruction.

Early next week, we will have information out to all residents on the overall status along with more specific information for affected areas. We will continue to work with the contractor to reduce the impact on residents. As always, people in affected areas should directly contact our Village Engineer Bill Sprague to work through any problems.

5. Executive Assistant Vicki Pries, Community Development Director Dan Ungerleider and Zach Creer met with CivicPlus's design team this week to finalize the front page design for the new web site. We should have a draft of the page by November with launch expected in December.

SUBJECT: Department Report

- \$1,300,000 in General Obligation Bonds (Alternate Revenue Source) were issued on Monday for the Village's 2015 SSA road program. The results were favorable to the Village and SSA residents as Hinsdale Bank and Trust Co. purchased the bonds at a true interest rate of 2.68%. This compares to a true interest rate of 3.31% on last year's bond issuance. On Monday, October 5, the Board will be presented with ordinances for adoption to levy annual taxes on the properties within SSAs 27 and 28 for repayment of this debt. The annual tax rate is anticipated to be \$0.13-\$0.14 per \$100 of the equalized assessed valuation of the property, payable for fifteen years. This translates into approximately \$225 annually for a \$500,000 home value.

- Downtown Design Review Commission.** On Wednesday evening the proposed developer for 9-23 Walker Avenue (the vacant parcel at Park and Walker Avenues), presented architectural, site and landscape plans for a four (4) story apartment building to the Downtown Design Review Commission. During the meeting the Commissioner provided the developer extensive direction of how the proposed development design should be modified to better fit contextually with the downtown. The DTDRC will be meeting again with the developer before the end of September. A public hearing for the developer's request is tentatively scheduled for October 15 before the Zoning Board of Appeals/Plan Commission.
- Blackhawk Heights.** The Department continues to work with the Public Works Department and the Village Engineer to assess and potentially make recommendations to address residence concerns with regard to stormwater management in the Blackhawk Heights neighborhood.
- Permit Report.** The Village has issued seventeen (17) permits so far in September, having a total reported value of \$353,889. The Monthly Permit Report for August is posted at www.clarendonhills.us/cdforms.cfm.

Recent events and training:


- September 8, I attended the Du-Comm Chief's Committee meeting, where they approved our request to join. Our request will now move to Du-Comm's Board of Directors meeting Sept. 23, 7:30 am, for approval.
- September 7, Officer Helms represented the Village of Clarendon Hills at the funeral of Fox Lake Police Officer Glinewicz.
- September 7, 8, & 9, The Board of Police Commissioners have been conducting group interviews with candidates who passed the written test. The Department is looking to fill one police officer vacancy.
- The Department received notification from the Illinois Department of Transportation that we have been awarded a \$14,922.64 grant for seatbelt and DUI enforcement. The grant begins Halloween 2015 and runs through Labor Day 2016.

Significant traffic and criminal activity during the period September 5, 2015 through September 11, 2015.

September 6, 1:30 am, while on patrol, an officer came across a subject laying down behind a bench in Hosek Park. The subject ran when approached by the officer and left behind a bottle containing alcohol, an empty black and yellow Adidas back pack, and a purple Diamondback Zoom 381 women's bicycle. The 17 to 19 year old male was not located. The property was collected and brought to the Police Department.

September 8, a resident of the 10 block of Woodstock called and requested to see an officer to report harassment by telephone. The officer assisted the resident by contacting the caller and instructing him not to call again.

September 9, 9:27 am, officers responded to S/B Ill. Rt. 83 just passed the Burlington bridge for a vehicle crash. A 41 year old driver from Schaumburg lost control of his GMC dump truck and crashed into the wooden sound barrier wall. He received a severe injury to his left arm and was transported by CHFD to the hospital. IDOT was notified to make repairs to the sound barrier.


