1. Following up on the paperless agenda issue, we have purchased one iPad as a test to see how it works with our agenda. We believe it works well. Zach Creer plans to bring it up during the Reports of Officers portion of the meeting on Monday. Since one or two of you have already indicated you may want to purchase your own, please confirm with us on Monday night if you want one purchased for your use. In either case, we hope to have these up and running sometime in October.
2. At the last meeting we reviewed a possible ordinance regarding commercial filming regulation. As part of the Village Attorney review we identified a few concerns regarding the Village's ability to regulate as presented because of our non-home-rule status. As a result, we have pulled this item from the agenda and are reviewing it further. Please advise if you have questions.
3. AIS ordered the equipment for the podcast, it will hopefully be ready for the first meeting in October.
4. If you recall, a few meetings ago the Board authorized us to go ahead with the remaining cost (\$13,200) for the METRA area improvement planning efforts even though the State had suspended grant payments. Dan Ungerleider advised me that Jon McCabe, the Village appointed member of West Suburban Mass Transit District (WSMTD), let him know the WSMTD Board had approved our request and will be granting the Village \$13,200. Thanks to Dan for his work on this and Jon McCabe for his advocacy.
5. On Monday, Assistant to the Manager Creer and I met with Republic Services (our garbage contractor) to discuss issues regarding garbage removal in the downtown area. Republic has been providing the required services, but we were seeking input on ways to address overflow and cleanliness concerns. Republic agreed to provide and begin the use of plastic liners to help keep the cans clean and sanitary. The liners were already in as of Thursday. We also hope this method will make it easier to keep the cans from overflowing in front of Starbucks. We also discussed ways to use the newer double cans for recycling. We appreciate Republic's efforts in helping us keep the downtown area attractive.
6. On Tuesday, Public Works Director Millette and I met with Burke Engineering to plan out the process for the 2016 road and water main replacement program. Amongst other things, we discussed contractual and other means to improve the process so we can avoid some of the delay

and dust related nuisances that have occurred as part of the 2015 program. We also discussed better traffic control for the remainder of the 2015 program to help alleviate those concerns.

7. On Wednesday evening I attended the DuPage Mayors and Managers Conference meeting in Lisle. The primary topic of conversation was reviewing innovative programs and projects developed by municipalities in our region. I am sharing the ideas presented with Village staff to determine if any of the ideas can be of help in Clarendon Hills.
8. Executive Assistant Vicki Pries, Community Development Director Dan Ungerleider and Assistant to the Manager Zach Creer met with CivicPlus's design team last week to finalize the front page design for the new web site. We should have a draft of the page by November with launch expected in December.
9. Interviews for a new part-time police assistant were conducted Thursday and Friday. Hopefully, we will have a final candidate chosen by early next week.

SUBJECT: Department Notes

1. 2015 Road Program: Paving of the binder (intermediate) course of asphalt on Norfolk, McIntosh, Blodgett and Gilbert scheduled to begin next Monday. Storm sewer work is underway along Rose. Grinding for the concrete shoulder along Golf and Norfolk, east of Prospect began today. The concrete placement is scheduled for Wednesday and Thursday. We have put the contractor on notice that their progress over the past two weeks does not seem sufficient to ensure completion of the project by October 31st and asked for a revised schedule that will allow them to make their deadline. When submitted, CBBEL will advise as to its practicality.
2. CBBEL is performing a survey of the culvert and storm sewer system on Hiawatha and Iroquois. They will have suggestions for us in two weeks.
3. Homer Tree Service has nearly completed all tree removals. Our crew is following close behind and filling the stumpholes.
4. Street sign replacement work is in progress, primarily north of Chicago.
5. New unit 2 is ready for service. I will bring a disposal request for old unit 2 to the Board in October.

Recent events and training:

- September 14, Sgt. Leinweber attended an advanced homicide investigations class hosted by NEMERT. This completes the Department's certification requirement mandated by Illinois Law.
- September 17, the Clarendon Hills Board of Fire and Police Commissioners completed the last phase of candidate selection to fill the Department's police officer vacancy. The Department investigators will conduct background investigations on selected prospects after a conditional offer will be made to one candidate (pending the required psychological and medical exams).

Significant traffic and criminal activity during the period September 5, 2015 through September 11, 2015.

September 17, an officer responded to Burlington and Prospect for a hit and run vehicle crash. The 23 year old women from Martinon Illinois reported to the officer that her vehicle was hit by a black SUV driven by a white male. The crash occurred as she turned west bound on to Burlington from Prospect in front of the bank. The SUV pulled out from his parking spot and hit the victim's vehicle, and then drove away east bound Burlington Ave.

This week, officers made 5 traffic arrests of individuals who had invalid driving privileges.

5. Emergency Management Report:

6. On Friday, September 11th all Self Contained Breathing Apparatus (SCBA) units were flow tested and calibrated according to Illinois Department of Labor regulations. This testing is performed annually by a third party vendor.




