1. Please note that the Police Department has established trick or treat hours this year -- from 2:00 p.m. to 7:30 p.m. on Saturday October 31. The 2:00 p.m. time is immediately following the Chamber event.
2. I attended, along with Fire Chief Leahy and Police Chief Farmer, the Du-Comm meeting on Wednesday morning in Carol Stream. Entry of Clarendon Hills into Du-Comm, along with Willowbrook and Burr Ridge, was approved. We are pleased with this process so far and anticipate a smooth transfer that will be effective May 1, 2016.
3. Village President Austin and I attended a District 181 Strategic Planning Focus Group on Wednesday. Most of those in attendance were parents from Clarendon Hills and Hinsdale. It was an interesting session where much feedback was provided in a relatively short session. District 181 is holding several of these sessions.
4. On Wednesday night I attended the "District 3" meeting in Burr Ridge which is an informal gathering of County and municipal officials intended to share relevant information. Many items were discussed, though much of the interest was in regards to the on-going State budget crisis (see more below). Clarendon Hills is slated to host the next meeting.
5. Dan Ungerleider and I met with Jonathan McCabe, the Village representative with the West Suburban Mass Transit District (WSMTD), on Thursday morning to discuss issues related to the railroad and transit facilities. As reported before, Jonathan was instrumental in procuring a grant to cover the portion of grant money for rail area street improvement planning that was not covered by the State. The meeting was productive and we feel we gained insight in how WSMTD can help us move forward in the future. Jonathan voiced interest in continuing to serve in the future and will likely come up for appointment in the near future.
6. As mentioned above, there has been more recent discussion regarding potential changes to State funding for municipalities. Many of the potential options discussed could cause significant financial damage to the Village and our residents. Reduction, or even limitation, of our share of the State Income Tax is still on the table. Discussion of property tax freezes and even forcing transfers from local funds to the State are being discussed. Enactment of any of these concepts would damage our finances and, in effect, force Clarendon Hills' residents to further subsidize

the State budget. We are better off as a community if we maintain local control. In any case, there is no obvious date where a decision will be reached. I will continue to keep you informed.

7. This Wednesday, Executive Assistant Vicki Pries, Community Development Director Dan Ungerleider and Assistant to the Manager Zach Creer did a final design approval with Civic Plus for the new website template. We should have a draft of the page by November with launch expected in December.
8. The Village is excited to announce two new employees this week. Luis Calderon will be our new part-time Police Assistant. Julia Katsaros was hired as a new police officer. Please give them a warm welcome when you see them in town.
9. The annual employee picnic is taking place this (Friday) afternoon. Village offices will be closed.
10. Carpet replacement will be taking place next week in the upstairs of Village Hall. The Village Hall will remain open during construction, but employees may be taken away from their desks and phones. We expect to be finished by Wednesday.



SUBJECT: Department Notes

1. 2015 Road Program: Paving of the binder (intermediate) course of asphalt on Norfolk, McIntosh, Blodgett and Gilbert has been completed. Storm sewer work is underway along Waverly and Chestnut. Placement of the concrete shoulder along Golf (west/north side) and Norfolk (south) will be completed today. Parkway restoration on Middaugh has begun. Weekly meetings will commence next Wednesday which will focus on making the contractor push their efforts to complete the surface asphalt throughout the project by October 30th.
2. Homer Tree Service has only a few tree removals remaining. They will be complete this month. Our crew is following close behind and filling the stumpholes.
3. The fall banners have been hung in the CBD.
4. Fire hydrant painting is underway and will last through to the end of the month.


