1. The FY 2015-16 budget is nearly ready for adoption. The second reading and approval is scheduled for the April 20 Board Meeting.
2. The DuPage Mayors and Managers Conference (DMMC) has been working on the issue of potential cuts to the LGDF (income tax distribution). The Village has posted on our web page a link to a video explaining the potential impact of these cuts and a link that allows concerned citizens to voice their opinion to the Governor and local legislators. I am also sending other materials prepared by the DMMC to the Board for further discussion and possible future action. These relate to the LGDF and other areas of municipal concern regarding the State.
3. On Tuesday, Zach Creer and Chris Boone attended training on contractual risk management. Based on this training the Village is updating its contractual insurance policy to the latest standards provided by IRMA.
4. On Thursday, Zach Creer and I attended the Metro Managers' luncheon. Topics included performance measures and a going away for NIU Professor Gabris. The Professor has been instrumental in training professional administrators in this region for more than 30 years.
5. On May 8th and May 9th, IRMA will be performing its IMAP certification for the Village. The last time the Village was audited onsite was 2009. Full compliance allows for lower rates and hopefully lower losses. The Safety Committee met this week to prepare for the audit.
6. On Friday, Zach Creer met with Republic to discuss their new online and mobile apps for residents. Clarendon Hills will be one of the first communities with access, and hopefully it will better improve customer service for refuse collection. Look for upcoming information through the village email list, Facebook page and Trustee Topics.

SUBJECT: Department Report

- A quarterly Police Pension Board meeting was held on Monday evening, April 13. The results of the election for one active trustee position were determined; Rick Talerico was re-elected for a two year term of May 1, 2015 through April 30, 2017. Great Lakes Advisors, the pension fund's new investment manager, provided an update on the transition of Police Pension assets.
- A quarterly Fire Pension Board meeting was held this morning as well. Sawyer Falduto Asset Management LLC provided the quarterly investment performance report as of March 31, 2015.
- Public Act 99-0002 (the state's FY 15 budget fix) included transfers, or "sweeps," from many special state funds into the General Revenue Fund. This included a \$50 million transfer from the Illinois Motor Fuel Tax (MFT) Account. While legislators and the Governor's staff indicated that municipalities would not be impacted by the sweeps, we learned this week that MFT payments for the month of March were affected.

The six month average of Village MFT revenues totals \$18,344.31, while the amount received in March was \$7,766.46, a difference of \$10,577.85. MFT revenues are a significant source of funding for road salt and maintenance, tree trimming and removal, sidewalk replacements, and traffic signal maintenance. While these transfers are a one-time deduction and normal monthly distribution is expected to resume for April, this transfer certainly affects the funds available for these projects.

Subject: Weekly Activity Report

1. Recent training:

- Officer Shaw completed a 40 hour Field Training Officer course. CHPD hosted the five day class for 30 police officers from area PDs. Northeast Multi-Regional Training presents several classes a year in our training room. CHPD officers get free training slots in the classes we host.
 - One officer attended one day of FIAT SWAT training.
 - Police Assistant Kelly Green attended a Law Enforcement Records Managers of Illinois (LERMI) meeting and a DuPage Records Management meeting this week. DuPage County has gone out to bid for a new county wide records management system. Kelly has done a great job of tracking their progress and evaluating how it will effect CHPD. Records management and CAD systems track a 911 call from the time an emergency call is received by the dispatcher. Because we are dispatched from a non-DuPage County center our involvement is different than most DuPage police agencies.
2. The severe weather last week damaged the downtown camera system and the water tower microwave link to our dispatch center. A copper to fiber translator was ordered and installed Tuesday to repair the communication link. Parts are on order to repair the camera system and the repairs should be completed next week.
 3. Village Manager Kevin Barr attended our afternoon roll call on Monday. Kevin had a nice discussion with the day and afternoon shifts and met our two new officers, Jordan Smith and Chad Johnson.
 4. DC Farmer and I attended the Chamber of Commerce meeting on Wednesday. Plans for our bike auction to be held on June 13th on the Daisy Days stage were discussed and finalized.

5. DC Farmer attended the CH Safety Committee meeting on Wednesday. Preparations for the upcoming IMAP inspection were discussed.
6. DC Farmer and I attended a Police Alternative Fuel Summit in Buffalo Grove on Thursday. Presenters from environmental groups, alternative fuel suppliers, vehicle technology companies and fleet managers from several large companies discussed the advantages of using natural gas and propane in police fleet vehicles.
7. Supervisors are finalizing employee annual reviews this week. Following legislation that was passed last year preventing the use of ticket totals and other activity from being used in police officer evaluations we have had to adjust our officer evaluation criterion. Police supervisors met earlier this month and came up with a plan to benchmark officer standards and goals without the use of ticket counts.
8. Sergeant Dalen and Officers Zack Finfrock, James Shaw and Jeff Pasteris completed and turned in our 2014 Chief's Challenge project. The project is a yearlong effort culminating in a report to document those efforts and the resulting effect on traffic safety in our jurisdiction. The project report is submitted to the Illinois Police Chiefs Association for review and compared to other projects from similar sized police departments in the state. CHPD competes in the 10 to 25 officer category. Participation has become mandatory if a department wants to be eligible for most traffic enforcement grants. I am very proud of what Sergeant Dalen and his team have done this year, CH roadways are safer because of their efforts.
9. Administrative tow hearings were held Wednesday at the PD. Clarendon Hills had eight cases, Hinsdale had six. The Hinsdale and Clarendon Hills agreement to conduct the hearings at the same time, with the same hearing officer, continues to save time and money for both Villages.
10. Save the Date: CHPD has scheduled a blood drive for Saturday, April 25 from 9 am to 3pm. The event will be held at the Clarendon Hills Police Station.
