3. On Thursday, Interim Village Manager Bourke signed a three month extension with Constellation for electric supply at 6.8 cents per kilowatt hour. This represents a significant savings over the ComEd rate of 7.572 cents per kilowatt hours. Residents can expect no change in service or billing as both of those items will still be handled by ComEd.

1. Homer Tree Care began our annual tree pruning and removal project this week. The project covers the entire Village and should be completed by the end of the month. As with all construction-related activities residents are asked to heed warning signs and obey flaggers' instructions.
2. This phase of work at the Village Hall is wrapping-up as we began the installation of new lights in the lobby yesterday. The final phase will consist of stripping wallpaper and painting the back stairwell and some amount of carpet replacement which is currently under review. We expect this work to be completed in February.
3. We will remove the holiday decorations from the CBD and hang the winter banners starting tomorrow.
4. Snow removal efforts have ceased as the January thaw approaches. In the same manner that 'April showers bring May flowers' the January thaw brings...potholes! That may not rhyme, but our road patching activities next week will be 'on time'.

1. **227-231 Burlington** - The DTDRC held a meeting on January 6, 2015 to conduct a level 3 downtown design review hearing for a proposed self-warehouse facility. The development is being designed to comply with the current I-Industrial District standards and the Downtown Design Review Guidelines. A second meeting to discuss the Commission's requested revisions to the plan will be held on February 3, 2015 at 7pm in the Village Hall board room.

The village-initiated map amendment effecting this property will be presented to the Village Board on January 20, 2015. The requested map amendment will rezone the subject Burlington Avenue properties from I-Industrial to B-2 General Business district as recommended by the Downtown Master Plan and in keeping with the character of the downtown business district.

2. **Business/Contractor License Online Applications** - Application for 2015 Business, Contractor, Home Occupation or Scavenger licenses are available online at <http://www.clarendonhills.us/businesslist.cfm>. Once completed and approved, business owners will be emailed a copy of their license and will be given access to their online GoLocal directory listing and access to their online building permit files. Please call the Community Development Department at 630-286-5410 if you have any questions or need assistance completing an online license form.
3. **Stormwater Detention Program** - Late 2014 the Village Board adopted an ordinance amending the Village stormwater management standards that, come May 2015, will require projects greater than 300 square feet to include stormwater storage. This week staff began working with our consulting Village Engineer to develop a program to assist the development community with this provision. The program will ultimately include a set permit review, installation inspection and maintenance inspection process. For smaller projects between 300 square feet to 800 square feet, the program will also include "toolkits" that will provide established stormwater management systems that could be considered without having to hire a design engineer. More information about this program will be posted on the Community Development Department webpage as it is developed.
4. **GIS Mapping** - In addition to creating a new zoning map, which can be viewed on the Community Development Department webpage, the Department is creating maps illustrating the Village's ongoing street program, existing land use patterns. As they are generated, these map will be posted on the Department's webpage.
5. **Coldwell Banker Expansion** - Over the past 6-8 months, the Department has been having preliminary discussions with the owner of the building at Eastern and Prospect Avenue regarding the renovation of the his building to accommodate the expansion of the Coldwell Banker offices. As recommended by the Downtown Design Review Guidelines, the property owner is considering to renovate the façade and increasing the size of the plaza at the corner of his building. This development will require Village Board, ZBA and DTDRC commission review and approval before a building permit can be issued.
6. **Building Permit Report** - Permit requests remains slow. So far in January the Village issued 5 permits having a reported total construction value of \$ \$17,550.



1. Last Friday DC Farmer and I were invited to tour US Customs and Border Patrol operations at O'Hare Airport. CBP stations over 300 personnel at O'Hare and is responsible for screening an average of 15,000 international passengers and their luggage daily. Agents also screen all incoming and outgoing international mail at the O'Hare postal facility. The competent staff and state of the art equipment was very impressive.
2. The Police Department was treated to lunch by representatives of the "Mom's List" on Monday. The "Mom's List" is an email list compiled through several sources and has been a valuable communication resource to the Village on multiple occasions. The "Ladies of the List" provided lunch for the PD as a thank you and welcome back to Sergeant Paul Dalen. We are all thankful for their support and kind gesture.
3. Sergeant Dalen also received a thank you from 5 year old Lucas. Lucas and his Mom brought in chocolate chip cookies for Paul and a kind note. 4. Recent training:

Significant traffic and criminal activity during the period January 9, 2015 through January 15, 2014

1. On 1/11, a resident on the 300 block of Reserve Circle reported that her front door was forced open by a male at 1:18pm. She related that approximately 10 minutes after her husband left the house she heard a loud noise. She called "Hello" downstairs and a male voice responded "Hello". She went to the top of the stairs and saw a male subject flee from the entryway. Nothing was taken from the home but the front door and frame were damaged. Pending.

1. Fire Prevention Bureau Activity during the past week.
 - Work continues on the computerized pre plan project.
 - 2015 Fire Prevention/Life Safety inspections have begun.

3. Emergency Medical Services Report:
 - Wednesday evening, twenty one (21) Firefighter EMT-B's and Paramedics attended monthly continuing education conducted by a Loyola representative at the fire station.
 - Finance Director Peg Hartnett and I will be working with the Hinsdale Fire Chief and Hinsdale Finance Director to propose adjustments to our ambulance service fees for both villages. More to report on this in the next few weeks.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - Hinsdale Chief Ronovsky and I will be meeting with DuComm representatives today to discuss dispatching operational issues for when Hinsdale moves to DuComm in May.
5. Emergency Management Report:
 - No report.
6. Attached is a letter from D181 Superintendant Don White thanking us for the help we provided when a pipe broke at the Hinsdale Middle School last week.
7. On Thursday I attended the monthly meeting of the SWCD Executive Committee.
8. As reported last week about the bathroom sewer problems, this work started on Wednesday and the plumbing portion of the project should be completed today. Finish floor tile work should be done in 1-2 weeks.

9. This week we received the \$18,000 from the State Fire Marshal small equipment grant program for the purchase of firefighter protective clothing. We hope to have this equipment ordered next week.
10. Yesterday, I filed the paper work for grant funding from our insurance cooperative (IRMA) for our power cot and power loading system that was a part of the new ambulance. I received an email from IRMA that they will be including about \$11,500 in their 2016 budget for payment to us for this equipment. IRMA is doing this as an incentive for fire departments to purchase this type of equipment which can reduce back injuries of EMS personnel.
11. On Wednesday, I attended the monthly meeting of the MABAS Division 10 Fire Chiefs.
12. Incidents of interest:
 - During the past week Hinsdale FD responded to two (2) automatic response calls in Clarendon Hills.
 - During the past week Clarendon Hills FD responded to four (4) automatic response calls in Hinsdale.
13. Mutual Aid Calls:
 - None
14. Fire/Rescue/EMS calls:
 - No significant calls of interest.
 - During the past week the fire department responded to twenty six (26) emergency calls.
