1. First draft of the website was revealed on Tuesday. Staff will spend two days next week reviewing content on the site with CivicPlus, and learning all the new modules and features. Hopefully, the big reveal to the Board will be in December.
2. The Village and the Historical Society have agreed to terms on a lease amendment and cost sharing for the repairs. The agreement includes a 50-50 cost split on any repairs and the lease was amended to clarify which party pays in the event of another major insurance claim. The amendment will be up for approval at the Board meeting on Monday.
3. On Thursday, I attended a "District Two" meeting, which gathers local government and County officials from the area to discuss issues of mutual interest. Amongst other things, discussion included joint cost sharing efforts in areas such as public works purchases and GIS services.
4. As you may have noticed, the 2015 road program is nearly complete. All primary paving work has been completed. The contractors are working diligently on landscaping (sod) work and should be done early next week. There may be clean-up work to do after that. Please let us know if you have any questions regarding this matter.

1. **9-23 Walker Avenue.** The Public Hearing for the proposed development at 9-23 Walker Avenue, originally continued to November 19, 2015, has been postponed to the ZBAPC's next regularly scheduled meeting on December 17, 2015 at the petitioner's request. As a result, the ZBAPC meeting for November has been canceled. A copy of the cancelation notice will be published on the village website at www.clarendonhills.us/zbapcagendas.cfm.
2. **201-211 Burlington Avenue.** This upcoming Tuesday on November 17 at 7pm, the Downtown Design Review Commission will be reviewing plans for the proposed renovation of the 211 Burlington Avenue building, the relocation of the public alley forty (40) feet to the east, the construction of an outdoor dining area, a kiosk, and a public/private plaza. The Commission's recommendations and finding will be forwarded to the Village Board for consideration and approval.
3. **Permit Report.** So far in November the Village has issued fourteen (14) permits, including one (1) new home, having a total reported construction value of \$461.135. As previously reported, the Monthly Permit Report for October is posted at www.clarendonhills.us/cdforms.cfm.

1. Fire Prevention Bureau Activity during the past week.
 - No inspections were conducted during the past week because Lt. Godek was in a week long Fire Officer Level 2 training class.
2. Training Report:
 - Captain Mark Rediehs is updating NIMS compliance for the village.
3. Emergency Medical Services Report:
 - Wednesday evening, twenty one (21) firefighters attended monthly EMS continuing education.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - Ambulance fee updates are now in the hands of the village boards in Clarendon Hills and Hinsdale and should be approved next week.
5. Emergency Management Report:
 - Next week we will be working on the After Action Report (AAR) for the Table Top EOC exercise that was conducted. When this is completed all of the documentation will be sent in to the DuPage County Office of Homeland Security and Emergency Management for approval a credit for this exercise.
6. On Tuesday I attended the monthly meeting of the DuPage County Fire Chiefs in Glendale Heights. Updates and discussion centered around the new DuPage County Wide Computer Aided Dispatch (CAD) project and also Public Safety Answering Point (PASP) Consolidation.
7. On Tuesday afternoon I attended the DuComm Chiefs Operations Committee meeting in Glendale Heights.
8. On Thursday, Lt. Jim Weil and I participated in the DuComm SE Consolidation meeting conference call at which time we discussed things to be completed for the transition from SWCD to DuComm. These meetings and conference calls include representatives of the Clarendon Hills Fire and Police Departments, Burr Ridge Police Department, Willowbrook Police Department and DuComm.

9. Incidents of Interest:

- Monday, November 9th at 1:12 PM. The fire department responded for a natural gas line severed by a contractor. Firefighters slowed the leak until the arrival of Nicor.


10. Mutual Aid Calls:


