Dear City Mayor or Village President:

Last month, I proposed two paths for dealing with the fiscal crisis facing our state: working together or executive management. The first is my preferred path: a bipartisan balanced budget alongside structural reforms that make our state more competitive, drive down costs for local governments and lower the total tax burden on all Illinois families.

Under that scenario, we would fully fund the Local Government Distributive Fund, lower workers' compensation costs, provide relief from unfunded mandates, enact pension reform, provide local control of collective bargaining and prevailing wage and invest in our infrastructure. Mayors across the state have advocated for all of these reforms for years.

But this future cannot be achieved if the leaders of the General Assembly refuse to compromise and reject this preferred budget path. If Speaker Madigan, President Cullerton and the members of their caucuses refuse to work together, we must still take action to balance the state budget. That would mean deep cuts. It's not my preferred path, but we cannot keep digging ourselves into a financial hole.

I encourage you to contact your elected officials and urge them to choose the preferred budget path of working together so that we strongly support local governments with reforms and revenue.

- March 3, Assistant to the Chief Green attended a one day FOIA and Records Management class sponsored by PRI Management Group.
- March 4, Sergeant Porter and Officer Finrock attended a training seminar sponsored by The DuPage County State's Attorney's Office: "Effective School Staff Interactions with Staff and Police" it addressed improving school climate through collaboration with police.

Significant traffic and criminal activity during the period February 27, 2016 through March 4, 2016.

1. March 1, Officers were dispatched to a home in the 100 block of Ogden Ave. for a report of a battery. The case is under investigation.
2. March 3, Officers were called to the area of the drive-up window at PMC Bank, 300 Holmes Ave., where a man refused to pull away from the drive-up window. Officers approached the vehicle and talked with the driver. The 61 year old Darien man was found to be intoxicated. He was arrested for DUI.
3. March 4, Officers were called to the Birches Assisted Living facility at 215 55th Street for an ambulance assist for an unresponsive subject. Paramedics found the 84 year old women had passed away. The Police Department investigated the case. The DuPage Coroner's office reviewed the findings and determined natural cause of death.
4. March 4, 8:49am, the Police and Fire Departments were notified ComEd wires were down in the Walker Ave. alley and on Prospect Ave by the R.R. crossing. The scene was secured and ComEd notified. A large semi-truck had made a delivery in the area and was turning around in the gravel lot at 9-23 Walker Ave, when the truck snagged the ComEd lines and this caused a ComEd pole to break and fall on an unoccupied vehicle parked in the area. The power was out in the area for 2 hours. This incident did cause the BNSF R.R. crossing gates at Prospect Ave. to malfunction and remain down for an extended period of time.
