3. Communication re: Subsidized Housing. Again following up on the 9-23 Walker discussion, the following is a note from the Executive Director of the local Housing Authority. It helps to explain the current state of subsidized housing in DuPage County.

President Austin and Village of Clarendon Hills Board of Trustees,

I want to make myself available to you to answer any questions you as a Board or the residents of Clarendon Hills may have regarding the Housing Choice Voucher (HCV) program. I will gladly attend any meeting of the Board, any committee or called meeting in Clarendon Hills to try to clear up the published comments of mis-information and quite frankly fabrications assigned to the "Section 8" program and its participants, that I read in today's **Clarendon Hills Doings** about last night's meeting.

In speaking to groups I never try to change anyone's opinion of the program or its participants. My goal is to educate and to present the facts. I don't live in Clarendon Hills and I also cannot deny or dismiss anyone's experience, but I can provide the facts about the program itself, the program in DuPage County in general and Clarendon Hills in particular.

A few facts: There are only 2,907 HCV subsidies assigned by HUD in DuPage County. Of that total about 2,560 are in use and about 400 of those are assigned for seniors living in senior buildings with 300 currently in use. There are another 650 HCV subsidies in DuPage County of program participants who chose to move here with their voucher from other jurisdictions in the U.S. Overall, that total of 3,300 voucher holders in DuPage County pales in comparison to the hundreds of thousands of market renters... and to have it otherwise insinuated they principally be blamed for crime and increases in crime is wholly unfair. The largest number of voucher holders live in Naperville and number about 500. The smallest number of voucher holders live in Burr Ridge with only 1. Clarendon Hills has 12.
