PRESS RELEASE

On August 5th 2016 at 11:59 a.m. the Clarendon Hills Police Department responded to a reported armed robbery at 300 Holmes Ave (PNC Bank). The offender is described by witnesses as a male, black, 30-40 years of age, 5'6" to 5'08", with a medium build, brown eyes and a graying beard. He was described as wearing a grey/blue/black plaid collar button up shirt, dark jeans, and a black Chicago Cubs baseball hat. The offender displayed a silver/black handgun in his waistband during the robbery and is considered armed and dangerous.



The Clarendon Hills Police Department is conducting an investigation to locate the offender in conjunction with the FBI. Anyone recognizing this individual or having information about his whereabouts is asked to contact the Chicago Field Office of the Federal Bureau of Investigation at 312-421-6700 or the Clarendon Hills Police Department at 630-286-5460. Subject: Department Report

1. Work on the 2016 Road Improvement Program is ready to shift into its final stages. Asphalt grinding and binder asphalt placement is tentatively scheduled to begin next week on 56th, Hudson, Ruby, Harris (east of Western) and Western (south of Ridge.) Black dirt has been placed in this area as well. Nicor's contractor will begin gas service transfers in the remaining project are next Monday and inform us that they will be completed by September 16th. Westmont's contractor will begin transferring water services on Richmond next week and anticipates moving out of our work zone within two weeks which will allow our contractor to begin restoration work. Overall, the project will be close to completion by September 30th.
2. The bids for resurfacing Terrace Court and the 55th Street Frontage Road will be opened next Thursday. An award of contract will be prepared for the September 6th Board agenda.
3. We have, finally, found a water main leak on North Prospect that we have been chasing for over a year. This completes our current list of known and suspected leaks. Kudos to Water Operator Joe Ferrel and his team for their diligence in completing this task.
4. Kudos as well to Lead Maintenance Worker Dave Pendill and his crew for completing the Richmond Garden Apiary base work in conjunction with the Eagle Scout candidate's project and for following right behind Homer Tree Service to repair the stump holes left after tree removals.
