Subject: Weekly Report

1. **ComEd Smart Meter Installation:** I have been advised that the smart meters are now scheduled for installation starting the week of October 31. I do not have information on how long this will take. Further notification from ComEd via automatic calls and letters are expected during this period. Please advise if any issues come up.
2. **Du-Comm Board of Directors Meeting:** I attended this meeting on Tuesday morning. We primarily discussed continued efforts to plan for a new facility at the DuPage County government site. There is much planning work that needs to be completed, but it looks promising for this to occur.
3. **Chamber Meeting:** I attended the Chamber meeting on Wednesday morning along with other members of the Village staff. The Chamber is working diligently on upcoming events including Halloween Windows on October 24th and the downtown trick-or-treat event on October 29th (11 a.m. to 2 p.m.). They are also working on the annual Christmas Walk event on December 2nd. The Village is working with the Chamber to support these events.
4. **Metro Managers Meeting:** I attended the Metro Managers meeting on Thursday. The Illinois State Comptroller, Leslie Munger, was the speaker. She provided information regarding the State's financial condition (not good) and the procedure they follow for paying bills. Bottom line, there is a long back log on paying bills, which are processed as the revenue comes in. This situation is getting worse even though the overall economic picture is improving. Still no sign as to how this will, or will not, impact the Village in the future.
5. **Phone System Update:** Staff is continuing to work on the new phone system. We still expect the new system will be installed by Halloween.

1. On Wednesday, October 19, 2016, Derick Cheek from the Department of Commerce and Economic Opportunity contacted the Finance Department to notify the Village that we were being sent a payment of \$174,003.09. This is the final payment for the Metra Engineering Grant. This grant was awarded to support the initial design and engineering work needed in support of the Village of Clarendon Hill commuter station property redevelopment.
2. On Friday, October 21, 2016, the Finance Department processed its first payroll using the new third party provider Paylocity. As with most new implementations there are usually a few glitches. The Village experienced a few errors which are being rectified, however this did not have an impact on a timely issuance of payment and all employees were paid on time.

Subject: Department Report ★

1. Surface placement for the remaining streets of the 2016 Road Improvement Program is underway and should be completed this afternoon. Limited work remains for the Park District at Hosek Park which will continue through the end of the month. Nicor has still not given us a firm schedule for the completion of their restoration work.
2. Terrace Court and the 55th Street Frontage Road have had curb replacement and underground structure adjustments completed. They will be grinding the existing pavement today and begin patching operations. Next Monday (and Tuesday, if necessary) they will be placing the binder course of asphalt. No work will occur on Wednesday to accommodate a large event occurring at Christ Lutheran Church. The surface asphalt is scheduled for Thursday or Friday.
3. The pre-construction conference for the annual sidewalk removal and replacement contract was held Thursday morning. They did not yet provide us with a firm start date. When they do, it will be posted on our website.
4. Fall tree planting is underway. We are planting 14 trees this week utilizing in-house resources.
5. Our contractor, M.E. Simpson is in town exercising water valves on the south side of the BNSF tracks.

Recent events and training:

Monday, October 17, the Police Department reports an arrest was made regarding the burglary and theft of a handgun from a business office located in the 115 Holmes Ave. office building. A 29 year old male from Chicago, who recently lived in Clarendon Hills, was charged with burglary and possession of a stolen firearm. He was transported to DuPage County Jail.

The Department's Investigations Team worked this case with urgency and determination to solve it quickly. Detective Shirley, Detective Shaw, Detective Sergeant Leinweber and Administrative Sergeant Dalen worked long hours searching for and locating the offender. Detective Shirley and Detective Shaw interviewed the offender resulting in the charges.

October 14, 3:00 pm, a resident of the 10 block of Tuttle Ave. came into the station to make a fraud report. The elderly victim reported he received a phone call from who he thought was from his grandson, but in fact was a scam artist. The scammer told the victim he was in jail in Wisconsin and needed \$1955.00 to bond out. The victim paid the money via a Walmart store money transfer. The offender called back to get more money for "court costs" totaling \$1785.00, but the victim came to the Clarendon Hills Police Department instead. The officer assisted the victim. Pending investigation.

October 15, 2:06 am, officers were called to a home in the 300 block of Ridge Ave. for a report of domestic trouble. Officers resolved the situation, both parties separated for the night.

October 16, an officer responded to the parking area of 550 Chase Dr. for a report of criminal damage to a parked truck. The victim found his truck scratched along the driver's side.

October 17, 4:40 pm, officers and CHFD was called a home in the 100 block of south Prospect for a death investigation. The DuPage County Coroner and the Police Department conducted an investigation and determined the death was not suspicious in nature.

October 19, 3:53 pm, an officer was called to a home in the 100 block of Byrd Ct. for a burglary to motor vehicle. The victim related it occurred a day earlier on Oct. 18 at approximately 1:00 am. She said she was not going to report it, but changed her mind when she saw the Department's crime prevention sign flashing the message downtown. The victim related someone unknown had entered her unlocked side garage door and then went into her unlocked car. The victim found the interior and trunk had been rummaged through, but nothing was taken.

October 20, sometime between 7:10 am and 8:10 am, someone unknown entered an unlocked vehicle parked in the alley behind 155 Ann Street. The victim left her vehicle unlocked with her I-Phone on the front seat. She returned to her vehicle to find it missing.
