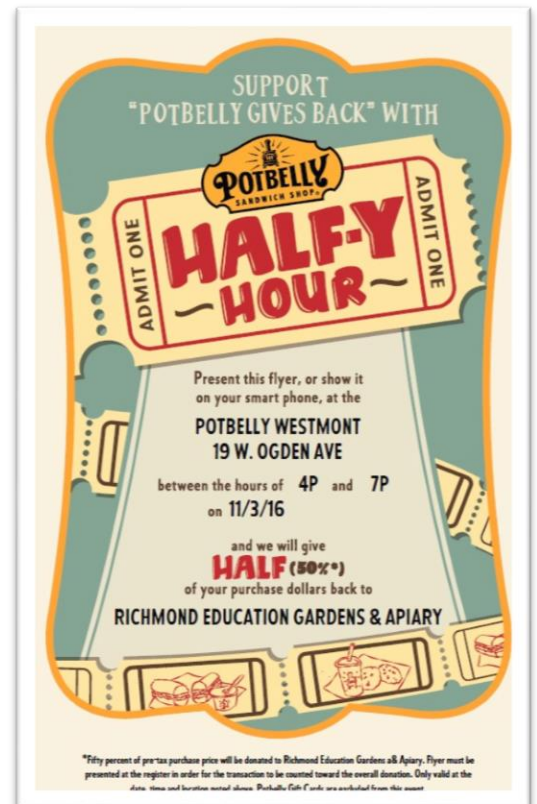
1. Surface placement for the remaining streets of the 2016 Road Improvement Program has been completed. Limited work remains for the Park District at Hosek Park which will continue into next week. Nicor has still not given us a firm schedule for the completion of their restoration work.
2. Terrace Court and 55th Street Frontage Road were completed this morning. A minor amount of clean-up will linger into next week.
3. The annual sidewalk removal and replacement program is currently underway. Most of the replacement work will be complete this afternoon with a few areas waiting until next Tuesday.
4. Fall tree planting is complete.
5. We have begun the process of plow maintenance which consists of replacing blades and curb shoes. All will be ready by mid-November.
6. Our new 3-ton plow truck is at the up-fitter and will be here before Thanksgiving. The 1-1/2-ton is also in queue to be up-fitted and is expected before the end of the year. As a precaution against any delay or break-in issues, we will maintain possession of the existing 3-ton throughout the winter.

1. **229 Park Avenue (fka 9-23 Walker).** The construction fencing around the property was installed last Friday. Parking along the east side of Walker Avenue, adjacent to the development site, will be unavailable during the duration of the project. A temporary sidewalk along Park Avenue has been created. Pedestrians and vehicles passing by the construction area should do so with caution. We anticipate issuing the permit for this project in early November.
2. **Richmond Education Gardens Update.** Thank again to all who participated in the October 10th fundraiser. Our next fundraiser will be on November 3rd at Potbelly (19 W Ogden) from 4 -7pm. , Potbelly will share 50% of your purchases back to the Gardens when a customer presents a flyer. 3. **5647 Western Ave.** The Village has been pursuing demolition of this home due to extreme property maintenance and building code compliance issues. On October 24, 2016 the Court authorized the Village to demolish the subject property. The Village will place a lien on the property for all costs related to these proceeding and the demolition of the property. The Village has been in pursuit of this action since March 2016.
4. **Permits.** So far in October, the Village has issued thirty (30) building permits, including four (4) new homes, having a total reported construction value of \$2,698,026.

1. Fire Prevention Bureau Activity during the past week.
 - Three (3) Fire/Life Safety Inspections were conducted this week.
 - Several Fire Prevention Public Education talks were given as schools this week by on duty firefighters.
 - Several fire prevention/fire station tours were given this week.
 - Several pre-plan drawings were entered electronically this week. Lt. Godek and on duty staff members have been updating the pre-plan drawings many occupancies in the village and entering into our electronic data base. All buildings on the south side of the village are now completed.
2. Training Report:
 - Wednesday evening, eighteen (18) firefighters attended training. Rapid Intervention Training was conducted with the Hinsdale FD at a building at 950 N. Madison St. in Hinsdale where firefighters practiced rescuing firefighters that were disabled or trapped inside a fire building.

6. On Thursday, Chief Farmer and I met with DuComm Director Brian Tegtmeyer to discuss several dispatch issues to fine tune the dispatching of fire and police departments.

9. This week the Reserve Ambulance Medic 86 was placed into service because the newer Freightliner ambulance went to the Freightliner Dealer for warranty work. It is planned to place the newer ambulance back in service next week.
10. Last week the Lions Fire Lane Emergency Gate was damaged from heavy winds. The gate was repaired this week. Both Hinsdale and Clarendon Hills share in the maintenance costs for this gate.
