1. **Meeting regarding Metra Station Area Plan:** Dan Ungerleider, Zach Creer and I, along with our Legat consultants, met downtown on Wednesday with Metra and BNSF staff to discuss the potential project. The meeting was productive in that we gathered useful information and confirmed that there are no obvious restrictions to proceeding with improvements. We also confirmed, unfortunately, that there is little or no funding available from these agencies. We will continue working on preliminary planning efforts in part with the goal of preparing a submittal for funding from the West Suburban Mass Transit District. We expect to provide further planning information for the Board in January or February.
