Our officers, working with neighboring departments, were able to apprehend two suspects and retrieve the stolen property. Great job by our officers. Bellwood Man Charged with Aggravated Robbery In Grocery Store Parking Lot

WHEATON – DuPage County State's Attorney Robert B. Berlin announced today that bond has been set for a Bellwood man alleging he stole a woman's purse outside the Jewel grocery store located in Clarendon Hills. Enkhbold Naidandavaa, 20 (d.o.b. 6/14/1996) of 3604 St. Paul Avenue, appeared in bond court this morning where Judge Richard Russo set bond in the amount of \$100,000 with 10% to apply. Naidandavaa has been charged with one count of Aggravated Robbery, a Class 1 Felony and one count of Aggravated Battery, a Class 3 Felony.

It is alleged that on January 5, 2017, at approximately 8:30 p.m., Naidandavaa, wearing a ski mask and dark clothing, approached his victim from behind while she was loading groceries into her vehicle. It is further alleged that as he snatched the woman's purse from her, he pulled a gun on the woman and then pushed her to the ground. The gun was later determined to be an air-soft pistol. After stealing the woman's purse, Naidandavaa fled the scene. He was apprehended by officers with the Willowbrook Police Department four blocks from the store approximately ten minutes later and taken into custody without incident.

“The allegations against Mr. Naidandavaa are extremely disturbing,” Berlin said. “This type of outrageous conduct will not be tolerated in DuPage County and will be met with the full force of the law. I would like to thank the Clarendon Hills and Willowbrook Police Departments for their work on this case and for the quick apprehension of the suspect. I would also like to thank Assistant State's Attorney Jim French for his efforts in this case as well.”

Clarendon Hills Police Chief, Boyd Farmer, added “the successful arrest was a direct result of the quick response from Clarendon Hills officers. They were able to coordinate efforts with Willowbrook, Hinsdale and Westmont police officers that ultimately led to Naidandavaa’s apprehension.”

Naidandavaa’s next court appearance is scheduled for January 17, 2017 in front of Judge Liam Brennan.

Members of the public are reminded that this complaint contains only charges and is not proof of the defendant’s guilt. The defendant is presumed innocent and is entitled to a fair trial in which it is the government’s burden to prove his guilt beyond a reasonable doubt.

Recent events and training:



December 23, Officer Storino graduated the Cook County Sheriff's Academy.

Significant traffic and criminal activity during the period December 31, 2016 through January 6, 2017.

Dec 31, 10:10 pm, officers were called to an apartment located in the 285 N. Richmond Ave apartment building for a report of domestic battery. A 38 year old female was attacked by her 16 year old daughter. The 16 year old daughter was arrested for domestic battery and transported to DuPage County Juvenile Detention.

January 3, 2:47 am, officers were called to the area of Ann and Sheridan where it was reported four male juveniles were attempting to pull a street sign out of the ground. Officers located the individuals who ran from the officers when confronted. A 19 year old Clarendon Hills man was apprehended after he ran into a tree and fell to the ground. He was charged with damage to village property and consumption of alcohol by minor.

January 4, 5:55 pm, a 59 year old woman from Willowbrook came into the station to report her vehicle stolen from the Metra train station parking lot. The women related the vehicle was left unlocked with the keys inside. Department investigators are following up the case.

January 5, a resident in the 200 block of Holmes Ave came into the station to make an identity theft report. He had been notified of an account opened in his name from a bank in North Carolina. Officers assisted him and gave him information to resolve the situation.

January 5, about 8:30 pm, officers responded to the parking lot of the Jewel Food Store, 303 Holmes Ave, where an armed robbery had just occurred in the parking lot. A 63 year old Willowbrook woman, while walking to her vehicle, was approached by the offender, who attempted to take her purse. The victim resisted, which caused the offender to pull out an "air-soft" gun and stick it into her chest. Once the victim saw the gun she stopped resisting. The offender took her purse and ran south from the scene. Clarendon Hills' officers responded and called surrounding towns for assistance. Officers established a perimeter and a short time later the offender was taken into custody by Willowbrook officers. The offender is a 20 year old man from Bellwood. He was charged with aggravated robbery and aggravated battery. He was transported to DuPage County Jail.
