Subject: Weekly Report

1. **Meeting re: Downtown Decorations:** Mike Millette and I met with two residents to discuss downtown holiday decorations. We came up with some ideas for discussion including: Can the candles be removed from the existing wreaths if we chose to do so? Is it possible/affordable to use fresh wreaths on all or part of the poles (similar to Westmont and Hinsdale)? Can we get “softer” LED lights for the wraps? We will have a follow-up meeting to discuss these issues and eventually report back to the Village Board with recommendations.
2. **Meeting with Comcast Representatives:** Zach Creer and I met with Comcast representatives on Wednesday to discuss any issues we might have with Comcast service and/or the existing franchise. We did determine we will probably need to revise the franchise agreement to reflect the decision to not use the dedicated “PEG” (Public, educational, and government access) channel.
3. **Information re: Water Fund:** At the Board Meeting on Tuesday night, Trustee Stach asked for additional analysis regarding the Water Fund. I expect to have something to distribute to the Board at or before the March 20th meeting.
4. **Historical Society Building:** The Society has continued to work on repairs and upgrades to the building following the arson fire. We have recently authorized additional improvements including a new concrete patio area on the west side of the building. This work is being carried out by the Society, with the exception of some staff assistance from the Village to remove obsolete equipment.
