- 1. Tree City USA Designation:** Per the attached, I am happy to advise that the Village has again been recognized as a Tree City USA community. This is the 27th year of receiving this award. Thank you to our Public Works Department staff, especially our Forester Joe Ferrel, for their hard work in keeping our trees in such good condition.
- 2. Meeting re: IPBC Renewal:** Maureen Potempa, Zach Creer and I met with IPBC representatives to discuss our upcoming health insurance renewal. Though not confirmed by the full IPBC Board, it appears that our increase taking effect on July 1 will be 4.7%. This is the increase that applies specifically to our "sub-pool" with the IPBC. This is within the budgeted amount of 5%.
- 3. Planting Partner Sponsorships:** Sponsorships have been acquired for 8 of the 13 planting beds within the downtown business district. Sponsorship forms have been sent out to all the Chamber Members this past week in hopes of getting sponsors for the rest of the beds. Arbor Day Foundation Names Clarendon Hills Tree City USA

Clarendon Hills, IL was named a 2016 Tree City USA by the Arbor Day Foundation in honor of its commitment to effective urban forest management.

Clarendon Hills achieved Tree City USA recognition by meeting the program's four requirements: a tree board or department, a tree-care ordinance, an annual community forestry budget of at least \$2 per capita and an Arbor Day observance and proclamation.

“Tree City USA communities see the impact an urban forest has in a community first hand,” said Dan Lambe, President of the Arbor Day Foundation. “Additionally, recognition brings residents together and creates a sense of community pride, whether it’s through volunteer engagement or public education.”

Trees provide multiple benefits to a community when properly planted and maintained. They help to improve the visual appeal of a neighborhood, increase property values, reduce home cooling costs, remove air pollutants and provide wildlife habitat, among many other benefits.

Significant traffic and criminal activity during the period March 4, 2017 through March 10, 2017.

March 3, the Department was notified that Milwaukee Police Department had recovered one of the vehicles which had been stolen from the Infinity Dealership back in February. Milwaukee PD indicated the vehicle was used during the commission of a crime in their jurisdiction. This is the fourth vehicle recovered out of six stolen.

March 4, 9:46 pm, officers were called to the 200 block of Coe Rd. for an underage drinking party. Upon arrival, officers found three teens outside, who indicated there was underage drinking inside and the host's parent was home. Officers talked with the homeowner, who thought it was okay for his 18 year old son to host a drinking party, because he thought the partygoers were all taking Uber home. Officers counted approximately 60 teens at the party. All teens were required to call and be picked up by their parents. The homeowner was cited for allowing the party and will be required to appear at the Adjudication hearing.
