1. **Car Show:** We have confirmed that the Ferrari Club of America will be hosting a car show on Saturday June 24th. We are reserving the downtown parking spaces on the west side of Prospect Avenue that morning. The Club expects to have as many as 20 cars there starting at about 8 a.m. Hope you can come by, see the cars, and cater our downtown businesses.
2. **Daisy Days and Daisy Dash:** Daisy Days (June 16th and June 17th) and Daisy Dash (June 18th) are this weekend. Staff met with the Chamber and the Daisy Dash Committee to help make these events a success. Public Works and the Police Department will be busy assisting both events.
3. **Dancin' in the Street Update:** Dancin' in the Street planning efforts continued this week with a meeting Thursday Night. It appears everything is good to go for the first show on June 21st. Thank you to Mike McCurry, Village Veterinary Practice and Domino's Pizza for their major sponsorships this year.
4. **Strategic Planning:** Next Saturday (June 24th) at 9 am the Village Board will hold its bi-annual strategic planning meeting at the Police Station. Staff is working on preparing a presentation and items for discussion for this meeting.

1. **Brama La Pizza - 34 S Prospect Avenue.** Finished final inspections for the building renovation accommodating the Village's newest restaurant, Brama La Pizza. The restaurant owner and new owner of the building, Angelo Zayed, has completely renovated the interior of the building at the corner of Park Ave and S Prospect Ave. His menu will feature big slices of pizza and soda for \$5, whole pizzas, pastas and Italian sandwiches. He plans to be open this weekend for Daisy Days.
2. **Academic Approach - 136 Burlington Avenue.** We welcome Academic Approach to our downtown business community. Academic Approach will be offering student tutoring and personalized act/sat test preparation lessons. They will be hosting an open house at their new facility at 136 Burlington Avenue on June 24th from 9am-1pm. More information about their services can be found at www.academicapproach.com.
3. **RFP Comprehensive Zoning Ordinance Amendment.** On June 6, 2017, the Village posted a Request for Proposals (RFP) seeking consultant services for the preparation of a comprehensive zoning ordinance amendment for the Village of Clarendon Hills. The RFP identifies the need to identify, correct legal conflicts and deficiencies in the Zoning Ordinance, and to modernize the ordinance as a whole to ensure that it is clear in language as well as user-friendly for Village staff, residents and the Clarendon Hills' business community. On Tuesday morning I hosted a pre-submittal conference call allowing potential consultants the opportunity to ask questions about the requested project. Four consulting firms participated. Given that there were very few questions asked during the conference call, I suspect we will be receiving proposals from consultants who did not participate in the call in addition to those who did. Proposals are due on June 27, 2017.
4. **55th Street Sub-Area Plan Steering Committee Meeting.** On Wednesday evening the project Steering Committee met at village hall to review and discuss the presented interim report. To date, the 55th Street Sub-Area Plan has included evaluation of existing conditions (what is in the sub-area), community engagement (how do people feel about the sub-area), and goals and objectives (what are the vision and priorities for the subarea). During Wednesday night's meeting the Steering Committee was asked to consider the next logical question: what are the implications for the Village, its residents, and all those in the subarea of potentially annexing properties into Clarendon Hills? A copy of the interim report will soon be posted on the project webpage. We plan to schedule an open house at the Christian Church of Clarendon Hills in late-July/early-August.
5. **NPDES Audit.** The Village of Clarendon Hills is required to hold and maintain a National Pollution Discharge Elimination System (NPDES). This permit assures that the Village's stormwater management systems and respective programs

protect local water bodies (creeks, rivers, lakes etc.) from polluted stormwater runoff. On Wednesday morning Public Works Director Millette and I met with a representative of the Illinois Environmental Protection Agency to review program and discuss how the Village can improve its compliance with the respective NPDES regulations. More information about this program can be found at www.clarendonhills.us/npdes. In addition to reviewing the recently drafted Stormwater Management Program Plan, drafted by the Village Engineering Consultant (CBBEL), we inspected the Public Works garage and service yard, and the Williams Court development on Woodstock. All things considered, our meeting went well.

6. **Permits.** So far in June the Village has issued eight (8) building permits having a total construction value of \$179,955.

1. Fire Prevention Bureau Activity during the past week.
 - Three (3) Fire Prevention/Life Safety Inspections were conducted.
2. Training Report:

3. Emergency Medical Services Report:
 - Wednesday evening, Twenty three (23) Firefighter EMT's and Paramedics attended monthly continuing education. Skills were practiced on various pieces of EMS equipment such as IV set up, Cardiac Monitor, Defibrillation, Power Cot and Power loader training, etc.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
5. Emergency Management Report:
 - No report this week.
6. DuComm Report:
 - On Tuesday afternoon, Chief Farmer and I attended the monthly meeting of the DuComm Fire/Police Chiefs. 9-1-1 phone system problems, Illinois 9-1-1 funding issues and the new CAD system were discussed.
 - On Thursday morning, I attended the monthly meeting of the DuComm Fire Chiefs. Three (3) call reviews were conducted along with other normal business.
 - Today, DuComm is scheduled to change the Fire VHF radio antenna on our water tower at 233 Burlington Ave.
7. The new Heavy Duty Rescue Squad 86 is in its 11th week of construction and is progressing rapidly. Deputy Chief Krupp, Lieutenant Godek, Engineer Laffey and I will be going back to Pierce in Wisconsin on Monday June 26th for the final inspection. At this inspection we perform a complete check out of the vehicle to make sure it includes all equipment and components as required in our specifications and also the operation of all of this equipment. After this final inspection the vehicle will remain at Pierce for about another week to correct any items on our punch list. After that the vehicle will be delivered to the Pierce Dealer in Aurora for final cleanup and correction of any other defects. We are anticipating on accepting the vehicle at the dealer in Aurora during the 2nd week in July. Every week Pierce takes photos of the vehicle in production

and sends them to customers. Attached are the week 10 photos that were taken on June 9, 2017. I should receive week 11 photos later today or tomorrow.

8. On Saturday afternoon, Deputy Chief Krupp and I will be attended the fire academy graduation for recruit firefighters Alex Dorow, Scott Larem and Austin Schlicher at the Western Springs Fire Department. Recruit firefighters from Clarendon Hills, LaGrange Park and Western Springs were in this academy. Myself and the Chiefs from Western Springs and LaGrange Park gave presentations to everyone present at the graduation.
9. On Monday, Waterway, Inc. was onsite at the fire station to perform pressure testing on all fire department hose and also ground ladder testing. This is done annually.
10. Incidents of Interest:
 - Wednesday, June 14th at 5:11 PM. Clarendon Hills firefighters along with Hinsdale Engine 84 responded for a house on fire at 124 Oxford Ave. Upon arrival firefighters found a Com Ed utility pole in the rear yard that was struck by lightning and was on fire. No fire at the house. Fire extinguished quickly, area secured and Com Ed notified.
 - Mutual Aid Calls:
 - Three (3) ambulance assists to the Westmont Fire Department.
11. Fire/Rescue/EMS calls:
 - The Hinsdale Fire Department responded Automatic Aid to Clarendon Hills six (6) times.
 - The Clarendon Hills Fire Department responded Automatic Aid to Hinsdale four (4) times.
 - During the past week, the fire department responded to twenty seven (27) emergency calls.

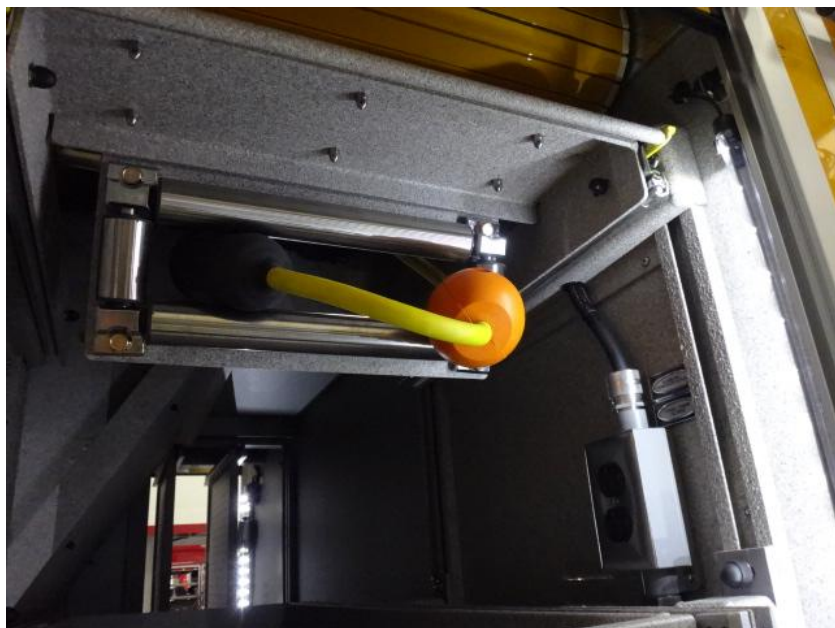

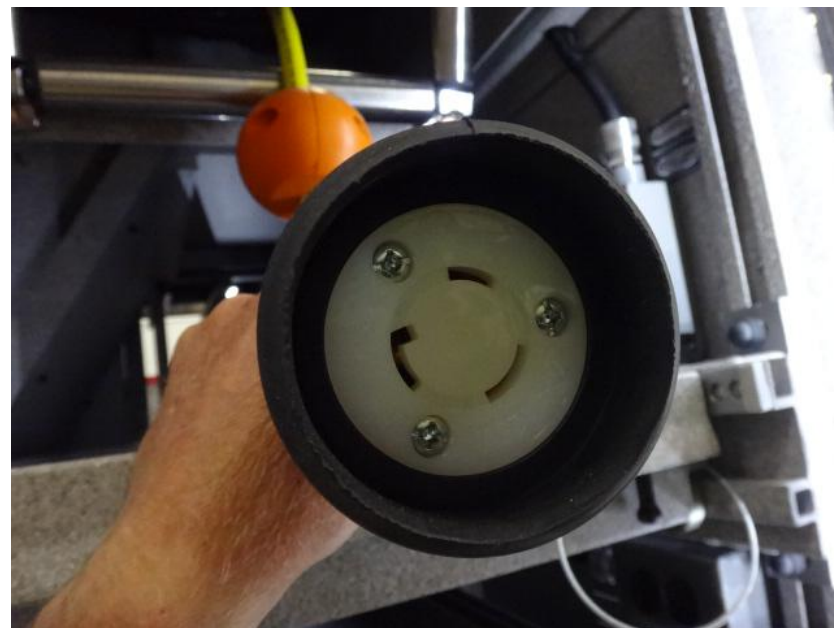
