Subject: Weekly Report

1. **Dancin' in the Street Update:** Despite the storms and bad forecasts the concert went on this past Wednesday. It was our lowest attendance in a while, but the rain held off. These type of weather days make it difficult in terms of deciding when or if to cancel the event. Let's hope for better weather the next few weeks. The next concert will be July 19th. The concert series is now scheduled to run through August 9th.
2. **Audit Update:** President Austin, Trustee Jorissen, Maureen Potempa and I met on Friday afternoon with Fred Lantz from Sikich to review the SY '16 Audit. It was a positive presentation. Fred is prepared to make a shorter presentation of the document to the full Board at the July 17th meeting.
3. **State Budget Authorization Update:** On Thursday, July 13, 2017, Maureen Potempa attended a seminar hosted by the Illinois Department of Revenue. This presentation was put together several months ago so not all of the information was reflective of the recent changes that were just passed in Springfield. However the changes were discussed and the impact that municipalities can expect to see. LGDF was the main topic of discussion. The first change that we will directly be impacted by is a 10% reduction in LGDF payments in state fiscal year 2018. The second change is the direct deposit of these funds into the Local Government Distributive Fund rather than requiring the money to first pass through the State General Revenue Fund. Bypassing the GRF will result in municipalities receiving two accelerated payments (one time only) for a total of 14 LGDF payments instead of 12 in state fiscal year 2018. This means that, despite the 10% reduction in LGDF payments during state fiscal year 2018, local governments should actually see a slight increase in distributions for this one year. The accelerated payments, however, may be contingent on the Comptroller having the cash flow to make the payments earlier than usual. The bottom line is that we expect to see a loss of 10% of revenue from the LGDF over the next year, or approximately \$85,000.

In some instances, they find keys in a vehicle which results in the theft of the vehicle or the ability for the criminal to enter your home that night or at a later date. Other events:

July 10-13, the Department hosted a 4 day NEMERT instructor course. The State of Illinois Training and Standards Board mandates law enforcement instructors to be certified in order to instruct officers. Officer Finrock attended and became a certified instructor, which allows us to continue in-house training.

July 9, 159am, an officer stopped a vehicle at Burlington and Rose for speeding. The vehicle was occupied by a 16 year old driver from Clarendon Hills and a 17 year old passenger from Hinsdale. Both had been drinking. The officer called their parents, who picked them up from the scene.

July 12, a resident came into the station to make an identity theft report. The resident indicated someone had used his SSN to open fraudulent credit card accounts. One of the accounts had \$2,000.00 in charges.

1. Fire Prevention Bureau Activity during the past week.
 - Several fire inspection inspections were conducted this week.
2. Training Report:
 - No report.
3. Emergency Medical Services Report:
 - Wednesday evening, twenty eight (28) Firefighter EMT's and Paramedics attended monthly continuing education that was instructed by a Loyola EMS Instructor.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
5. Emergency Management Report:
 - No report this week.
6. DuComm Report:
 - The new DuComm facility in Wheaton now has pre-cast concrete walls in place.
 - On Tuesday, July 11th I attended the monthly meeting of the DuComm Chiefs (Fire & Police) Operations Committee. Normal business was conducted. It was also reported at this meeting that the state 9-1-1 surcharge was increased from .87 cents to \$1.50 effective January 1, 2018. This means that revenues for the DuPage County ETSB will increase dramatically. Also at this meeting I was elected President of this Committee, and Burr Ridge Police Chief John Madden was elected as Vice-Chairman. Both positions are for one (1) year. The DuComm Chiefs also voted to recommend to the Executive Committee the purchase of new Frontline Software which will be a new software that will handle overnight parking requests for all police departments within DuComm.
7. Global Fire Equipment (Pierce Dealer) continued work this week to correct three (3) issues with the new squad truck. At this time it looks like all repairs will be made and we will accept the vehicle next week and also make the final payment to them.
8. The 1994 Squad Truck was posted on Ebay for one (1) week, and unfortunately it did not sell for the minimum price of \$25,000. This week I have been in contact with three (3) used fire equipment buyers and have received an offer from one of them. I am still waiting for responses from the other two before a decision is made.

9. Today, the members of the Clarendon Hills Firefighter Pension Board held their quarterly meeting. Normal business was conducted.

10. Incidents of Interest:

- Friday, July 7th at 3:39 PM. The fire department responded for a grill on fire at 5 Blodgett Ave. Fire was extinguished quickly by firefighters. No damage to the house.
- Tuesday, July 11th at 12:10 PM. Medic 86 and Squad 86 responded for a vehicle accident with injuries on 55th St. at Tennessee Ave. One (1) injured patient transported to a local hospital.
- Thursday, July 13th at 6:19 AM. The fire Department was called for an explosion in the area of Railroad Ave. and Walker Ave. Upon arrival firefighters found high voltage Com Ed wires down on Railroad Ave. Firefighters cordoned off the area for safety reasons to keep commuters out. Called Com Ed and awaited for their arrival. Com Ed arrived and cut power to the downed wires. Several buildings in the downtown area along Railroad Avenue were without power. Com Ed restored the power at 3:11 PM, almost nine (9) hours later.
