## Message from the President - Candyland

It's a great time of year in the Village as our downtown fills with families and people head out for their summer vacations. One thing to keep in mind this summer is safety. Most suburban communities have been hit with an increase in property crime, particularly car break-ins and car thefts, over the last few months. Even our small town has fallen victim on a few occasions. Thieves that have been apprehended in neighboring towns refer to our area as *CANDYLAND*. Candyland because it's so easy to steal and deceive people. Fortunately, there are easy ways to help prevent these thefts.

**LOCK YOUR CAR DOORS AND DO NOT KEEP KEYS IN THE CAR.** Doing both of these things are simple ways to make our town less attractive to would be thieves, which benefits not only you and your families but also your neighbors.

Another note, to cut down on fake solicitors, the Village has stepped up its solicitor licensing program. Per Village Code, any non-religious, non-political solicitor/canvasser must register with the police department, and provide a background check to the police department. **Any solicitor without an approved permit should be reported to the police.** The top portion of the permit looks like the sample below. It is a common burglary technique to impersonate a solicitor in order to case houses for potential robberies. Registering solicitors is one way to cut down on this crime. We continue to rank as the one of the safest communities in Illinois, but there is always room for improvement especially with common sense crime prevention techniques.

### REQUIRED ATTACHMENTS TO APPLICATION

(Each Individual conducting solicitation must complete a separate form and pay a separate \$50.00 fee)

- NON-REFUNDABLE APPLICATION FEE OF \$50.00** (cash or check-make payable to Village of Clarendon Hills)
- COPY OF APPLICANT'S DRIVERS'LICENSE OR STATE ID**
- COLOR PHOTO** (passport size, this will be used on the solicitor's license)
- RESULTS OF BACKGROUND CHECK** Background results must be from IL State Police Bureau of Identification (fingerprints taken by a state-approved Livescan vendor within the last 90 days), with the results submitted to this Police Dept. For authorized vendors see the Illinois State Police website.

# Bi-Monthly Water Billing

July is the first month in which the Village of Clarendon Hills has implemented bi-monthly billing, which the Village Board approved as a cost saving measure and to improve operating efficiency for the Village. What does this mean? This means that you will receive a water bill for the previous two months every other month. For example, this July bill is billing you for your May and June usage. The schedule is as follows:

- May and June usage: Billed in July
- July and August usage: Billed in September
- September and October usage: Billed in November
- November and December usage: Billed in January
- January and February usage: Billed in March
- March and April usage: Billed in May



## Water Bill Late Fee Changes

Water bills are due the 25th day of the billing month.

A 10% late penalty will be added to the total amount of the bill after this date. Payment must be received, not postmarked, by the end of the business day of the due date to avoid the late payment penalty. Failure to receive the bill does NOT exempt the customer from this penalty. Accounts with any balance, including fees and /or penalties that remain past due after 30 days will receive a Red Tag Notification. An automatic \$75.00 Red Tag fee will be applied to the customer's account at the time of the Notification. If payment, along with Red Tag fee is not received within two days following the Notification, water service may be disconnected. If water service is disconnected, payment of the entire balance of the bill and a \$75.00 re-connection fee is required before services will be resumed.

## Electronic Water Billing - Coming Soon!

In May, the Village Board approved a more convenient option for residents who prefer to receive and pay their bills on-line. This new Green Pay E-Billing system allows customers many great benefits including:

- 24 Hour Access to a personal customer portal with online bill showing up-to-date balances and usage history
- Assists property owners and other out of town payers to make payments on water bills
- Access to faster online bill pay
- Currently, residents need to type in all of their information online every time a payment is made on-line. The new system saves residents time by allowing recurring ACH, Credit card or debit card and will maintain customer information for quicker access and payment for those who do not choose recurring payments
- Access fee-less online payment by ACH (Direct Debit)
- Increased ease of signing up for and maintaining Automatic ACH Bill Pay (Direct Debit)
- Residents will have the option of receiving an e-bill bi-monthly along with their Trustee Topics newsletter, giving customers more control over paying bills and reducing the risk of bills or payments getting lost in the mail
- Village can send out reminders that payment is due
- Helps the environment by saving trees

You will be notified as soon as this option is up and running. In the meantime, should you have any questions regarding these changes, please contact the Water Department at 630-286-5416.
