
In contrast to the positive feelings about our town, I am disappointed about what we are seeing in Springfield. Despite (finally) passing a budget, the state continues toward structural financial problems without real reforms. Rating agencies are downgrading communities because of state financial problems (although our Village is one of the few to maintain a AAA rating). The State continues failing to adequately fund our local schools, universities, and keeps picking away at revenues promised to our Village. Instead of fixing problems with the State's revenue base and solving long-term financial problems, the state continues to concentrate on issues which are irrelevant to the State's budget and shift costs to the local governments whom people actually trust and count on to keep us safe and our children educated. Instead of setting up a balanced budget, the State continues to limp along with a huge bill backlog, despite the large income tax increase.

The grand compromise was hardly a compromise at all. We have yet to see any of the promised relief from Springfield from unfunded mandates. We have not received any real workers' compensation reform. We have not gotten any relief from prevailing wages which increase our construction costs and makes needed infrastructure improvements cost prohibitive. Common sense reforms like Suburban Township consolidation, and pension fund consolidation are not within reach. Harder reforms that allow larger consolidations continue to be a fool's dream. Instead of a plan, we have continued uncertainty which will surely continue through the next gubernatorial election.

We are a great State with a world class city, a highly educated population full of talented people, international manufacturing companies, and a strong financial sector. We need meaningful reforms that encourage people to stay in the state after their children complete high school or when they are considering retirement!

Well, enough political updates, now back to the community we enjoy. Please mark your calendars for the next community event which is the Park District's Fall Family Festival on Saturday, September 16th from 3:30-6:30 in Prospect Park (off Norfolk Avenue). Fun for the whole family with food and beverages and lots of children's activities.

Slow down and keep your eyes on the road! Our charming town has narrow, winding streets and lots of hills that block visibility. On garbage day especially it is important to pay attention as the streets get even more narrow as residents' garbage cans incorrectly encroach on streets rather than staying on their private driveways. The speed limit is 25 mph within the Village, with the speed slowing down to 20 mph in the business district and school zones. We have a lot of children who walk to and from school, along with residents whom enjoy walking to town. Keep you and our other residents safe by driving the speed limit. Please, pay attention to the road, keep off your phones while behind the wheel! Our officers are watching.

Electrical Aggregation

Following the passage of a 2013 voter referendum by majority vote, the Village of Clarendon Hills has contracted to procure lower-cost electric supply for residents and small businesses. Since the program started, resident's have benefited over \$500,000 from lower rates than ComEd base rate. The Village recently renewed the program with the lowest bidder, Dynegy Energy, at a fixed rate of 7.107¢ per kWh for a 13-month term from September 2017 to October 2018. There is no enrollment fee to join, and no early termination fee to leave the program. All residents are automatically enrolled in the program who have not opted-out in previous cycles. There is no required action from resident's if they wish to remain in the program. After the initial opt out period, a ratepayer may enroll at any time by calling Dynegy at 844-351-7691 and asking for the Village of Clarendon Hills rate.

ComEd default rate Sep 2017 to May 2018:	7.122¢ per kWh
Clarendon Hills rate to October 2018:	7.107¢ per kWh

The ComEd rate will readjust in June 2018 while the Clarendon Hills rate will remain fixed through October 2018. Additionally , the ComEd rate can float 0.5¢ per kWh in either direction.

As a reminder, all of the wires and transmission are still handled by ComEd. To report an electrical outage, or for questions pertaining to your ComEd bill, call ComEd at 800-334-7661.

As always, resident's can choose other third party suppliers. The Village recommends that in doing so, the potential customer read all of the fine print looked especially for introductory rates that increase greatly shortly thereafter. Also, look for potential opt-out penalties in these agreements as these fees often can be large.

If you require additional assistance, call NIMEC at 800-856-3404 to leave your question and callback number. You will be contacted within 24 hours regarding the issue.

Water Bill Late Fee Changes

Water bills are due the 25th day of the billing month. Billing months are September, November, January, March, May and July.

A 10% late penalty will be added to the total amount of the bill after this date. Payment must be received, not postmarked, by the end of the business day of the date due.

Tips on Flood Prevention!

- Clean gutters and install gutter covers to prevent clogging.
- Redefine and clear swales throughout yard to allow an appropriate drainage way for storm water runoff.*
- Raise the low entry elevation at which storm water can enter your home around basement doorways or windows.
- Install an ejector pump or backflow device to reduce flooding from sanitary sewers and combined sewers.*
- Verify existing sump pump and outlet pipe have sufficient capacity for discharging during intense storm events.
- Provide a relief outlet for the sump pump outside of the house that is a safe distance from the foundation in case of surcharge, frozen outlet pipe, or other blockage.*
- Install a backup source of power for sump pump in case of electrical power failure.*
- Extend downspouts away from the foundation 5-10 feet; be sure discharge remains a distance of at least 5-10 feet from your property line.
- Repair foundation cracks throughout basement to prevent seepage.
- Raise the low-entry elevation of window wells and/or install drains in the window wells and connect them to the sump pump system.
- Install glass block windows in place of basement windows (except escape window required by code) to prevent water inflow or infiltration. *
- If a storm sewer structure is adjacent to the lot, an underdrain system could be installed to collect excess runoff, any remaining seepage or any infiltration resulting from hydrostatic pressure.*

The recommendations provided above may not eliminate flooding or flood damage within the residence; however, if installed correctly they should effectively reduce the risk of flooding. It should also be noted that any of the recommendations may be implemented individually, however, many suggestions may be used in conjunction with one another to provide a greater impact in helping to reduce the risk of future flood damage.
