1. **CY '18 Budget Distribution:** Our original schedule showed the full budget being released on October 13th. Though it is fundamentally completed, I have decided to hold it over the weekend for one last review. We now expect to release the budget on-line on Tuesday or Wednesday next week. This still leaves plenty of time for review prior to the budget hearing on October 28th. Please contact Maureen Potempa or me if you have any questions regarding the schedule.
2. **Finance Committee Meeting:** The Finance Committee met on Tuesday evening to discuss the General Capital Fund and capital portion of the Water Fund. We had a good discussion which was helpful in identifying questions that the Board as a whole may have. We will review those as part of the discussion on October 28th.
3. **DMMC Coffee Break with Legislators:** President Austin and I attended this event on Wednesday morning. We had the opportunity to discuss areas of local concern with area State legislators, including Representative Patti Bellock.
4. **Meeting re: Park District Plans:** Dan Ungerleider and I met with Park District staff on Thursday to discuss their plans for maintenance facilities at Prospect Park and at the Public Works Garage. We agreed to work towards an IGA for use of the PW site that included support for the Education Garden. A part of the plan is to gather rainfall from the roof of the new facility for use at the Garden. We also may be able to take power off the new facility for use at the Garden.
5. **Discussions re: Additional Tower Lease:** Zach Creer and I had a phone conference with representative from a communication company regarding putting equipment on our Burlington tower. It appears we will be able to reach an agreement which will come before the Board at an upcoming meeting. This would result in additional revenue for the Capital Projects Fund.

Subject: Weekly Activity Report

Significant traffic and criminal activity during the period October 6, 2017 through October 13, 2017.

- On October 6, 11:15pm, a Naperville resident was stopped on Rt. 83 and cited for driving on a suspended driver's license. The vehicle was driven from the scene by a valid driver.
- On October 7, 1:09am, a Chicago resident was stopped on 55th St. for speeding. A check of the driver revealed he had a suspended driver's license and an outstanding traffic warrant for his arrest. The driver was placed into custody and transported to the station. The subject posted the necessary bond and was released.
- On October 7, 10:30pm, officers stopped an Oak Park resident for driving on a suspended driver's license. He was placed into custody and transported to the station. He posted bond and was released.
- On October 8, 12:54am, officers stopped a Chicago resident for driving on a suspended driver's license. He was placed into custody and transported to the station. He posted bond and was released.
- On October 9, 1:02am officers responded to Ann Street for a suspicious circumstances call. Upon arrival, the complainant eluded to possible drug activity and advised that several cars keep coming and going from the apartment building throughout the night and that multiple people continually visit an apartment on Ann Street. Officers made contact with several subjects who were found outside the building. Investigation continues.
- On October 9, 4:30pm, officers cited a Chicago resident for driving on a suspended driver's license while on Ogden Ave. The driver was released after bonding out.
- On October 12, 2:45am, officers stopped a vehicle for a stop sign violation at Harris and Eastern. While speaking with the occupants, officers could smell the odor of cannabis. After a brief investigation, two juvenile passengers were

taken into custody and transported to the station. One juvenile was cited under local ordinance for possession of cannabis, possession of alcohol by a minor and a curfew violation. The other juvenile was cited under local ordinance for possession of cannabis. Both juveniles were released after contacting their parents.
