Subject: Weekly Report

- 1. CY '18 Budget Distribution/Session:** As of today the proposed budget for CY '18 is available for review. The document is available in the drop box and is on the [Village's website](#) for public review. This is all in preparation for the budget review session on Saturday, October 28th. As mentioned before, we made many changes to the budget format and assumptions, so it is possible we will have additional changes moving forward. One of the many changes is the inclusion of detail sheets in the operating budget sections to provide additional information about individual budget items. Please contact Maureen Potempa, Zach Creer or me if you have any questions regarding the budget before next Saturday.
- 2. District #3 Meeting:** I attended the District #3 meeting in Darien on Tuesday night. Representatives from Westmont, Darien, Willowbrook, Burr Ridge and Woodridge also attended the meeting, along with County and State legislators. We discussed various issues of interest to each municipality and the region.
- 3. Du-Comm Board of Directors Meeting:** I attended this meeting on Tuesday morning, along with Chief Leahy. Various issues regarding membership and the new Du-Comm facility were discussed. We also set up a follow-up meeting of the Fire Rate Committee in November.
- 4. Discussions re: Additional Tower Lease:** We have had additional conversations regarding a communication company request to put equipment on our Burlington tower. We hope to have additional news on this in the next couple of weeks.
- 5. Explosions in Willowbrook:** Explosions occurred in Willowbrook earlier today, apparently the result of a gasoline leak affecting sanitary sewer lines. CH Fire personnel have been assisting in the effort. All indications are the leak involved has and will not affect properties in Clarendon Hills.

6. **Last Weekend Storm/Flooding Event:** We discussed this event at the Board Meeting last Monday night. The Board asked that staff and the Village Engineer review previous studies to determine if improvements were considered at the Hinsdale Golf Club and the Park Avenue Basin. Further information on this is included in the Public Works Department report. Staff has continued to talk to residents who suffered damage as part of the storm. We expect to continue reviewing these incidents to determine if there are any viable ways to address the incidents. We remain concerned that there will be little that can be done to avoid flooding events when we see that quantity of rain.

Subject: Department Report

1. I confirmed that that the Friday night to Saturday morning rainfall total of 0.9" was included in the gauge's record, so **8.57"** is the correct amount for the event. Our general storm clean-up efforts were complete by mid-day Tuesday and the Park Avenue basin was ready for soccer and lacrosse practice yesterday. We are still following-up with a dozen residents.
2. The sidewalk replacement work is substantially complete. Some squares were vandalized and will be surface ground or replaced. A pad for the bike rack near Starbucks and The Creperie was installed as part of this contract as was a pad on the south side of Burlington east of Golf. The racks will be anchored in place as soon as the concrete cures.
3. Lee Fell (CBBEL) confirmed that, after the April 2013 flood, the Park Avenue basin was analyzed for improvements as was the Hinsdale Golf Course. Nothing was found that could improve the golf course aside from removing entire sections of it from use and solely dedicating them to stormwater management. The Park Avenue basin could only be modified if the chiropractic building and the house immediately to its east were to be removed or a system of flood walls and gates were installed to protect those properties from water deflected from the rear yards of the Colfax properties.
4. Speaking of the golf course, yesterday Joe Ferrel was called to observe the sinkhole which had developed over the existing 18" corrugated metal storm sewer which carries drainage from Oxford to the golf course pond. In a joint effort, golf course personnel excavated the sewer, Village personnel replaced the section of pipe and golf course forces backfilled it and will repair

the turf. However, the remainder of the pipe is in bad shape, so we will televise it and may need to consider a larger replacement effort.

 - On Tuesday morning I attended the Du-Comm Board of Directors and Executive Committee meetings in Carol Stream. One thing discussed by the director was the changing of Du-Comm over to a new 9-1-1 telephone system on October 25, 2017 at 6:30 AM.

- Tuesday, October 17th at 9:08 AM. Ladder 86 and Squad 86 responded for a gas leak at Chicago and Tuttle Ave.
- Tuesday, October 17th at 6:13 PM. Ladder 86, Medic 86 and Squad 86 responded again to Chicago and Tuttle Ave. for a large gas leak. Leak located, Nicor called and Nicor began excavating the ground to repair the leak.
