Subject: Weekly Report

1. **CY '18 Budget Workshop:** The Budget workshop will be held this Saturday. The budget has been published on the website since October 20<sup>th</sup>. First consideration is expected at the Village Board meeting on November 6. Thank you to all Village Staff who participated in this year's budget process. In particular, thank you to Maureen Potempa, Zach Creer, and Vicki Pries for all of their work getting the final proposed budget together. This 175 page document is a huge undertaking every year.
2. **Trick or Treat Hours:** Hours for trick or treating next week are on October 31<sup>st</sup> from 3:00 pm to 7 pm.
3. **Trick or Treat at the Police Department:** The Police Department will be open from 9 am to 7 pm for trick-or-treaters on Halloween. Please stop by if you get the chance.
4. **Storm/Flooding Event:** Staff continues to respond to flooding complaints. Staff is assembling a complete list and is planning on creating a report on the hardest hit areas. Staff is recommending in particular additional funds in the 2018 budget for studies around Park Ave.
5. **Meeting with CHMS Principal:** Dan Ungerleider and I met with the CHMS principal on Monday morning. It was good to get a chance to meet. Amongst other things we discussed how we might work together in the future to share services if the opportunity arose.
6. **Assistant to Village Manager Recruitment:** We have begun recruitment for this position with several interviews already scheduled for next week. We hope this process can be completed as soon as possible.

1. We have completed the resigning of the 2018 Road Improvement project area including the addition of two flashing pedestrian ahead signs on Oxford.
2. The sidewalk replacement work is complete. The bike racks near Starbucks and The Creperie and on the south side of Burlington east of Golf are being anchored today.
3. Collin Franco and Mike Beuser have made great progress in the LED light fixture swap-out project. The contractor is also progressing well on the external fixtures and light pole changes. The grant deadline is November 17<sup>th</sup> and we are well on track to meet it.
4. We are still following-up on some of the concerns raised by the October 15-15 storm. As leaves start to fall, we will be as diligent as we are able to stay ahead of our known problem areas. Any help residents can provide is always appreciated.
5. A design kick-off meeting for the Burlington tank painting project was held on Tuesday. Upon further review and discussion, Joe Ferrel and I are recommending that we switch the schedule and paint the Park Avenue tower next year and the Burlington tower in 2019. The tight work space at Burlington will require temporary access agreements which may take months to negotiate and the number of cell antennas (soon to be five) require a longer lead time for temporary relocation. The last time the tank was painted, these concerns did not exist. Had we known, we would have started the design process sooner. Fortunately, the Park Avenue tower is considered a “vanilla” project and the design and bidding process can be completed by February/March of 2018.

1. **Zoning Ordinance Modernization Project.** During the past two weeks the Village hosted stakeholder meeting with various members of the Clarendon Hills community to discuss issues and priorities related to the upcoming comprehensive zoning ordinance amendment. The observations, comments and recommendations provided by these volunteers are now being compiled by the Village's planning consultant, Camiros, and will be used during the development of the new ordinance. 2. **Downtown Construction.** 88 Park Avenue has begun third floor construction and installation of streetscape improvements on Prospect and Park Avenues. 229 Park Avenue has begun construction of second to fourth floors with expectations of being "under roof" by the end of this year. On Wednesday, the general contractor for 229 Park Avenue provided temporary pavement in the alley in preparation for the winter. Total reconstruction of the alley will occur in the spring. My appreciation to all of the businesses backing to this project for their continued patience.
3. **Richmond Education Gardens.** Last week an Eagle Scout Candidate and his troop cleared the remaining weed trees and evasive plants from the garden site to make way for rough grading later in October. In spring the scout will return to install a gravel pathway and to plant various trees in the Garden's food forest.

4. **Burlington Water Tank.** On Wednesday, Public Works and Community Development Departments met with our engineering consultant to review plans for the upcoming painting of the Burlington Water Tank. This project will include temporarily removing all antennas from the tank, cleaning the tank and repainting the tank.
5. **Permits.** So far in October the Village has issued 21 permits, including one new home, having a total reported construction value of \$872,309.
