**Significant traffic and criminal activity during the period November 23, 2017 through November 30, 2017.**

- On November 24, 9:09am, officers responded to the 10 block of Iroquois for a loud noise complaint. Due to this being an ongoing issue, the resident has been referred to the adjudication process.
- On November 24, 7:26pm, officers responded to a vehicle crash at Stonegate and Ogden. Once on scene, officers noted an odor of cannabis emitting from the offending driver's vehicle. The offender also displayed indicia of cannabis consumption. After a brief investigation, officers attempted to place the offending driver into custody. The driver resisted officers, but was ultimately taken into custody and transported to the station. The Downers Grove resident was charged with resisting a police officer and given a civil ticket for possession of drug paraphernalia. The offender was released after posting bond.
- On November 24, 10:08pm, officers responded to the Country House Restaurant for a fight in progress. Once on scene, officers separated the parties involved and conducted an investigation. Pending.
- On November 27, 12:03pm, a resident came into the station and reported unknown subjects attempted to open a line of credit using their personal credentials. Investigation continues.
- On November 28, 3:34pm, officers responded to the 100blk of Byrd Ct. for the identity theft report. The complainant related that an unknown subject opened a line of credit in their name. Pending.

12. Mutual Aid Calls:


