1. **Water Fund Review:** Finance Director Potempa and I continue to review issues related to the Water Fund, including reviews of existing policies with previous staff members. We expect this review to lead to recommendations to the Board on how to proceed with water projects in 2019 and beyond.
2. **EDC Meeting Preparation:** Community Development Director Ungerleider is working with members of the Economic Development Commission to set up a Forum to discuss development opportunities for the community. The panel for this discussion is expected to consist of developers, real estate professionals and financial experts. An announcement will be made regarding a date, expected in early March, shortly.
3. **DMMC Manager's Committee Meeting:** I attended this meeting on Thursday morning. Many items were discussed including forming a human resources sub-committee to help communities deal with these issues in a more efficient manner. Peter Nickell will likely attend these meetings. We also received the results of a credit card use survey which we had requested. The results will help us determine a course of action moving forward.

1. Light pole replacements continue on Prospect. Nine of the planned ten are in place and the last was to have been installed today until...
2. ...we were called-out for a water main break @ 145 Chicago at 2:00 a.m. This was a substantial break and we lost a lot of water. We have not yet had the time to estimate the loss but both water towers dropped five feet starting at 1:00 a.m. until the main break was isolated around 3:00 a.m. The loss was so great because the main on Chicago is a 10" feeder and the break was relatively close to the Middaugh Avenue connection to the Water Commission. The main was installed in 1980 and the break appears to have been related to acidic soils. As of the time of this writing, the repair is complete, Chicago Avenue is open for two-way traffic and the residents again have water. Kudos to Mike Bueser, Joe Coons, Colin Franco, Roger Heidenreich, Dave Pendill and Ed Tannhauser who worked on the break itself and to Glenn Dolgner who kept a steady supply of salt on Chicago the keep westbound traffic moving safely. This afternoon, we will focus on removing ice build-up on the sidewalks.
