Subject: Department Report

1. The 2018 Water Main Replacement project is moving along quickly. The new main is complete on the south block of Arthur and has been undergoing bacteriological testing since Wednesday. It is anticipated that the results will be clear by Monday allowing service transfers to begin Tuesday. While this testing has been underway, main installation continued and was completed today on the northern block with the termination at Chicago.
2. Our contractor performing spring storm sewer jetting completed their work this week. We spent extra time on Chicago between Golf and Prospect because that sewer was impacted by the trench pumping we had to do when the water main broke in January.
3. In-house crews are working on sign replacements and tree trimming and removal.
4. Two big trucks are currently loaded with salt and one crew is on standby for tomorrow morning should the ice storm develop.

- 229 Park Avenue.** The grand opening of the model at 229 Park will be on March 18 from 1-4pm. The model is a two level live-work unit with a store front entrance ready for business on Walker Avenue. The model will feature all of the amenities and finishes that will be found throughout the building when it is completed in May 2018. - Richmond Education Gardens & Apiary.** On Monday we received notice from the DuPage Water Commission that they will be granting \$10,000 to the Villages of Clarendon Hills and Westmont for purchase and construction of a hand water pump and cistern at the Richmond Education Gardens & Apiary. Earthwork and installation of underground stormwater systems, including the cistern and hand pump, is expected to begin in late April. - Zoning Ordinance Modernization Project.** On March 22 at 7:30pm the ZBA/PC will be conducting the first of several workshop needed to review and develop a comprehensive amendment to the village zoning ordinance. During Thursday night's meeting the Village's planning consultant will be presenting the First Draft Ordinance and provide instruction for future review and discussion. No action will occur during the meeting. The Village does not anticipate completing this project until late August 2018. Please visit www.clarendonhills.us/zomp to learn more.
- Permits.** So far in March the Village has issued seven (7) permits, including one (1) for a new home, having a reported combined construction value of \$720,595.

Recent events and training:

- Sergeant Leinweber attended a marijuana legalization presentation.

- Officers worked with the CHMS staff during the student walkout held this past Wednesday. There were no issues.

Significant traffic and criminal activity during the period of March 9, 2018 through March 15, 2018.

March 10, 8:31pm, officers cited a Plainfield resident for speeding and having no valid driver's license. She was released to an UBER.

March 12, 4:07pm, officers stopped a Palatine resident on Rte. 83 when a registration check of the vehicle revealed his driver's license was suspended. While speaking with the driver, officers noted indicia of intoxication. After a brief investigation, the subject was taken into custody for DUI.
