**Subject:** Weekly Report

**1. Republic Services Rate Adjustment:** We are in the final year of our contract with Republic and per our agreement the rates will increase by 2.49% effective 7/1/18. The new rate for Refuse and Yard Waste stickers is **\$2.55 per sticker**. These rates are effective 7/1/18 to 6/30/19.

Other Republic Services rates are as follows:

- Weekly Can rate: \$21.98 (Senior rate \$18.98)
- Back Door Can Service rate: \$33.07
- Yardwaste Toter rate: \$27.32

**2. Comcast Service Notification:** Attached is a notification we received from Comcast regarding required changes in some set top converter boxes. For your information.

**3. Metra Meeting re: Schedule Changes:** As a reminder, Metra has announced proposed changes to the BNSF schedule due to the upcoming implementation of the “Positive Train Control” system, which is meant to improve safety. The changes will alter the schedule including the existing express trains. Metra representative(s) have agreed to discuss the proposed changes at an upcoming public event. This will be held at the Clarendon Hills Village Hall on Tuesday, April 10<sup>th</sup> between 4 p.m. and 6 p.m. All interested parties may attend. If you cannot attend but would like to comment on the proposed schedule you may do so by sending a message to: [BNSFservice2018@metrarr.com](mailto:BNSFservice2018@metrarr.com) prior to April 15<sup>th</sup>.

**4. DMMC Manager's Committee Meeting:** I attended this meeting on Thursday. Several issues were discussed. One was the status of the DuJis (records management system). Though delayed, the report is that this is moving forward and is expected to “go live” in February 2019, about six (6) months later than originally anticipated. We expect to be able to operate with our existing system without harm in the meantime. The second primary area of discussion was the State legislation regarding small cell wireless facilities. It appears that the legislation is moving forward. We are continuing to monitor the situation, for which we may want to bring an ordinance forward in the short term to regulate these sites. So far we have been waiting for resolution at the State level.

5. **Flagg Creek Operations Meeting:** I met on Monday with representative from Westmont, Lombard, Hinsdale, Burr Ridge and Willowbrook to discuss issues related to Flagg Creek operations. Concerns were raised regarding providing proper “locates” for construction projects, restoration after work is performed, working with appropriate permits and general transparency. The group will continue to monitor these concerns.

1. The 2018 Water Main Replacement is fully in the home stretch. At the end of the day, the new main on Tuttle will be about 150 feet short of Chicago, leaving next Monday as the last day of main installation. Service transfers on Tuttle will follow beginning at Burlington and heading north. After service transfers are complete, the old main will be abandoned in place. Work will be essentially complete by the end of the month.
2. We continue to perform our annual tree pruning and should wrap-up next week.
3. We are working on completing specifications for the replacement of Unit #9 and intend to have them ready for Board action on April 16<sup>th</sup>.

1. **DuPage Community Development Commission.** I was recently appointed as an executive member of the DuPage County Community Commission (CDC), and a member of the Home Advisory Group. The primary responsibility of the CDC is to advise the County Board on the following programs: Community Development Block Grant (CDBG) Public Service, Capital and ADA Assistance; CDBG Disaster Recovery Assistance; Emergency Solutions Grant; HOME Investment Partnerships Program (HOME); and Human Services Grant Fund. I attended the CDC meeting on Tuesday, and will be attending monthly. More information about CDC can be found at [www.dupageco.org/cdc](http://www.dupageco.org/cdc).
2. **West Suburban Mass Transit District.** Earlier in March we requested funding from the West Suburban Mass Transit District (WSMTD) in support of the Village's due diligence and design work for a new commuter station and shelter system. Last Monday we received a \$30,000 grant from WSMTD. We will continue to work with WSMTD as the project proceeds.
3. **Richmond Education Gardens.** This week we received a 2,000 gallons cistern that will be used to store stormwater collected throughout the Gardens site. This water will be available for garden irrigation and an interactive water feature found in the Gardens. Funding for the cistern was granted by the DuPage Water Commission. 4. **Thipi Thai Grand Opening.** On April 16<sup>th</sup> from 5-8 Thipi Thai will be hosting a Grand Opening buffet dinner.
5. **Building Code Update Open House 4/19/2018.** Plans Underway to Adopt 2015 ICC Building Code. [Read on...](#)
6. **Zoning Ordinance Modernization Project.** On April 17<sup>th</sup> the ZBA/PC will be holding a special meeting to continue their review of the proposed comprehensive amendment to the village zoning ordinance. More information can be found at [www.clarendonhills.us/zomp](http://www.clarendonhills.us/zomp).
7. **Downtown Design Review Commission Meeting.** As described above (see WSMTD), the Village has been studying and developing design concepts for the redevelopment of its commuter station and shelter systems north as south of the rail road tracks. On April 10<sup>th</sup> at 7pm the DTDRC will be asked to consider two similar design concepts for the commuter station. With the consensus of the DTDRC members, their recommendations will be forwarded to the Village Board for further action and planning.
8. **Permits.** In March, the Village issued eighteen (18) permits, including one (1) for a new home, having a reported combined construction value of \$823,459. The monthly permit report for March is posted at [www.clarendonhills.us/bp](http://www.clarendonhills.us/bp). So far in April the Village issued four (4) permits, including two (2) for new homes, having a reported combined construction value of \$991,725.
