Subject: Weekly Report

- 1. Prospect Avenue Project Update** – The Public Works report includes the full update on this project. I wanted to add that all of the “re-striped” spaces are now 10 feet wide. This was done to address concerns raised about larger vehicles not having enough room to open doors. Previous spaces ranged from 8.5-9.5 feet wide. We were able to only lose three (3) spots as a result of this change.
- 2. Public Services Committee** – The agenda for Monday night includes numerous items for this Committee. Given the heavy load, and the absence of a public works director, Village Engineer Lee Fell will be attending the meeting. We will also ask Lee to review the anticipated impact of recently installed drainage improvements in Blackhawk Heights.
- 3. Public Works Director Millette** – Today is Mike’s last day. I wanted to take one last opportunity to thank Mike for his years of service to the Village and wish him luck in his new position in South Elgin. Best Wishes Mike!

1. The surface asphalt has been placed throughout the project site. The new parking area at Prospect Park and five residential driveway aprons remain to be completed next week. Also a significant amount of clean-up, ditch grading and sodding will continue for the next two weeks.
2. The enhanced pedestrian crosswalks and pavement striping of Prospect and Park were completed this week. The mason has been working on the reduction of the planter in front of Brama La Pizza and will be completed today. The sidewalk patch adjacent to the reconfigured planter will be included with our yearly program and should be completed before the end of October. The new electrical panel is in fabrication and we expect Utility Dynamics to be on site mid-October to complete the installation and rewiring of Sloane Triangle.
3. Bids for the 2018 Sidewalk Removal and Replacement program were opened on Tuesday. Globe Construction is again the low bidder. The contract will be on the agenda for Monday night's Bard meeting. The project will require a week's worth of effort and will be completed by the end of October or early November.
4. We will begin our fall clean-up activities in earnest next week. This work generally includes planter bed clearing and winterizing, final (hopefully) mowing and weeding of the "hand list" areas (i.e. those areas which are too expensive to contract out), and yard and building cleaning.

As this is my last missive, I'd like to take the opportunity to put in writing what I said at the last Village Board meeting. It has been my distinct privilege to work here for the past six years and it has been so because of the great staff, administrators, Village Board and citizens of Clarendon Hills. This is, bar none, the best Director of Public Works position in all of DuPage County. Thank you.

1. **Downtown Planters.** This week the planters in front of Brama La Pizza and Talley's Kitchen & Bar were cleaned and tuck pointed. The planter directly in front of Brama La Pizza was reduced in size to allow for better pedestrian circulation. Minor repair to the gazebo foundation wall also conducted.
2. **Downtown Revitalization Project.** On Wednesday morning the Community Development Department held a project kick-off meeting for the 2019 Downtown Revitalization Project. The Project will include improvements to the streets, railroad crossing gates, and train station shelters at and around the Village train station. During the next several months the Village will be developing formal engineering and architectural construction plans for the overall project. 3. **Permits.** So far in September the Village has issued twenty-five (25) permits having a reported combined construction value of \$2,555,726. The monthly permit report for September will be posted at www.clarendonhills.us/bp next week.

1. Fire Prevention Bureau Activity during the past week.
 - Five (5) Fire/Life Safety Inspections were conducted.
 - Preparations are in high gear for the Fire Department annual Fire Prevention Week Open House on Saturday, October 6th.
2. Training Report:
 - Wednesday evening, eighteen (18) firefighters attended regular fire suppression training.
3. Emergency Medical Services Report:
 - Over the last weekend Medic 86 experienced a problem with the cot power load system. Medic 86 was taken out of service and Medic 86 (reserved) was put into service. The cot loader was repaired on Tuesday and was the result of a failed control module in the loader.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
5. Emergency Management Report:
 - No report.
6. Du-Comm Report:
 - On Wednesday morning, I attended the monthly meeting of the Du-Comm Executive Committee. Normal business was conducted.
 - Du-Comm has been operating in their new Wheaton facility for about a month now. No major problems have occurred.
 - On Thursday, the DuPage Starcom radio system experienced a major failure that was related to some construction work done on the tollway. Police Departments used their UHF radio backup systems and Fire Departments switched to their backup VHF radio systems. The Starcom system failures lasted about 12 hours (7am to 7pm). These failures effected Du-Comm, ACDC, State Police and the Sheriff. Du-Comm, ACDC and the Sheriff will be meeting with Motorola Starcom and the Tollway to try and determine the exact cause of the failure in hopes of preventing this in the future.
 - On Wednesday morning, I met with the Du-Comm Deputy Director of Support Services Matt Baarman regarding the painting of the Clarendon Hills Water Tower in 2019. Du-Comm has communication equipment on the tower which has to be moved off during painting. Matt Baarman will be attending tower painting coordination meetings for this project.
