1. **Board Meeting Schedule** – As a reminder, the next Board Meeting will be on Tuesday, January 22nd (re-scheduled from Monday due to the MLK Holiday). The Public Services Committee is scheduled to meet on January 14th to discuss scope issues for the Chestnut Alley project and the 2019 SSA road program.
2. **Recruitment Efforts** – Assistant to the Village Manager Nickell has coordinated interviews for the Public Works Department full-time Maintenance Worker I position. Second interviews took place today and we hope to make a decision next week. Staff is anticipating that a new employee can begin by early February.
3. **Downtown/Train Station Redevelopment Planning** – Staff and consultants met earlier this week to discuss the on-going planning for these projects. We still expect these projects to proceed later this year. Further review by the Village Board is anticipated sometime in February.
4. **Secretary of State Mobile Unit** –Secretary of State Mobile unit will be here at Village Hall on Friday, January 18th from 10 am to 2 pm for residents to renew or correct their Driver's License/State ID, get a new license plate sticker and/or register to be an organ donor. This event is sponsored and organized by the Clarendon Hills Bank.

Subject: Weekly Report

1. This week's safety talk was on daily work plans and how to incorporate safety into each job.
2. Crews hauled off branches from the stockpile on Monday.
3. A small water leak on Hiawatha was repaired on Tuesday. The grades on the ditch were reestablished and we will sod/seed in the spring.
4. Several street signs were straightened or replaced. A sampling of decommissioned meters were taken for accuracy testing.
5. Com-Ed dropped power at 261 Ann St. on Thursday to perform some electrical repairs to a cross-arm which holds a transformer. This affected the Ann Street reservoir and water intake, but we were able to coordinate with ComEd and so there was no impact to water delivery.
6. One additional first interview for the vacant Maintenance Worker I position was conducted on Tuesday. A second round of interviews occurred late on Friday. We anticipate selecting a candidate early next week.
7. Tree and brush removal was completed on Norfolk. We will be performing trimming and some removals along the sound wall abutting Route 83 next week.
8. Joe Ferrel and I met with Mike Ramsey, the Public Works Director in Westmont. They are planning to build a new public works building this year. We discussed ways that the two departments can work cooperatively and support each other's efforts.
9. Water Operators inspected multiple connections and disconnections of residential water services and repairs. They also performed multiple appointments for possible leaks for residential and one commercial property.
10. The IEPA's Lead and Copper report was completed. Well #6 was operated and the first round of monthly water samples taken.
11. Staff repaired an electrical issue on unit 1. New LED lights were installed at Ann and Maple metering stations.
12. Staff began reviewing engineering plans for the 2019 Water Main Program.
13. Dixon Engineering inspected the AT&T antennae upgrade on the Burlington Water Tower.
14. Trucks were prepped for salting operations for the snow anticipated to start Saturday morning and occur through most of the day. The forecast is for roughly an inch or so.
