1. **Chestnut Alley** – Planning for this project continues. Christopher B. Burke Engineering's landscape architect has continued his review of the possible ways of dealing with the bio swale requirement for the various properties involved. We currently expect to call a Public Services Committee meeting, inviting the residents involved, in the next few weeks to review the status. We will of course continue to keep you advised as this moves forward.
2. **2019 Road Program Review Issues** – Early this week we sent a letter to residents in SSA #32 area providing more information regarding the cost of the project. To date we have heard from a few residents, including some who would remove their signature from the petition they signed. We will provide an update for the Board on the general situation and will ask for input regarding the final treatment of the 100 block of Prospect Avenue.
3. **DMMC Regulatory Committee Meeting** – I attended a meeting of this Committee on Wednesday morning. Members discussed issues related to ComEd legislation and ComEd response to storm events.

1. Our safety topic this week was "Work Zone Safety".
2. The water main project continued this week with installation of a new water main on Walker Ave going South. Crews took advantage of Walker school being out for spring break and installed water main and the necessary valves to connect to the school. The water main will still need to be pressure tested, chlorinated and bacteriological tested before the school and residential connections can be transferred over. By the end of Friday, water main installation should be South of Harris Avenue on Walker and the crews will continue South on Walker next week going to 55th Street. Street sweeping and general cleanup will be done to ensure a safe startup of school next week.
3. Public Works crews were busy assisting with support for the water main project, working valves and locating utilities. Crews also performed a pressure test on the water main on Harris Avenue from Holmes to Walker Avenue.
4. Crews made a round of cold patching throughout the town as more of the ground starts to thaw.
5. Public Works reworked some of the ditching on Norfolk Avenue to help with some standing water.
6. Now that the ground has thawed crews are able to address street signage. Chicago, Norfolk Avenues and other miscellaneous areas will be addressed.
7. Public Works repaired a shut off valve (b-box) in the parkway at N. Richmond. A Westmont resident that is supplied water from Clarendon Hills required assistance in temporarily shutting off their water which resulted in a failure at the b-box.
8. During vehicle maintenance inspections Unit #11 a 3-ton truck was found to have a leaking oil pan. We will be taking it out of service and dropping it off for repairs today.
