Subject: Weekly Report

1. **Chestnut Alley** – As reported previously, staff met week with the DuPage County official responsible for our project to discuss the bio swale portion of the project and if we can adjust the grant requirements. We will pleased to learn that this should be possible while at the same time preserving all or most of the grant. We will work through the various issues and report back to the Board shortly.
2. **2019 Road Program Review Issues** – We have reported previously regarding the petitions being circulated to stop the road program in one or both of the proposed SSA's. As of this afternoon petitions for SSA #32 have been submitted. Staff will review the petitions to determine if they meet the necessary criteria and then consider next steps. We will probably recommend public notification regarding these results next week.
3. **DMMC Business Meeting** – Village President Austin and I attended the DuPage Mayors and Managers Meeting on Wednesday morning. General DMMC business was conducted and various honors were read for outgoing elected and appointed officials. The Director of the Illinois Municipal League was in attendance and reported on various legislative areas of interest, including potential legislation related to lead water service lines.
4. **Metro Managers Meeting** – I attended and presented this meeting on Thursday afternoon. A presentation was given regarding the potential outline of proposed cannabis legalization legislation. We will continue to monitor this legislation and its potential impact on the Village.
5. **Downtown Plantings** – It must be spring, because the downtown flowers were planted today. Please take a look when you get a chance. Our very own English Garden is doing the honors again.

1. Water main construction continued this week with crews tying in the new water main into the existing system on 55th Street at both Prospect and Walker. Homes on Harris were tied into the new water main. Next week, crews will be connecting homes to the new water main on Prospect from Park to Harris.
2. Water Department employees collected our monthly water samples and delivered to the lab. All samples came back with no issues.
3. Staff assisted English Gardens by prepping some of the landscape planters in the Downtown. English Gardens planted spring flowers on Friday.
4. Staff met with a representative from DuPage County Stormwater Division to discuss the bioswales associated with the Chestnut Alley Drainage Improvements. She was supportive of our request to reduce some of the planting areas due to established plants in rear yards and the location of fences in the area. This change will not have an impact on the \$100,000 grant being provided by DuPage County.
5. Crews continued work on some of the ruts along the road edges but due to rain and the ability to get black dirt the amount of work they were able to get done was limited.

RE. Department Report

1. **Downtown Revitalization Project.** Last Friday we learned that BNSF and ICC were not able to agree to the terms regarding the cost of railroad crossing gate improvements. As a result, IDOT was not able to accept our construction plans for the planned road and out-bound train station improvements along Prospect and Burlington Avenue. I am diligently working with both parties to resolve their issues before the next IDOT submittal due date in August 2019. Ultimately this may cause a delay the project start from early to late fall, or Spring 2020.

The in-bound train station improvements are still on schedule to start in mid-summer 2019. Project updates for the entire Downtown Revitalization Project are posted at www.clarendonhills.us/dtrevitalization.

2. **Permits.** So far in April the Village has issued ten (10) building permits, including one new home, having a total reported construction value of \$898,496.
3. **National Planning Conference.** Last weekend and early this week I attended the National Planning Conference in San Francisco. During the conference I attended over 30 hours of training sessions. Some of the topics covered included: geo-design, planning law and ethics, cannabis land use relations, regulating pop-up retail spaces, economic development initiatives, green roof and storm water management policies, affordable housing, and planning for healthy communities. SF is a beautify city, but I'd rather be in Clarendon Hills.
