1. **Power Outages** – We had another round of power outages on Sunday – this time clearly storm related. High winds in excess of 70 mph were the culprit. Power was restored with little incident.

3. **Hinsdale Golf Club (HGC) Fireworks** – The HGC will again be shooting off fireworks for their members and guest on the evening of July 4th (rain date of July 5th). The fireworks are visible from areas on the north side of town, especially Prospect Park. Feel free to come out and enjoy the show.
4. **227 Burlington Lien Payment** – As you may know, about 6 years ago the Village took action to have an old building at this address torn down. A lien in the amount of \$64,890 was placed on the property to cover Village expenses. I am pleased to report that, as a result of potential development of this property, the Village has now received this payment, which has been deposited in the General Fund. Thanks to Dan Ungerleider and Dave Godek who successfully worked this problem to this conclusion.
5. **Village Offices Closed on Thursday/Abbreviated Report** – Village offices will of course be closed on Thursday, July 4th for the Independence Day holiday. 1. 2019 Road Program – Crews are wrapping up the drainage portion of the project. The plan for next week is to start removing portions of the driveway apron on the west side of Walker beginning on Monday starting at 55th Street and moving north. Crews will also remove driveways on the south side of Harris on Monday. On Tuesday, a three foot wide milling for the new concrete ribbon will occur. Wednesday and Thursday will be focused on layout and pouring of the concrete ribbon. Crews will then shift to pouring concrete aprons. Impacted residents will be notified just prior to removals starting. Residents need not contact the Police for overnight parking. They are aware of the work. Residents should have their new Vehicle Stickers on display.
2. Crews responded on Tuesday night to heavy downpours in the area. Over two inches of rain came down at a rate that exceeded the capacity of many ditches and storm sewers. Street flooding occurred on multiple streets and recessed during the overnight hours. Chestnut Alley also flooded and was pumped out to Burlington throughout the night.
3. Bids for the Chestnut Alley stormwater project and for painting the Burlington Water Tower will be opened next week.
