Subject: Weekly Report

1. **Du-Comm Meeting re: Fire Funding Formula** – I attended a meeting on Tuesday to discuss this on-going concern. A proposal was suggested that would improve the funding formula for Clarendon Hills. It will be reviewed by Du-Comm membership at an upcoming meeting at which point we will review our future status.
2. **DMMC Manager's Committee Meeting** – I attended this meeting on Thursday morning at the Conference office. Many issues of note were discussed, including 5G system construction, the Illinois Capital Bill and the impact of legislation legalizing recreational marijuana. The later will require further discussion with the Village Board before the end of the year.
3. **Storm/Flooding Event**- The Village suffered through another storm event on the Tuesday before the 4th of July. In this case there was an enormous amount of rain (almost 3") recorded in less than one hour. The net result of this type of storm is an immediate overwhelming of drainage systems, followed by a relatively quick draw down of the water. This resulted with problems at many of the typical locations including Chestnut Alley, Burlington Avenue, Tuttle/Norfolk and Middaugh between Ogden and Naperville. The Park Avenue and Dallas Basins took water, but because the total amount was limited, did not overflow. Village crews responded to the event, including pumping in the Chestnut Alley, but there was a limited amount that could be done.
4. **Dancin' in the Street Update**– We finally had great weather for the concert this past Wednesday, which of course led to great crowds who enjoyed the band, the Tasty Taco food truck and the change to gather with family and friends. We also love to see all the customers that the concerts bring to our downtown businesses. Join us again on July 17 when The Millennials will be performing. 5. **Hinsdale Golf Club (HGC) Fireworks**- The HGC was able to hold their fireworks event on the evening of July 4th despite all the water left over from the July 2nd storm. We were able to work with them to move the launch site to a dry location. We are happy to work with the HGC on this event, which can be enjoyed by many people around the community.

1. 2019 Road Program – Crews started on the concrete portion of the job this week. Excavations were made for the concrete ribbons on the west side of Walker and the south side of Harris. The actual pouring of the concrete will occur on Friday and Monday. After the ribbon portion is poured crews will pour the concrete driveway aprons or place temporary stone for asphalt driveways. Residents should be able to access their driveways at the end of the week. Crews will then shift to the opposite side of the street and begin prepping for the concrete ribbons on that side.
2. Contractors installed a new manhole on Western Avenue to facilitate drainage connections and address stormwater issues in that area.
3. Bids for the Chestnut Alley stormwater project and for painting the Burlington Water Tower were opened this week. They will be presented to the Village Board for consideration on Monday night.
4. Crews performed typical summer work including lawn mowing, trimming, tree planting and watering, rut repairs and set up and take down for Dancing in the Streets. Monthly water samples were also taken.
5. Crews began identifying diseased and dying trees for removal. Notices are provided to the impacted properties.

1. **Downtown Revitalization Project.** The Village participated in a hearing before the Illinois Commerce Commission on July 9, 2019, regarding the share costs associated for the Prospect Avenue gate improvements. During the hearing it was agreed to by all parties that BNSF would be providing an updated cost analysis of the improved gate system to ICC and the Village by July 29th for review on August 1, 2019. A status hearing has been scheduled for August 6, 2019. This process is expected to take at least 6 months to complete.
2. **Verizon Wireless.** On Tuesday afternoon, Public Works Director and I met with representatives from Verizon Wireless. Verizon is proposing the installation of 36 standalone small wireless antennas in parkways throughout the Village. The facilities are required to deploy the latest 5G cellular technology offered by Verizon. Although State law requires municipalities to allow such facilities, Staff is working with Verizon to ensure their installations fit within the character and needs of the Village, and in accordance with Village ordinance and design standards. More information will be posted soon.
3. **Zoning Ordinance Modernization Project.** The Zoning Board of Appeals will be conducting a public hearing to review the draft comprehensive zoning ordinance amendment on August 15, 2019. 4. **Permits.** So far in July the Village has issued three (3) building permits having a total reported construction value of \$36,025.

The victim related that she just witnessed her neighbor smash the windshield on her son's car. Apparently, the offender took exception to the victim's car being parked in front of his house. The offender was taken to the station and charged under local ordinance.

1. Fire Prevention Bureau Activity during the past week.
 - Twelve (12) Fire/Life Safety Inspections were conducted.
2. Training Report:
 - Tuesday, July 2nd twenty one (21) firefighters attended regular fire suppression training.
 - Tuesday July 9th and Thursday, July 11th, a total of six (6) Clarendon Hills firefighters attended Rescue Task Force training that is for Active Shooter situations in Westmont and Western Springs.
3. Emergency Medical Services Report:
 - Tuesday, July 9th, eighteen (18) Firefighter EMT's and Paramedics attended monthly continuing education training.
4. Clarendon Hills/Hinsdale FD sharing of services report:
 - No report.
5. Emergency Management Report:
 - No report.
6. Du-Comm Report:
 - On Wednesday, July 10th I attended the monthly meeting of the DuComm Executive Committee. Topics covered: Agreement for Gov HR for the recruitment of a Deputy Director, Declared two (2) staff vehicles surplus, New CAD interfaces for Leads and Fire Alarms, Proposal to change the Technical Manager position to Support Procurement position, Discussed the fire funding formula to be presented to the Board of Directors next week, CAD and RMS review and progress report and the annual review of the Executive Director.
7. Vehicle maintenance:
 - Ladder 86 was transported to Wirfs Industries in McHenry early Monday morning by Engineer Laffey. While at Wirfs Ladder 86 will get its annual service completed, annual ladder service completed, pump service testing, generator service testing, repairs to various defects, and also the annual UL ladder testing that is required by OSHA/IDOL. We expect Ladder 86 to be at Wirfs for 2-3 weeks. During the time Ladder 86 is out of service we will have Westmont Ladder 183 respond when needed. Hinsdale Ladder Tower 84 is out of service for an unknown period because it was damaged during the floods on July 2nd.

- Captain Bonser installed a new Starcom mobile radio in Medic 86r (backup ambulance). Now all fire department vehicles are equipped with Starcom radios. Money was saved on the installation because it was done by Captain Bonser while already on duty.
8. On Friday, July 12th we will be holding the quarterly meeting of the Firefighter Pension Board. Normal business will be conducted.
 9. On Friday, you and Peter Nickell will be meeting with me to discuss the future of the fire department. Things faced in future years will be discussed, equipment needs and staffing needs.
 10. On Wednesday, July 4th, Clarendon Hills Ladder 86 participated in the Hinsdale 4th of July Parade. Clarendon Hills Medic 86 was staged on the west side of the Parade at 4th and Grant to handle any medical emergencies on the west side of the parade and was also available to respond to calls in Clarendon Hills at the same time.
 11. On Wednesday, July 4th the fireworks display site was inspected several times by Lt. Godek and was given approval to operate late in the day.
 12. On Wednesday, July 4th Clarendon Hills Engine 86 and Medic 86 stood by at the Hinsdale Golf Club Fireworks launch area during the entire fireworks display.
 13. Incidents of Interest:
 - Friday, June 28th at 6:10 PM. Medic 86, Squad 86 and Hinsdale Engine 84 responded for a vehicle accident injuries on 55th St. at Western Ave. One (1) patient transported to a local hospital.
 - Sunday, June 30th at 2:07 PM. Ladder 86 responded for COMED wires down in the rear of 24 S. Prospect Ave. Area secured while waiting for the arrival of COMED to shut off power.
 - Sunday, June 30th at 2:28 PM. Engine 86 responded for COMED wires down in the rear of 17 Mohawk Drive. Area secured while waiting for COMED to arrive to disconnect the power to the downed lines.
 - Tuesday, July 2nd at 1:11 PM. Medic 86 and Utility 86 responded for an unresponsive patient on the 4th floor balcony at 229 Park Ave. Upon arrival Paramedics discovered that the patient died 5 days ago. Hospital contacted and situation turned over to the police department and the DuPage County Coroner.
 - Wednesday, July 3rd at 8:44 AM. Ladder 86 responded for a vehicle fire on Rose Place at Norfolk Ave. Firefighters extinguished a fire in the rear of a work van using a pre-connected fire hose and 50 gallons of water. Damaged estimated to be about \$6,000.
 - Thursday, July 4th at 2:20 PM. Ladder 86, Engine 86, Squad 86, Medic 86 and Hinsdale Engine 84 responded for a natural gas leak inside the house at 234 Coe Rd. Firefighters found the significant leak, stopped the leak, ventilated the house and notified NICOR. Firefighters remained on the scene until the arrival of NICOR.
 - Saturday, July 6th at 12:44 PM. Medic 86, Squad 86, Chief 86, Hinsdale Engine 84 and Medic 84 responded for multiple vehicle accident on Rt. 83 southbound at about Burlington Ave. Two (2) patients found on the scene and both refused transport to a hospital.
 - Sunday, July 7th at 4:48 AM. Medic 86 and Utility 86 responded to an apartment unit at 285 N. Richmond for an unconscious person. Paramedics and police officers found an unconscious person from a drug over dose. Narcan administered by the police then the paramedics to revive the patient. Patient transported to a local hospital.
 - Tuesday, July 9th at 2:39 PM. Squad 86 and Medic 86 responded for a person trapped in a stuck elevator at 326 Park Ave. Firefighters were able to remove the occupant from the elevator without incident.



- Tuesday, July 9th at 6:27 PM. Engine 86 responded to assist a resident who was locked out of his 2nd floor apartment. Firefighters used a ladder to access a 2nd floor window to gain access.
- Tuesday, July 2nd from 8:25 PM until 10:30 PM. Firefighters responded to eighteen flooding calls for water in basements, electrical problems and cars stuck in deep water due to a heavy and quick rain of 2-1/2 of rain in a 45 minute period. Firefighters encountered some very irate residents. Firefighters tried to explain the intensity of the rain in a short period causing this problem.

14. Mutual Aid Calls:

- Medic 86 responded to assist the Hinsdale Fire Department one (1) time.
- Medic 86 responded to assist the Westmont Fire Department one (1) time.
- Engine 86 responded to assist the Westmont Fire Department three (3) times.

15. Fire/Rescue/EMS calls:

- The Hinsdale Fire Department responded Automatic Aid to Clarendon Hills eight (8) times.
- The Clarendon Hills Fire Department responded Automatic Aid to Hinsdale ten (10) times.
- The fire department responded to seventy four (74) emergency calls in 2 weeks.
