1. 2019 Road Program – Crews installed the base layer of asphalt on Walker and on Harris this week. Sewer and water access structures are being adjusted to match the final elevation of the wearing surface. The final layer of asphalt will be placed in conjunction with the final layer of asphalt on Prospect. Next week, crews will start work on the west side of Prospect removing driveway aprons, grinding a trench for the concrete ribbon and then pouring the concrete ribbon late in the week.

1. **Zoning Ordinance Modernization Project.** Last night the Zoning Board of Appeals/Plan Commission (ZBA/PC) will be conducted a public hearing to review the draft comprehensive zoning ordinance. During the meeting, Staff presented the draft ordinance, a culmination of over 18-month of work by the ZBA/PC and received testimony from attendees. At the conclusion of the meeting, the ZBA/PC unanimously recommended approval of the draft ordinance. The ZBA/PC's recommendation will be submitted to the Village Board for their consideration during the September 16 Village Board meeting.
