Subject: Weekly Report

1. **Chamber of Commerce Meeting** – I attended this meeting on Wednesday morning. The group discussed upcoming events including their Halloween Event (*Saturday, Oct. 26th*) and the Christmas Walk (*Friday, Dec. 6th*), both in the Downtown Business District. I reported to the group on the various projects that are on-going or upcoming, including the Downtown Revitalization Project.
2. **Meeting with Potential Train Station Contractor** – Dan Ungerleider, Brendan McLaughlin and I met with the potential developer for the train station project on Wednesday. Assuming we can work out an appropriate contract, we may be bringing this to the Board for approval as early as October 7th. This contractor is also considering submitting a quote for the Chestnut Alley project.
3. **Budget Meetings** – Staff review for the operating portions of the budget began this week. The Fire and Police Departments have been completed.
4. **2019 Road Program** – The paving portion of the road program for 2019 has been completed. Striping and punch-list items remain, but overall this year's program has been completed in an efficient manner. You may recall previous years where we struggled to complete landscape restoration before winter started.
5. **Traffic Issues** – The Police and Public Works Departments have continued to address concerns regarding traffic and crossings in various parts of the community, in particular at Coe/Norfolk and Chicago intersection. We are hopeful that the completion of the Village's road program will help reduce traffic concerns on streets south of the tracks.
6. **Recycling Event** – The SCARCE event sponsored jointly with the Village was held at Prospect Elementary School last Saturday. It was a success with 226 cars dropping off materials. Thanks to Assistant to the Village Manager Peter Nickell for coordinating and attending this event, and to Public Works and Police personnel for their support.

1. 2019 Road Program – This week crews completed the surface course of the pavement. There remains a handful of locations where work needs to be completed related to drainage, striping and signage.
2. The Burlington Water Tower was taken out of service this week. Staging for the painting project has begun. Work is expected to start next week.
3. A water main break was repaired on Hiawatha and Norfolk on Saturday 9/14.
4. Crews performed maintenance on several ditch lines, mowed village properties, removed bushes on Norfolk and on Park, water planters in the Central Business District and performed maintenance work on the water system.

1. **Downtown Revitalization Project.** The Illinois Department of Transportation (IDOT) accepted bids for Phase I of the streetscape improvements along Burlington Ave and Prospect Ave, north of the tracks. IDOT received 6 bids ranging between \$1.4 and \$1.6 million, with A Lamp Concrete Contractors providing the low bid of \$1,434,658.46. The Village will be responsible for 20% of the total cost. More details will be made available next week regarding next steps and the construction schedule.

Phase II is on hold until BNSF and the State have resolved its issues with the scope and cost of the proposed railroad crossing gates at Prospect Avenue. Phase II includes the construction of the new outbound commuter station and bicycle shelter.

On Wednesday, Manager Barr, Public Works Director McLaughlin and I met with members of John Burns Construction to discuss the train station project, its schedule, and coordination with the other components of the Downtown Revitalization Project. The train station project is scheduled to begin in early November.

2. **34 S Prospect (fka Frida Kahlo Mexican Grill Restaurant)** - Early this week we learned that Frida Kahlo had permanently closed its doors due to legal issues between business partners. On Wednesday morning I met with the building owner and later that afternoon, I brought a potential restaurant owner to the building for introductions and a tour. The proposed restaurant owner is interested in opening a family-friendly restaurant serving hamburgers, etc.
3. **211 Burlington Avenue** – This morning I met with the potential purchaser of 211 Burlington Ave, the yellow building kitty-corner to Village Hall. He is proposing to renovate the building and open a whiskey distillery and store. I anticipate formally introducing him to the Village Board later in October. This business will be required to receive conditional use approval for a distillery and a new liquor license. I intend to share more detailed information once a formal contract to purchase has been signed by both parties.
4. **Zoning Ordinance Modernization Project** – On Monday evening, the Village Board accepted the Zoning Board of Appeals/Plan Commission's recommendation to approve the comprehensive amendment to the Village's zoning regulations. The second reading and approval of the Ordinance adopting these new regulations are expected on October 7, 2019. The new zoning regulations, posted at www.clarendonhills.us/zomp, will replace the existing code on October 8, 2019.
5. **Richmond Education Gardens & Apiary – Brick Paver Installation.** Last Monday the Village Board directed Staff to proceed with a proposal with CR Schmidt to begin the installation of brick pavers. CR Schmidt was responsible for building the brick-paved Williams Court cul-de-sac off of Woodstock Ave, south of Ogden Ave. Their work is scheduled to begin by mid-October. During installation, CR Schmidt will inset the engraved bricks throughout the brick-paved

areas in the Gardens. There is still time to order your bricks. Please support the Richmond Education Gardens and Apiary by purchasing [online](#) a custom engraved brick in honor of a family member, friend, business or organization.

6. **Permits.** So far in September the Village has issued nineteen (19) building permits having a total reported construction value of \$5,502,230, including a building addition (nineteenth hole) at Hinsdale Golf Club and 2 new single-family homes.

Training and Events:

The Department has been monitoring the intersections of Chicago at Coe and Holmes at Harris after receiving complaints of increased traffic volume caused by Rte. 83 road construction. To address concerns, the Department deployed its message board and speed sign to the area of Chicago and Coe to warn drivers to slow down. Public Works added a crosswalk sign at Chicago and Norfolk and a "no right turn" sign to the left turn lane on the west side of the planter. The Department will continue to assess traffic issues in these areas.

Significant traffic and criminal activity during the past week.

On September 15, 2:38am, officers stopped a vehicle that was speeding on Ogden Ave. During the stop, officers discovered that vehicle was stolen out of Aurora. One adult and three juveniles were taken into custody. Charges pending.

On September 17, 2:41am, officers responded to the 5700 block of Western for a drug overdose. Officers administered Narcan. CHFD transported the subject.

On September 17, 4:30pm, officers responded to Rte. 83 for a criminal damage to property / road rage incident. The complainant advised that while attempting to merge in the construction zone, a motorcycle enthusiast drove up next her and punched her driver's door. Pending.

On September 18, 8:30am, officers responded to the business district for a theft complaint. The complainant related that a business sign, recently put up, was stolen. After further investigation, it appears to be a civil issue between the business and sign contractor.

On September 19, 12:43pm, officers responded to the Infiniti dealership for a theft of service complaint. The complainant related that a customer took her car without paying for the services rendered. Pending.
