1. **Special Events Committee** – Assistant to the Village Manager Nickell attended this meeting on Tuesday night. The Committee is considering the possibility of scheduling seven DITS (7) concerts instead of six (6). This will be discussed with the Board as part of the upcoming budget process.
2. **DMMC Regulatory Committee Meeting** – I attended this meeting on Thursday. The key issues discussed was co-location of 5G equipment on ComEd poles. We will continue to pursue this possibility.
3. **Budget Meetings** – Staff review continued for operating portions of the budget this week. Public Works budgets (general fund and water) were discussed.
4. **Commuter/Downtown Parking Discussion** – Staff members on Monday and Tuesday met to discuss parking plans for the upcoming train station construction. This preliminary plan is to move commuter and “Blue dot” parking to areas that we expect to be available to make up for lost parking in the commuter lot. The plan will be presented to the Board when completed.
5. **Staff Recruitment Update** – Interviews are being conducted for the part-time Fiscal Assistant position in the Finance Department. We hope to be able to make a decision by the end of next week.
6. **Meeting with Westmont Officials** – Village President Austin and I met with the Village President and Manager in Westmont on Wednesday morning. We discussed various issues of mutual importance to the communities. We appreciate the positive relationship that we maintain, that allows us to collaborate in various areas including the Education Garden.
7. **Blackhawk Heights Sign** – Public Works Director McLaughlin and I spoke to the lead neighborhood spokesperson regarding the sign. We have a general agreement regarding the sign layout and she will work on the potential cost share discussed with the Village Board.
8. **Employee Appreciation Event** – Staff is participating in this event today. It is moving indoors (Public Works Garage) due to weather. We appreciate the efforts of Village Staff throughout the year and thank the Village Board for their on-going support of Staff and for allowing us to hold this event.

On Monday, I met with the owner of the building to offer assistance with finding a new business for the space, and check to with Talley's and I Want Candy. He asked that the Village continue to encourage residents to support their downtown businesses.
3. **Zoning Ordinance Modernization Project** – On October 7th the Village Board is scheduled to adopt the comprehensively updated new zoning regulations. The new zoning regulations, posted at www.clarendonhills.us/zomp, will immediately go into affect on October 8, 2019.

5. **Permits.** So far in September the Village has issued twenty-two (22) building permits having a total reported construction value of \$5,579,230, including a building addition (nineteenth hole) at Hinsdale Golf Club and 2 new single-family homes. 1. Work began on the Burlington Water Tower this week. Much of the work focused on welding additional safety factors (railings, platforms) in place. Equipment has been placed for the contractor to begin sandblasting the interior of the tank next week. Public Works assisted with capping the remaining water from entering the base of the tank.
2. The village-wide leak detection survey was completed this week. One leak was detected on the water main on Burlington at Woodstock. A service line leak was detected at a home on Algonquin.
3. A water service line was repaired on Walker.
4. Restoration work was completed from a main break at 56th and Western.
5. Plans for ComEd to replace poles near the corner of Prospect and Burlington were reviewed along with NICOR's plans for a new gas main in the Chestnut Alley.
6. A variety of signs were installed on Prospect, Walker and Harris.
7. Miscellaneous tree trimming work was completed this week. Bushes were removed on Park west of Walker. The island at Harris and Prospect was cleaned up.
8. Signs were installed on the planters downtown reminding people to walk their bikes and skateboards.

He was released after both victims declined to press charges. He was also medically cleared.
