Subject: Weekly Report

1. **DMMC Managers Committee Meeting** – I attended this meeting on Thursday morning. Several issues were discussed included a recent decision by the FCC which is expected to result in a loss of revenue from Cable Franchise Fees. In short, the decision states that “in-kind” services (like cable access to public building) will be deducted from the standard 5% fee. Everyone is waiting to see how this will shake out. The other item of great note was a discussion of the future of the “Field Court” used for standard police citations (moving violations). It has been in Downers Grove for years, but the County is concerned about aspects of that location. Options include moving all operations to Wheaton (which would result in increased costs due to travel time and other issues) or building a new facility in Woodridge, with the possibility of asking for local contributions. All of the municipal representatives were concerned about this option and we are seeking additional dialogue with the County. There are additional meetings scheduled next week.
2. **Metropolitan Managers Committee Meeting** – I attended this meeting on Thursday afternoon. The Executive Director (Brad Cole) of the Illinois Municipal League provided an update on pending legislative matters. Of most importance, he reported significant progress towards a functional consolidation of public safety pensions. If successful, this would result in cost savings statewide WITHOUT the loss of benefits by police officers or firefighters. More news on this should come out in the next week or two.
3. **State's Attorney Presentation at Board Meeting** – Bob Berlin, the DuPage County State's Attorney, is scheduled to attend our meeting on Monday night to make a presentation regarding the impact of cannabis legalization in Illinois. The presentation is scheduled at the start of the meeting in deference to Mr. Berlin's schedule. I am sure he will be willing to take questions from the Board.
4. **Staff Recruitment Update** – Interviews have continued for the part-time Fiscal Assistant position in the Finance Department. We expect to make a decision next week.
5. **Budget Update** – It is that season, so staff continues to work on developing the budget for 2020.
6. **Prospect Avenue Barber Shop** – You may have noticed signs going up for a new barber shop at the location of the old Clarendon Hair Design. There is a problem here, however, because the use is not allowed at that location due to the “retail” requirement in the B-1” District. We are in communication with the property and business owners regarding this issue.
7. **Free Leaf Pickup** - It's that time of year where leaves only in yard waste cans or paper yard waste bags may be placed out on Tuesdays with your other garbage without a sticker. Other yard waste (grass clippings, sticks, weeds, etc.) still require a sticker. This is in effect for the months of October and November.

1. Crews repaired a water service leak on Algonquin and a main break on Burlington that never came to the surface. Both locations were identified during a recent leak detection survey.
2. Monthly water meter readings were conducted on October 1st.
3. Crews removed four smaller trees that were between the Park Avenue Permit Lot and the Fire Station. This was done in advance of the repaving that will occur later this month. Both the parking lot and a portion of Park Avenue from roughly Walker to the Fire Department driveway will be resurfaced.
4. The rain that occurred late Wednesday and early Thursday morning required one Public Works employee to come in overnight and pump down the ditch line in Chestnut Alley. Over 1.25 inches of rain came down. No other stormwater issues were reported or observed. The Village will be going out to bid later this month to replace the permanent pump and create additional stormwater storage in the alley.
5. Crews met with a contract engineer for ComEd to review new electric poles in the vicinity of Prospect and Burlington.
6. The Village's tree removal contractor is grinding stumps where trees were cut down. The contractor will remove the grindings and place cone in the hole. Public Works will then fill the holes with dirt and seed.
7. The work on the Burlington Water Tower is continuing. The interior of the water tower has been blasted, the metal inspected and surface recoated. All inspections came back with good results on the metal. The mounting of the exterior containment system is nearly complete and will be in place for exterior blasting and then new paint.
8. Staff is researching replacement light poles that can allow for 5G Cellular providers to locate their equipment on the light pole. Verizon is proposing to roll out 5G service in Clarendon Hills and would be purchasing and installing the light poles. They report that the existing ComEd light poles will not work with their rollout.
